Someone asked what value there is to the average alcoholic? We spend a lot of time collecting and cataloguing our history, and if we don't train our people, we might as well toss all in a garage and/or throw it away//I obtain a great deal of spiritual gifts when I am able.//I think there is an intangible thing when we send someone away: personal connection is important//There are some times of the year when air fares go up, so am in favor of expediting this.//Historically, we are the committee. I brought the concept of archives to the conference floor: we planted the seed right here.

The chair took a sense of the room: vote today by simple majority: YES 48 NO 3 Abstentions 4 No minority opinion **MOTION PASSSES**

Assembly Bids:

DIST 09 SOLANO SOUTH: A/C would add 4k to bill. Without the total is \$1891 and I doubt we will need a/c in Benicia//Q. 4k sounds like a lot did you consider buying handheld fans for everyone? I see 350 chairs available: is it still wheelchair accessible?/ A. Yes, we can add more chairs and it will still be accessible/Q. I come from Humboldt where I think 68 is hot, so what are you talking about?/A. It's substantially cooler in Benicia./Q. Is it the case if we have groups over a certain size the cost goes up?/A. No./Q. Are the breakout rooms sliding curtains?/A. Yes, and we

will provide them.//This is not a problem for me to see a bid with a double cost. It's a normal way to do bids./Q. You mentioned we would need a generator. Will this make a lot of noise?/A.It has to be outside and we would be on the 2nd floor./Q. It sounds like it would be a noisy venue because of the curtain partitions. Are the curtains included in the cost of the facility?/A.The district is providing them./Q. Are the curtains like the partitions here?//A. No./Q. Did you not say that there are fans?/A. Yes, there are ceiling fans the site provides 6 large window fans./Q. Haven't we had assemblies in county fairgrounds with no a/c?/A. Yes, in Santa Clara it was 100 and they opened windows.

DIST 10 MARIN: Could not get answers to all our questions. We think we can do it without the early entry fee. In the past we've been able to find other places to host people instead of expensive hotels. I don't have any other answers.// I attended an assembly there and it's a beautiful place and the a/c worked really well.//Q. When did Marin have an assembly?/A. pre conf 2009 (Solano: post 2010)/Q. I see this has not been visited by the assembly coordinator and wonder if it's because we've been there already./ A. Yes/Q. I see here that there are partitions available, but no number? Can there be enough?/A. I think so.//I go to the county fair and there are many partitions available./Q. Do we have experience with past assemblies where we've had early entry waved?/ A. I don't remember the cost of this past two day assembly, where we came in on Fri. I really don't know./Q. Are the partitions solid or cloth?/A. solid./Q. Are there additional fees or costs for breaking up the room?/A. I don't know//I suggest we table this. We haven't rec'd confirmation. We can't accept it the way it is. The Benicia bid has a//c and partition concerns// << Discussion tabled until next month.>>

Pros Cons

Here is my pro argument for the motion:

Ending the hardcopy mailing of the Comments and Commentarios has been discussed as a topic for a few years at the Area meetings. It is a good idea and it's time has come.

As Bill described in his forward to the Service Manual, "an AA service is anything whatever that helps us to reach a fellow sufferer...concerning any given service we therefore pose but one question: is this service really needed? If it is than maintain it we must, or fail in our mission to those who need and seek AA."

Clearly, the an Area newsletter is an important AA service--it keeps those who serve the AA groups in our area well informed and up to date on vital matters. Howevever, it is also a very significant cost to the Area, about \$1100 per year. Here are some factors to consider:

- 1. We are currently running a deficit budget. Is the mailing a prudent use of our 7th tradition contributions?
- 2. It would be quite simple for DCMCs to append a copy of the Comments to their monthly email to their districts.
- 3. It could actually increase the use of the newsletter, as many would be motivated to read it on mobile devices.
- 4. With a digital only format, graphics and other features could be added that would be too costly with a print version. This could actually improve the content.
- 5. It would save volunteer work hours of folding and stapling every month.
- 6. The cost of downloading and printing a few copies for those that request them can be handled by the individual districts or by the area. The logistics for accommodating those who need a print copy can be tailored to limit costs --and these details can be worked out by an ad hoc committee.

I believe the first time I received the CNCA comments in the mail, I knew I was truly being of service to AA. I am from a dark district who before me hadn't had a GSR or a DCM for over 5 years. The comments that I got in the mail were my connection to the area, I live almost 30 miles from my monthly district meeting so the comments served as a bridging of the gap for me. My personal experience has taught me that when I physically have the comments in my hand I can truly carry the message. I can bring them to my sub-district meetings and ask the GSR's how they feel about what's going on in the area. I have also used them to educate AA members to them about General Service. I use them to bring people into general service work to show them what we do. When the GSR's that I recruited got their first CNCA comments I'm sure they had the same feeling wash over them. They in turn are now able to break open the flow of communication so that we can allow for the support and information to our sub-district. Sure you could say that I could print them and bring them however not all people in AA have the capacity to do so. I know that might sound ridiculous but it's true and I would hate to see those people cut off. In some areas the communication has slowed to a trickle and if you were to cut this off I would hate to watch people feel lost and uninformed and dwindle out of general service. We need communication, we need to reach out and ensure that no matter the cost our area stays strong with unity and knowledge.
