OLD BUSINESS: None

Discussion Topics: *Using an inventory to encourage improved participation; are we emphasizing all the steps, particularly Step 12 regarding service, in order that our GRS ratio to membership may improve?*

Sponsors should take the responsibility for teaching and sharing their responsibilities so they understand commitment. This should go all the way to group level. It means being responsible and honoring your commitments.//I haven't had good experience in telling sponsees to do much of anything. People are not attracted. I think we have a lot of dedicated people; we get the work done. The final reports is one of the greatest tools we have. We do our best to carry the message. People don't have to participate.//First thing is we need to have fun so that we can keep our GSRs so I do steps and traditions and concepts at all our meetings. I try to talk about interesting things. I explain that without GS things they rely on might not happen.//I was a member of AA for over 16 yrs before I ever saw a manual or the concepts. We are the train conductors and nobody is concerned about us until the train is late. It was only recently that I learned what service is all about. I don't think we know we are not doing enough.//We have difficulty getting GSRs in our area; I was in AA for 20 yrs before I heard of service. I look at my community and they are willing and giving. They send money but they don't understand, they are interested, but they are not interested in being of service.//The inventory process has helped me to encourage others to do the same. I've seen some home groups turn around behind an inventory and I've seen groups grow.//When I first came to GS I didn't even know what it was. We had no business mtgs, so I always gave an announcement; now we have monthly business mtgs, and people are being attracted. A lot of people out there think GS is nothing but politics and vitriol; it's just the opposite.//It is a fact that GS has a bad rep so we need to admit that and try to do something about it. Talking about service at the meeting is not going to get us anywhere. We need to look at the important things we need to emphasize.

We need to come up with solutions.//When I became a DCM I decided I needed 100% representation of GSRs. If people don't know it's my fault.//The reason I came to GS is because of its bad reputation. In my area a lot of people disagree with GS and I think it lies within the fellowship. The dots aren't connected within the rooms of AA. GS doesn't keep me sober, the Big Book and the 12 steps keep me sober.//We have an agenda planning meeting prior to our dist mtg. Our meeting has declined from 40-45% participation to less and I don't know why. This is a district problem. I'm not getting support from my DCMC.//I have only 3 GSRs in my sub dist and I know we get a lot of H&I support and I think we need a visual contact, like a green can, not just for money: for visibility.// Sponsor would encourage me to attend G.S. events, going to agenda topics workshop and help and it was an all-day affair. I encourage sponsees to do the same thing. How to do things matters the most. // A lot of people look at G.S. as being political and intrusive upon their recovery. I tell sponsees that if you're not enthusiastic and not having fun, then you're not doing your job. Present something short, sweet, simple and interesting.//I emphasize how we do things, not what we've accomplished. I've gotten people from out of our dist to help with inventory: it's not what we do, but HOW we do it and when they see the kind of sobriety our servants have, they are impressed.

Report from archive rep (Richard W) to Springfield, Ill national workshop: Springfield is the "home of Abraham Lincoln"; we visited some historical sights. We visited a church where Lincoln gave a speech on temperance: someone from Florida gave the same speech; we were amazed. Someone said gratitude is service and someone said service is love with your clothes on. Archives is important: first, do no harm is our primary rule. Archives topics were rich and varied. The most anonymous thing we can do in AA is filing. I learned a lot and I gained insight in taking oral histories. The work associated with maintaining archives can be uplifting and challenging but is well worth it. "When a society or civilization perishes, one condition can always be found: they forgot where they came from." Carl Sandburg.

WHAT'S ON YOUR MIND?

After the DCM sharing sessions we have a half an hour for lunch but there is a lot of noise from crackling bags during ACM.//I was asked to bring loving regards from people around the world. The world of AA is alive and active. We have *all* been invited to South Africa's national convention in Durban, April 18-20;//We sold out on all the radios so how many should I buy?

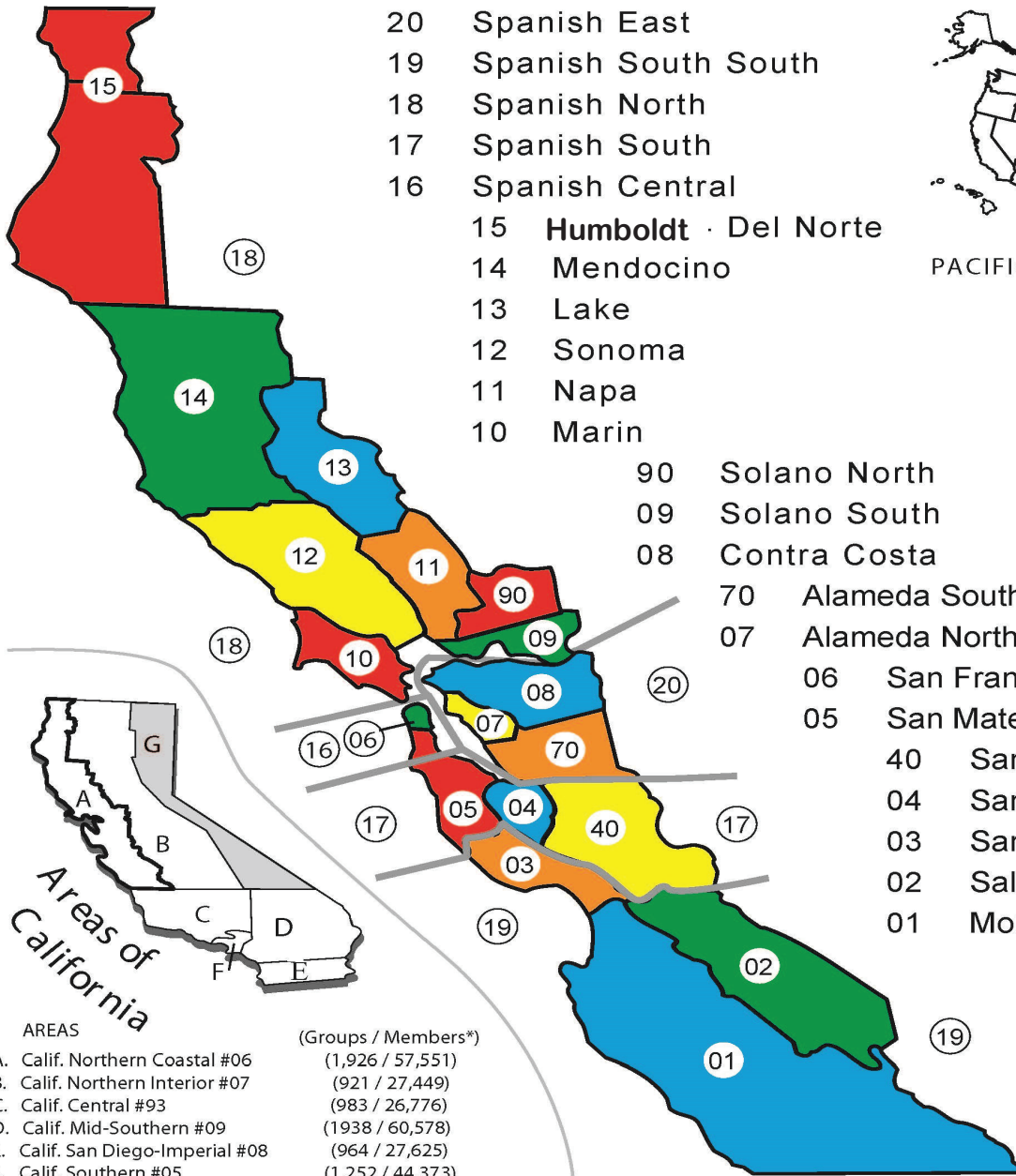

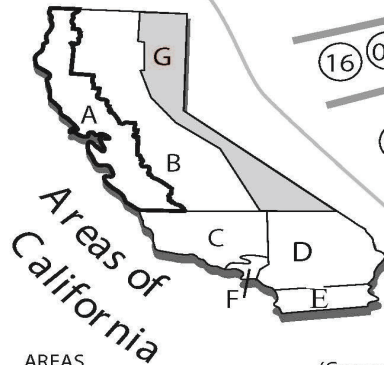

DCM SHARING SESSION

Phil B opened the meeting at 10:00 with the serenity prayer.

Presented by Bob K. Past Delegate D- Area 07 "How to give examples of the Concepts working in our Lives" Bob started the presentation with telling us early in his recovery he had said to his sponsor, I think I want to start working some of the 12 steps. His sponsor responded with, let's start at step one and go through to step 12 and we will see which ones you like. The Concepts are even more confusing because of the language that is used. Most of the concepts refer to the trustees. Bill was worried about the trustees having too much power. Each concept has a principal to it that you may start working in your life. For example, Concept 3 refers to the right of decision. This can work by starting to make decision in your life and not being afraid. Concept 9 talks about leadership. This tells me that it is ok to sit back and enjoy the group. Depending on what service position we have the concepts can help us as much as the steps and traditions help us in our lives. The most effective way to learn about the concepts is working with a service sponsor. They have already been through the "meat grinder". Even with newcomers a sponsor can introduce a concept without them even knowing they are working one. Concept 4 talks about service. I can talk to them about the importance of service and once they are in service at any level, they are working Concept 4. When I was a GSR at an area business meeting I was terrified. Not knowing where to sit, I found a group of people sitting in the back of the room that I found out was very helpful to me. I ask many questions and was always given an answer that made things start to make sense. I later found out that they were the past delegates. Don't be afraid to ask questions. Use the wealth of information that we have here at area. We are very lucky to have a wonderful group here. My personal experience with the concepts in action did not come until I was delegate. I saw many concepts come into play during those 2 years. Just remember to ask questions.

The principal to each concept can be found by trying to understand what Bill was feeling.

Under the surface of AA is change. The basic principal of the Concepts is change. Our sobriety is contingent on how well we deal with change

I have read the concepts a few times. I am always learning. It makes me feel like I am a part of all of AA.

Don't be afraid to ask questions. No questions are silly.

I was told to study concept 12 first. All the other 11 concepts are the warranties in concept 12. This made it easier to study.

You reminded me how important a service sponsor is. I need to call mine.

I have learned at area the principals of the concepts we are to use in our every day affairs. Service sponsors can help you make this possible.

I love the pamphlet on the concepts. The concepts are just like to Big Book – every time I read them I get something new.

General Service manages the changes in AA. The concepts are the way we behave and handle the changes. I go to a concept study group. This is a great way for me to learn. I use this information to bring back to my group to get information across.

When I served as a delegate I was able to give to the people so much more information that I had learned. In the 6 warranties I can use all these in my everyday life – financial prudence – personally punitive – unqualified authority.

I can use the concepts in my work life – delegated authority – try to get substantial unanimity in business decisions. Bill was looking for leaders that are not dictators – be a leader that our groups will want to follow.

Read the service manual. It is very informative.

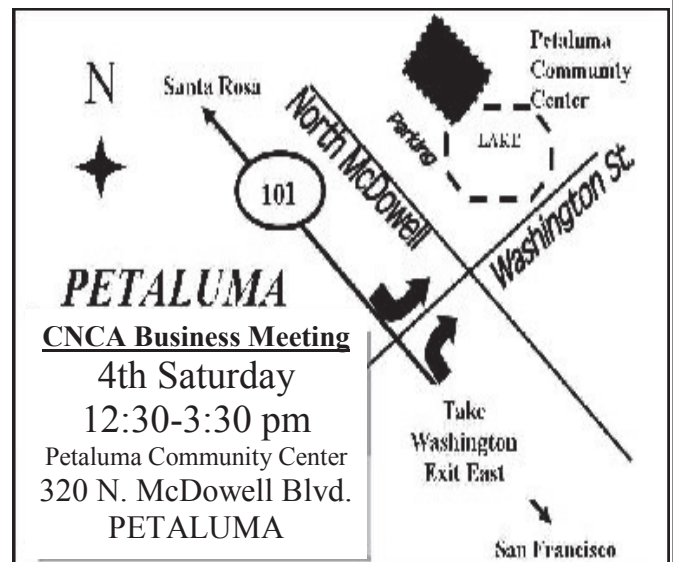
