# Preview of the Area Committee Meeting September 2014

Hello trusted servants of California Northern Coastal Area (CNCA),

In our last Area Committee Meeting on August 23rd we passed three House Keeping Motions.

- 1. "That CNCA Fund the BTG Committee to hold a Forum to be held November 1st in District 12 not to exceed \$700.00"- By Finance Committee
- 2. "District 04 requests that its new sub-district boundaries be approved."-By Dist.04
- 3. "That CNCA purchase a new coffee pot to replace broken coffee pot, not to exceed \$175.00."- By Assembly Coordinator. There was a presentation of New Business:

"That CNCA reimburse up to \$100.00 for qualifying hotel stays." -By Finance Committee.

The two items of New Business that were tabled to this month (ACM) were withdrawn;

We had an Assembly bid for the 2015 Post-Conference Assembly submitted by District 15 and was approved. We will continue discussion on the two items of the Assembly old Business I'd like to remind you to please bring your Group & District Conscience to the next Pre-Conference Assembly.

Hello Fellowship!

It seems just a short time ago I was a new GSR serving my home group and after my term, I happily rotated out. Still interested in GS I attended the district conference report by our delegate. Her experiences from the conference seemed so interesting, and she even mentioned there might even be a future delegate in the room that night.LOL. Later a GSR suggested I return to GS. I was then elected by the gsrs to be DCM. Thus began "My" journey down the A.A. triangle of service.

I certainly had "Contempt Prior to Investigation." I barely knew how to make copies, didnt have my own computer, was nervous about lots of driving and was very timid talking to unfamiliar folks. I had a choice to share a minority voice. The next meeting I spoke without being punitive, I was happy to be heard. I had courage and trust in the process, I didn't quit!

As I continued to serve as DCM, DCMC, and Area Officer the growth process continued and I explored even more in the practice of Concept IX. Out of conflicts and the work to find Unity and peaceful solutions, there grew a dedicated and willing A.A. trusted servant and leader. Our 12<sup>th</sup> Step "Carrying the message" our principle aim, has been my goal throughout my years of service and sobriety.

May I encourage you to consider how you can best serve A.A. in 2015/16. Discuss this with your sponsor, family and work place, there are sacrifices involved in service work. Your group, district and area have supported you on this journey.

Like Dr Bob and thousands others- I am alive because of AA, I am full of gratitude, and I am able to serve with love. As a result I have become an esteem able member of A.A. and society. That is a dream come true!

**OLD BUSINESS: None** 

Discussion Topic: "Should we discontinue the CNCA practice of limiting Area Officer Eligibility?" I currently see that sometimes only 3 people stand for an office. and at other areas. I see many making themselves available. In our Area, when we get to the fifth vote on our third legacy, we pull from the hat, and limit the pool God gets to choose from. I've also heard others talk about increasing the number of area officers.//I am the perennial limiting area officer visits guy: the idea of expanding the group of people who expand visits. We have a wealth of experience among past Area officers. The onerous nature of the job keeps people from making the commitment. Why not make a pool of past Area officers to compose a panel to come up with ideas.//I became aware that our Alt DCMC is not available to vote or stand for office. It doesn't seem equitable. There is a huge wealth of people who should be offered the opportunity to serve.//l've served on a few panels and could have made myself available. I've seen panels where there was a crowd of people for a position and where someone who might not have had the skill set, have been overwhelmed. Our Area is strong: we have to be careful about these positions. There is a lot to consider that many don't: there is an impact on your social and personal life. I have personally never felt that I have missed out on anything by not being an Area Officer. I think people need to think about what it means to be an Area Officer. People don't always have the equipment they need to step up. And most of our panels have been excellent.//I think it's a great way to have a discussion about who is eligible to vote. At our dist, it is recommended that the Alt DCMC also be a DCM so that there can be a vote to represent all.//If we expand the pool, there should be more people making themselves available. Those who are intelligently able to be available would offer a qualified pool. Get a minimum standard and see who makes themselves available.//Possibly have an at large officer pool or add alternates to the officer pool. They will know what is happening at the area

and local level and grow to serve better and step up to ease burden of Area officers.//I always like these discussions. How broad do you make the eligibility? Do you allow a GSR to be a delegate? Wow. That's great for my ego: some of the limitations might be good. When we look at this eligibility: what do we want on our committees or as Area officers: you certainly don't want a little dobedo like me.//l've been thinking of this a lot. I am a DCM and can make myself available as an Area Officer, or I can make myself available at the Dist level: I can't be available unless I become DCMC and that could take several more panels.//Last time I checked there were 156 registered DCMs and 22 DCMCs and 8 officers: that's a big pool. I think it would be better to have an alternate officer for some of the positions (treas/ chair).//Since I've been in General Service, we would always figure out ways to have our GSRs attend meetings. We don't have space for all. If we get 1000 GSRs at our assemblies, then yes. I like the way we do it. I don't think we have a big need to change.//This will probably be my last panel: I served as an officer and now am not eligible. I have new skills that could aid me. To have a bigger pool: you have to make a time commitment and a desire to serve the Area and AA in general. Thank you to the panel.//I don't really believe that this body would ever elect someone who is not qualified. I don't think most of us are in the dark about the level of commitment it takes to be an Area officer. I think there are people who would/could do an excellent job, but who are not eligible.//One time when the delegate gave a report, spoke of a delegate who had only 3 years sober: this is good to start and see how it works.//l've been to some meetings where holding some positions required having had a previous commitment. Perhaps becoming delegate or some other position requires a bit more experience; we should consider that.

Committee Chair Job Descriptions: Jennifer B, Finance: Primary purpose is to assist treasurer and to keep area informed. Members attend monthly ACM and committee mtg. and 4 assemblies, process receipts, collect monies, update financial guidelines. I give a report each month and mail a summary when Judy reminds me. This committee has more stringent requirements: DCMC/alt DCMC/DCM, past delegates.

Mary Lou M, Web Chair: We approve and promote content to communicate and coordinate committee info; uphold purpose of web; enhance communication; disseminate info about AA to the general public. We should be accessible and provide info in English and Spanish wherever possible. I prepare an agenda, chair meeting, give reports at ACM and assembly. Committee is appointed. Give your name to an Area Officer if interested/they appoint. Committee elects the chair.

ACM and Assemblies and ASL upon request. We provide equipment and interpreters. **Q**. What kind of time commitment for ITT and Web committees? **A**.1 hour for ACM: maybe a half an hour on occasion. Depends on demand for services. For Web: monthly attend 11 am mtg, this mtg. E mail amongst committee throughout the month. I get all the documents that need be posted. Ray sends the Comments; I forward to website editor. Same with Commentarios, chair preview, delegate's corner, Comments, motions. Not more than 2-3 hrs per month at max. **Q**. Is the ITT commitment a 2 panel commitment? **A**. It is a 2 year commitment. **Q**. As a standing committee chair, do you visit dists? **A**. Only on request. I haven't been requested.

Richard W: Comments Editor: I receive the comments info on Sat and edit them: about 1 hour. I have them printed and pick them up. We have a lick and stick (5 hrs)and then they are mailed. The Web Comments take only about 30 mins to edit. If you have questions, please contact me. **Q**. You mentioned that the Lick and Stick

takes about 5 hours. Can that be reduced? A. It's 5 hrs from the time I pick up at the printers. We start at 6 and the earliest we've finished is 8:30, the latest was 10:30. Q. Is taking it to the printer part of the job? Is it flexible to where you take it? A. The printer is the choice of the dist taking the bid. Q. Is all sorted and ready for bulk mailing? A. Labels come from registrar. There will be a pass it on to help. We will invite you to our dist and I will come and help you with your first issue. Q. How many numbers are we putting out? A. About 1150 each month. Q. I heard about 8 hrs per month? A. Yes, including the Lick and Stick. Q. Were you familiar with the publisher program? A. Some stuff I had to learn, but it was easy. Q. You mentioned that it's bulk mailed? So what actually gets licked? A. The envelope. Q. So there's folding as well? A. Yes. Q. Reiterate the process that changed the way it used to be done? What happened? A. This was a cheaper way to go with the price increase: we use lighter paper.

**AREA ASSEMBLY BUSINESS** 

Presentation of New Business: Motion: "That the General Service Conference reconsider the Panel 61 Public Information Advisory Action regarding A.A. videos containing full faces." –Presented by CNCA PI/CPC committee. Discussion: You can get some of these videos on the new website. We use the microphone and the Comments to relay info, no handouts.

# **ASSEMBLY BUSINESS MEETING MINUTES (Cont.)**

Pros: a real person is more effective than a head; we're not using the face of a member to promote AA. (Other service structures use full faces and there have been no problems); shows that we come in various forms; illustrates mind, body, heart, soul; more effective: there is a disclaimer about actors. Cons: Implies that real members must hide their faces in shame; could be perceived as anonymity break. Q. What was the process before the advisory action? A. The conference has to approve a video; which will still be the case. Having full faces requires an extra level of approval. The spirit is what evervone feels about full faces: more about using full faces than the process. Q. I was confused about the actor part. Do actors pretend to be members? A. Yes; we have disclaimers; that is part of the consideration. **Q**. Full face: if the actor subsequently develops a drinking problem, do we have to recall the video? A. We'll cross that bridge when we get to it. Q. I don't understand the motion? A. We want to go back to the way it was. We want to simplify the advisory action. Basically any PSA announcement that is created has to go to the GS Board unless it has a full face. We don't want that to happen as we feel full face PSAs are quite effective and very powerful. Q. I'm sure people will want to know the wording of the p61 advisory action. Can you read it? A. It's long. (Summary: Actors portraying members in AA videos shall not show full face unless the Board agrees.) Conference must authorize. The important thing is how do we feel about full faces? Q. Our trusted servants are trusted: changed last panel? A. Yes, we want to go back. Q. Did you find the spirit and the intent of the decision of the advisory action? **A.** It's about the perception. Concerned about anonymity breaks on line. Q. We want to see faces not cartoons. A. Keep questions about wording or intent. Q. Are you saying the board is well within its rights to simply disagree with a video: it says the board must agree. What does the board normally do? A. I don't know: we're asking that this level of scrutiny be eliminated. Q. I think I heard someone say there was fear. I'm wondering if we don't already have something in place with our traditional right of appeal? A. Obviously this is. **Q.** The only PSAs I've seen were 3-4 yrs ago at 3-4 am and I'd like to see them. I was impressed that there weren't faces. A. We need to move on with the spirit of the motion. Q. We're going to revisit the p61 motion and nullify it? A. Yes.

#### **OLD BUSINESS:**

**MOTION:** "That CNCA06 submit a request to delete 'of the opposite sex' from p117 in the book 'Twelve Steps and Twelve Traditions'." *Discussion:* Group is in favor// Unanimous to accept.//Yes, but minority felt it a slippery slope to change anything in program.//The adoption will be more inclusive. Some felt historical documents should not be changed.//Majority agreed to remove; mi-

nority said if we are to be politically correct we are starting a trend.//Group vehemently opposed to the motion: it's a Pandora's box; sets a precedent. Also felt that Bill W's writings are sacrosanct.//Group in favor. Minority thought other things might then open up to more changes//We support this despite the hurdles: it will make it more inclusive.//How many people have gotten and stayed sober with the phrase?//75% in favor; 25% opposed were old timers.//Preserve the original text with an asterisk with a comment.//Group overwhelmingly agreed: what would Bill have done if he were living now?// Focus on primary purpose.//Piece by piece overhauling of lit is costly. Consider the document as a whole. Leave it alone; it's already offensive.//Removing these words will allow more to be accepted in AA and out in the world. Are we being influenced by an outside entity?//Most in favor, existing language is divisive. Primary purpose would be enhanced.//Remove it; minority worried about cost.//Time to change//Majority of dist felt it time to discuss our outdated lit. Minority felt sponsorship is where to discuss. //Dist approved change. Minority felt our lit is divinely inspired.//Overwhelmingly supported out of respect and concern. It may however, distract us from primary purpose.//Unanimously voted to keep and apply a footnote that it was written in the vernacular of the day.//Yes// Unanimously in favor: it shouldn't be about sex and gender; times are changing. We should be inclusive, welcoming, and positive.// Unanimously in favor; no minority opinion.//Take it out: it's 2014. Times change. WE are not living in the 1950's Let's be as inclusive as possible.//Unanimous group approval.//Is there a need, if so make change: don't let fear get in the way.//Don't open the door. Once changes start they will occur every so often.//Wording is based on perspective. Substitute what you need.//Original intent was to maintain. Too many other places can change. Where would we stop?//Outside issue. Keep the historical concept.// Favor from a variety of members: "nearly every sound human being" was offensive to members. //lt's a small change that would make more feel included. Language should be more neutral.//Majority in favor: no discrimination. Keep AA open to everyone.//Write a pamphlet or change some of the stories in the Big Book.//Remove: akin to using "colored" following segregation. Excludes too many people. Minority said use an asterisk as we do on p34 of Big Book.//Don't freeze the text: keep all evolving in this modern era.// Language like this keeps the newcomer away.// Delete and open the floodgates in General Service.//We trust AA, General Service, and the process.//Do you want to keep it here or do you think it should go on?//Unanimously in favor; 10<sup>th</sup> tradition: no opinion on outside issues. It's about the newcomer.// This is about inclusivity; it falls under T10.//We hope we are more open-minded today and agree to change.//Put

# **ASSEMBLY BUSINESS MEETING MINUTES (Cont.)**

principles before personalities.// The minority should not dictate to the majority.//Current language is exclusionary. Good place to start change.//If this creates discussion throughout AA that would be awesome: create awareness.

Personal opinions: We were reading that page in a meeting and the person who read changed it.//I don't like hearing our lit described as historical documents and I'd like to see us move forward.//Gays and lesbians have always been a part of the program. It's a motion that promotes a political issue. (Will continue).

**MOTION:** "That future printings of the AA Service Manual include blank Group Change and New Group forms on the last page of the service manual." District 06. (*Will continue*).

Reports from breakout sessions: (The following notes will be kept brief. If you would like more info, please contact me or see your DCMC or DCM.)

Safety and respect: Many women come to us from a violent background and rough talk will scare them away. Sometimes a lack of observation of traditions in mtgs can escalate to serious problems (i.e.: suicide). Older members need not encourage inappropriate behavior. Men need to coach newcomers on how to treat others with respect, especially women. At one meeting inappropriate talk is not tolerated: they walk out. Traditions workshops might help: repeated flavor is that "I am responsible".

**Ego/Service Commitment**: Tradition 12 is where we offer our egos to AA. A trusted servant is a glorified messenger. We carry messages in two directions. Motive didn't matter why we went into service: God would smash egos and help do for us what we could not do for ourselves. If we love what we are doing, we will become good trusted servants. Our leaders learn to listen. Commitment is doing long after the desire.

Value of Service Sponsorship: You learn from another's experience: the needs of the fellowship, needs of others. Service helps us grow: use: manual, concepts checklist, and communication. Open mouth at business meeting only when dealing with traditions.

Anonymity and Social Media: GSO guidelines should be looked at. We are responsible for our own anonymity and that of others: when we break our anonymity we also break the anonymity of another. Just because I say I'm sober on the internet doesn't mean I'm a member of AA. The principle of anonymity is important, so I don't post on social media.

Variety and inclusion of all: 12 traditions teach us to embrace each other. Our primary person is our greatest asset. Customs of groups can be exclusive: we don't always treat everyone like family. Group change begins with the individual. Should we tolerate minor disruptions? How well do we practice our responsibilities?

Participating in GS is the art of inclusion. We are all different, but here for the same reason. "Bless them. Change me."

Gratitude in Action/Joy of Service: Service is vital. It's a great experience. It doesn't matter how to serve, it's a process learning to serve. Very happy if my service can help one person. I'm here because of someone else's service. I'm not the same person as when I started. There is joy in my service. Service helps form my character. HP knows our needs. Gratitude came after many years: I'm the planter, but God grows the crop. "WHAT'S ON YOUR MIND?"

It's been a nice day and we are learning a lot from you. We started a workshop in Area 93: we are inviting you to our 5th workshop. Hopefully we will someday have you guys as regular participants. We celebrated the anniversary of La Viña and were helped by Area 6: we are going to create guidelines for the La Viña celebration to make it easy. We decided to send 2 people from each area to participate in an ad hoc committee. Raymundo and Javier will attend from CNCA. Spanish Forum in Oct. I really appreciate being here. //It's a record summer assembly and third largest ever: 305/162=467!// Diversity workshop was excellent. Members who use medication; we all know AA has no opinion, but we really need to think of it: we are missing a lot of members. I hope we can open our minds to any person who has alcoholic problems.//I have one volunteer for BTG work: Claudia R, but no contact info.//I have flyers for the ACYPAA conference in San Jose. We are filling up fast.//I forgot to thank Teri Munson for hosting the preassembly dinner.//Elections assembly Nov 8 in San Jose. Hope to see you there.//We collected \$1970.00 (30%/cost).//This has been an awesome assembly. Thanks to the district.//Most of the membership surveys are in. Send them soon. You have buoyed me on this journey. I have not been alone. Come to the assembly in San Jose: look inside and see how you can serve your Area, District, and group.//Thank you for allowing me to be of service. This is the last assembly I'll be chairing, so thank you. You have given me so much and you've been very patient.

The meeting was closed at 4:45 with the Responsibility Declaration.



Facilitate the monthly area PI/CPC meeting the fourth Saturday of the month at 11am in Petaluma. Relay and coordinate sundry reguests. Attend sundry events, and coordinate coverage of events at which PI or CPC has a presence throughout the area. Answer sundry considerations. Prepare and distribute agendas and minutes; facilitate their translations. Manage contact information. Store equipment, and coordinate its use throughout the area. Deliver birthday envelopes to the birthday boys and girls and the Area Committee. Attend all Area Committee, Assembly and Officers meetings. Travel to three district meetings per month.
