I would like to thank you all for your great hospitality in each one of our districts. In 2000 at the International Convention I was invited to participate in one of the workshops; by then I already had my collection of La Viña which is kept at my home group. Also I would like to mention something about the Grapevine. The 72 thousand subscriptions that we have monthly, usually are read by about two more people each, which means that we are able to reach out over 200,000 readers.

Thank you all for your Grapevine gift subscriptions to the inmates that have requested them; all five of them have been fulfilled.

I would like to remind you to encourage young members in your area to write their personal stories for possible inclusion in the revised pamphlet "Young People and A.A." Stories should reflect "in a general way what we used to be like, what happened and what we are like now." Manuscripts should be 500 - 800 words, double space, in 12-point typeface. The words "Young People and A.A." should appear on top of the first page of the manuscript. The author's complete name, address and email/telephone information should be included with the submission. It can be emailed to: Literature@aa.org with "Young People and A.A." inserted in the subject line of the message. Alternatively, submissions can be mailed to: Literature Coordinator, General Service Office, Box 459, Grand Central Station, New York, NY 10163. The deadline for all submissions is December 30, 2016.

The AA Preamble was read by Kathleen of District 07, Tom of District 07 read Tradition 6 and Betty of District 12 read Concept 6. There were 2 past delegates present: Diane O. (Panel 35), and David N. (Panel 59). There were 4 GSRs and 1 new DCM present. One Visitor: Valley K., Class B Trustee from GSO India. The May minutes with the correction: "Bridging the Gap Committee report was given by Larry B." and financial report were accepted as printed in *CNCA Comments*. Birthdays: 4/85

Registered attendance: Voting= **61**, Non-voting= **26**.

### Officer Reports

**DELEGATE Raymundo L.:** I have had a great time giving my reports to the Districts. Thank-you for your hospitality. I have done 9 reports so far and am looking forward to 14 more. I received an email from Jeff at the Corrections desk in NY. I am very touched when I hear from inmates that have asked for help and they thank you for our contributions to be able to provide for them. I have received 5 requests for inmates requesting subscriptions to the GV. If you would like to help, please see me during the break. There will be a delegate's reunion June 16-18, 2017 in San Jose. There is also a call out for Young People's stories from NY. The essay should be 500 to 800 words, double spaced in 12 pt. fonts. With Young People in AA at the top of the manuscript and also in the subject line of the email. You can send the email to LiteratureAA.org I have also sent this out by email to the DCMC's. **ALTERNATE DELEGATE Phil B.:** We have been busy this panel, and this is a good time to relax and smell the roses. This is a great time for you to think about your pass it on to the next person in line for Panel 67. This will be a great tool for the person stepping up into your position.

**AREA CHAIR Joann L.:** I have a new cell number. The new number is [listed in the print version of the CNCA Comments]. I have had lots of help from the Finance Committee, who I would like to thank. We have completed 183 receipts today.

**REGISTRAR Ray W.:** I gave my job descriptions today at the DCM sharing session. **RECORDING SECRETARY Barbara S.:** Today is my first day as a non-smoker. I am still working on the motions book and Raymundo and I are getting close. Thanks to all that have

helped in the process so far. We hope to have up to date by the end of this panel. It would be great for the Spanish Districts to have a copy of the motions part of our Motions Book. **ASSEMBLY COORDINATOR Michael Q.:** I attended the planning meeting for the Summer Assembly with District 03 and 40. The lunch menu looks especially inviting and preparations for our outdoor workshops will make this a unique and exciting experience. Flyers in Spanish and English are available on the front table. The final flyer listing the workshops will be sent out next week. Today is the deadline to submit suggestions for the workshop topics. Please hand your district's suggestions to any officer. This is an opportunity for communication with our GSR's, an opportunity for Unity and a real opportunity for sharing experience strength and hope, not to mention that it's just plain fun. There are still 7 open assemblies for Pane 67; a list of suggested dates is available on the front desk. Please start this discussion with your district. **LITERATURE/GV/LV Agustin L.:** Grapevine is looking for Stories on the following: "Remote Communities – How to stay sober in faraway places" (deadline July 5<sup>th</sup>). "Emotional Sobriety (deadline August 1); "Making Amends" (deadline September 11). "Service during the Holiday" (deadline July 5). There will also be 3 vacancies on the "Editorial Advisory Board" of the GV in September 2016.

### District Reports

**01 MONTEREY Susan G.:** We had light attendance at our monthly meeting. We discussed "Anonymity Online" with the service material handout from GSO. We had a presentation on the Summer Assembly and the Feasibility Study. We are excited to have Dessert with the Delegate next month in lieu of our regular meeting.

**02 SALINAS/SAN BENITO Elijah H.:** We had our first GSR orientation on June 1<sup>st</sup>. It was well attended and enthusiastically received. Everyone had a lot of questions so we'll be busy learning and growing. A few of us attended the 21st Anniversary celebration of District 19. We enjoyed wonderful fellowship, food and music with inspirational speakers. Several individuals have expressed an interest in helping to serve breakfast at the summer assembly, so we are looking forward to that opportunity.

**03 SANTA CRUZ Jeff W.:** We had a great meeting. We had the Delegate's Report along with a potluck. We are looking forward to having the summer assembly. We are limited to 100 for Dinner, but the meeting will be open. We are having some of the workshops outside, so bring a blanket, chair or beach balls and enjoy the fairgrounds.

**04 SANTA CLARA NORTH Eric L.:** After a nine-month trial period, the district decided to permanently use Slack as a secure means of communicating within the district. group believes that it is not relevant and does not reflect the AA membership. We had a presentation on "How to put together an Assembly and what comes out of it." We also had a guest that shared a little about how AA works in India, generating lots of questions and interest at the meeting.

05 SAN MATEO *Erica S.*: We are having our Unity Day in August. Flyers are on the table and everyone is welcome. We had a motion pass to fund "Bus Placard PSA's for a 2-3 month period this winter and next summer. Every Samtrans bus will have in English and Spanish our PSA posted. A motion also passed to form an ad hoc committee to gather information on insurance for the District. We are also reading job descriptions and talking about what it means to be available.

06 SAN FRANCISCO *Rhys G.*: We had the Delegate's Report this month at our District meeting. We are working on our Unity Day with Intergroup and how to retain GSR's for next panel.

07 ALAMEDA NORTH *Thomas V.*: After the whirlwind of activity around the General Service Conference, we settled back into our motions and discussions and learning about GS. We had a presentation on lifting the veil on what happens at the meeting in Petaluma on the 4<sup>th</sup> Saturday.

### **Area Sub-Committees**

ARCHIVES *Richard W.*: We discussed our 11 upcoming District and Area events. We discussed our upcoming workdays including a discussion of our past workdays. We discussed in depth the features of the upcoming National AA Archives Workshop program on Sept. 8-11. We are doing a push for group histories. There are group history forms on the back table.

BRIDGING THE GAP *Bill B.*: We had 7 Districts reporting with 24 Presentations and 101 Requests for Contact. Our Correspondence Secretary, Larry, facilitated 11 out-of-area requests, all inside California. 6 letters were received; one was referred to GSO for corrections correspondence. One letter met the criteria for the short term pilot correspondence program and was assigned to a volunteer. We continued to plan for the BTG Forum on Oct. 15, 2016 at the Hoover Theater in San Jose. We discussed our pilot program with the aim of developing a BTG Committee group conscience at our August meeting to present to the area committee in September. We discussed splitting the BTG Correspondence Secretary position into 2 positions: an electronic correspondence secretary and a written correspondence secretary, effective Panel 67.

FINANCE COMMITTEE *Russ A.*: Next week committee chairs will be receiving Budget Worksheets for the next panel. These will include YTD expenditures through June and will be in Excel format. Keep in mind that you will be planning for some completely new committee members. Your experience is vital to the process of formulating a useful budget. We have invited a guest to attend the finance committee meetings. If you are interested in possibly serving on the committee next panel, please let one of our committee members know. We will be presenting a motion today regarding accepting contributions electronically.

PI/CPC *Phil B.*: Every month we get an update from GSO and this time they have an action request regarding Anonymity and the media. Please send sharing about Anonymity – (and the ongoing challenge). Here are some of the questions that might help explore local members about this vital principle. 1 – How does your committee utilize a variety of ways to share information. 2 – What has your committee found to be effective and not effective? Our topic today was “AA’s cooperation with treatment settings.”

WEBSITE COMMITTEE *Cheryl G.*: We passed the documents today for the Web Committee and will be providing copies of all to you next month at the ACM. We will have a motion today to send a member to the “National AA Technology Workshop,” this fall in Salem NC.

### INTERPRETATION AND TRANSLATION COMMITTEE

*Claudia N.*: We have a lot going on in translation requests.

Please always send your documents in a “Word” format so changes needed can be highlighted. This will expedite the process of translation. 1 member has been informing the committee on translation software to better streamline translation as a whole. We formed an ad-hoc committee to review “How will radios help our area in the translation needs through the year and provide sustainability to the process.” The lending program for radios is going well and we will experiment next month with a limited amount of radios to be available at 9:30 in the lobby.

CNCA COMMENTS *Robin T.*: We mailed 963 bulk and 41 first class Comments for 1004 total. Our next mailing party is July 7 at the Ukiah Fellowship Group. We were asked to increase the Comments to 20 pages in June to accommodate the Post Conference Assembly and Job Descriptions. This caused an over budget of \$63.51. The average number of pages has increased this panel, partly due to our using a larger font size.

COMENTARIOS DE ACNC *Manuel R.*: This month we had problems with the printers and we will be sending out this week. Sorry for the delay.

DCM SHARING SESSION *Claudia N.*: We had a presentation today on “Concept 3 – the Right of Decision.” Next month, we will have a presentation on “The Warranties,” A Brief Overview.

GRAPEVINE/LA VINA *Agustin L.*: We had a presentation today on “What’s in the GV.” We talked about Bill W. and all the articles he wrote for the GV, and how it started with the original 6 volunteers. GV/LV is a great tool for communication within the fellowship. Next month we will have a GV study meeting.

NCCAA *Diane O.*: The conference in Santa Rosa was outstanding. They passed a motion to have “Drunk Junk” at the next conference. The next conference is in Modesto on October 7<sup>th</sup> - 9<sup>th</sup> at the Centre Plaza. Registration is opened now. \$15 for pre-registration and \$20 at the door. Great panels and speakers are scheduled all weekend.

H&I *Diane O.*: We enjoyed the NCCAA Conference. We passed several revisions to our Pink pamphlet and we also changed our reimbursement for mileage and lodging to a more reasonable reimbursement to those involved. They will be included in the next printing of the Pink Pamphlet.

LA VINA ANNIVERSARY *Joshua H.*: We are ready to head to AZ. The reservations are made. The committee gave their final report in Bakersfield, CA Area 93. Their report included the treasury at \$15,069.54 as income and \$11,645.43 in expenses. Leaving \$3,699.11 in the bank. 512 registrations have been made. Looking for help with the banquet; they have sold 51 tickets and need to sell 150.

NATIONAL AA ARCHIVES WORKSHOP *Laura W.*: The NAAAW will be held Sept 8-11 in Concord at the Hilton Hotel. We are excited that our program is just about set. Feel free to take a look at it on the display board on the table.

New Flyers are available in English and Spanish. One main presentations are listed on the flyer now. We do need help with pre-registrations. This is essential for planning the event and meeting our current expenses. We also need help filling service commitments, everything from greeters to transportation.

Yes, we are looking into having a service that does not store the payment information. Q. How much does this cost? A. For set up it has no cost, but there is a small cost for each transaction, but we expect our contributions to increase to cover the cost. Q. I understand that contributions will increase from this, but do we want to pay a fee for payment that is not a contribution.// A. Good questions, we will have to consider that.// The committee came to this as to how we could be of service to our groups. We realized that the numbers of checks that are written each month by members is getting smaller and smaller. We feel this would be of service to our group. Q. I am from a small district and we now send checks. Would we need to get a credit card to make a contribution? A. No we will be expecting to take payments of all forms. Q. Is this to be able to accept payments on line and by check? A. Yes. Q. Are you anticipating who would have access? A. Yes, it would be limited. Q. Do you know how much this would increase our donations? A. We don't have any information except that contributions go up. Q. Are you still going to accept payments the old way or would it only be done by square? A. No.// The reason the motion is as brood as it is stated, is because this technology is constantly changing and we wanted future panels to use the best solution at that time.// Q. ##### Sharing of Experience, Strength and Hope from Valley K., a Class B Trustee from GSO in India:

I have attended about 28 meetings in the 14 days since I have been here and they look nothing like meetings in India. They start at 6 A.M. and they continue at all times during the day. I like the formats that you have. Santa Clara told me they had 600 meetings in their Intergroup. That was a shock; we have only 2,600 meetings in the whole country. I have been nominated as Trustee last year. I started as a treasurer, and I passed the delegate's position. I have watched one conference and had no voice. I have been visiting countries and have been home only 21 days this year. In India we have over 22 different languages and our Big Book took over 8 years. We need to translate into other languages. I serve on the Treatment Committee and the Finance Committee. I am not good with numbers so I like the Treatment Committee better. We do not combine this with H & I in our country like you do. We have this as a separate committee. I attended District 40 and 4 district meetings and plan to share my experience with my groups at home.

##### Discussion Topic:

**"Should the Area form a ACCESS Committee, or what are the benefits to forming an ACCESS Committee."**

Discussion: We are having an access committee at the Archives Workshop. I like the idea of it being more of a sharing session format to start. We would be able to share ideas and make AA more accessible to others.// Is this a committee that would be focused on the events of the area and meetings we have, or would this be members from each district sharing experience, strength and hope, or would it be both. There are good reasons for both.// Yes.// I discussed with some members at our district and we will be having as a discussion topic at our district. This is a new idea for our district and I think if this was at area, my district would learn how to carry the message to others.// We had this as a motion a few panels ago, and out of that discussion District 12 formed a committee and it has grown over the years. I think this would be a great committee that could provide services to the District and would receive support from GSO.// I love this idea. I have benefitted from some of the workshops District 12 has done. This could be the source to make presentations at other Districts to share experience as well as an educational tool for our members.// Some Districts do have ACCESS committees. Is this an area committee, or should be encouraged at Districts to have their own committees and we provide a forum for them to share ideas.// I think this is a great idea. The question on whether it would be representatives from Districts or an appointed committee can all be worked out. There are many areas that they would be able to discuss. Maybe this is something that should start at the local level and move up to the area. #### **Presentation: Concept III, Right of Decision; Gilbert G., District 6 San Francisco**

- Each element of world service is endowed with the Right of Decision.
- We need the right of decision and service authority in order to be effective
- We need to trust our servants to determine which decisions that they can exercise the right of decision and when to ask for feedback and input.
- We as DCM's need to relay this to our GSR's.
- We need to look inwardly when making decisions. We need to step back and not take action based on EGO.
- There will always be plenty of "ultimate authority" to correct any abuse of the Concept.
- Even when using the right of decision, proper communication is essential. This insures mutual trust.

#### **Discussion:**

- What about GSR's making a change at the mic after hearing the consciences of others at the Pre-Conference Assembly?
- When you are carrying the group conscience you are a messenger
- When you are voting, you may make a vote change if you've heard of something else that guides you in a different direction.
- I used my right of decision to "threaten" my group that if they don't participate, then I would have only my own opinion and decision.

- This ties in closely to Warranty Four which gives us the option to decide by simple majority and not substantial majority.
- The right of decision is a responsibility. To my group, my sub-district and my district.
- Concept III regarding the responsibility to vote responsibly. We as DCM's need to inform our GSRs.
- As a servant it is often necessary to know what our group or subdistrict or district wants and to vote that way.
- Refer to the Concepts for World Service Illustrated. The Dr. Seuss version!
- Circles of Love and Service is also a good primer to get people started to understanding how World Service operates.
- Every group conscience gets filtered through we as servants and as such carry our opinions and "flavor."
- I was told to listen. To look at what is best for AA as a whole. What is right for my group might not be best for the district. What is right for my district might not be best for the Area and what is best for my Area might not be what is best for the rest of the country.
- In order to do this, you must first know what is best for you and your group. Then you need to go to PRAASA and beyond to have a better understanding of what others do. Listening is a critical tool. Listen without what you bring to the table and listen to the rest of the table.
- The Grapevine is a good place to find out what people in other areas are thinking of.
- If the business is carrying the message and the income is the newcomer. Decisions should be made with the newcomer in mind.
- This involves multiple concepts and traditions. We need to understand that all of our decisions affect AA as a whole.

Placement of the below text will follow the current section **Note to medical professionals** (page 90)":

"Some alcoholics require medication.

We recognize that alcoholics are not immune to other diseases. Some of us have had to cope with depressions that can be suicidal; schizophrenia that sometimes requires hospitalization; bipolar disorder, and other mental and biological illnesses. Also among us are diabetics, epileptics, members with heart trouble, cancer, allergies, hypertension, and many other serious physical conditions. Because of the

difficulties that many alcoholics have with drugs, some members have taken the position that no one in A.A. should take any medication. While this position has undoubtedly prevented relapses for some it has meant disaster for others. A.A. members and many of their physicians have described situations in which depressed patients have been told by A.A.s to throw away the pills, only to have depression return with all its difficulties, sometimes resulting in suicide. We have heard, too, from members with other conditions, including schizophrenia, bi-polar disorder, epilepsy and others requiring medication, that well-meaning A.A. friends discourage them from taking any prescribed medication. Unfortunately, by following a layperson's advice, the sufferers find that their conditions can return with all their previous intensity. On top of that, they feel guilty because they are convinced that "A.A. is against pills." It becomes clear that just as it is wrong to enable or support any alcoholic to become readdicted to any drug, it's equally wrong to deprive any alcoholic of medication, which can alleviate or control other disabling physical and/or emotional problems."  
*Presented by District 07*

- "That language similar to the following be added to the section "How Decisions Affecting A.A. Are Made" in "The A.A. Group" pamphlet at the conclusion of the following sentence: "Annually, groups from the U.S. and Canada elect delegates (serving two-year terms) from their areas to the yearly meeting of the Conference in New York -- to hear the reports of the board's committees, G.S.O. and Grapevine staffs, and to recommend future directions, mainly in the form of Advisory Actions."

*"Prior to the annual General Service Conference a list of important issues to be discussed during the Conference is published and made available to each and every Group in the U.S. and Canada. Because these issues make up a part of the entire General Service Conference Agenda, they are referred to as Agenda Topics. Every Group in the U.S. and Canada has the opportunity to review, discuss, and develop an informed Group Conscience on these Agenda Topics. The Group's GSR then carries the Group's Conscience on Conference Agenda Topics to the Area's Delegate, usually at an Area Assembly prior to the General Service Conference.*

*The Area Delegate then represents the collective conscience of the Groups in the Area at the General Service Conference on these matters vital to A.A. as a whole." Presented by District 11*

## AREA OFFICER JOB DESCRIPTIONS

### **Area Registrar**

The Area Registrar maintains records of the groups in CNCA, Active, Inactive, Disbanded, Vacant (those with no GSR or Additional Mail Contact) approximately 2000+ groups. Along with records of Area Committee members in CNCA, and sends changes to GSO. New groups are checked against present group records, to avoid duplications. Timely changes ensure that the new trusted servants (GSRs, etc.) receive their GSO mailings as soon as possible. Changes come from District Registrars and other sources. Returned CNCA Comments gives some new addresses; these are changed in the area database then sent to District Registrars and GSO. Frequent trips to a local Post Office are to be expected. Sometimes there are mass changes when a District rearranges sub-districts. Accuracy is important. Each month the Area

Registrar supplies each district with a Sign in Sheet reflecting the current contact information contained in the area database. The Area Registrar also sends conformation forms for each change made to the District and to the GSO records department. The Area Registrar also has access to the GSO's FNV database, that access is mostly used to research and resolve discrepancies between the Area database and the GSO database.

Printing mailing labels for CNCA Comments is a function of the Area Registrar. Contact with the Area Newsletter editors (English and Spanish versions) helps to insure the labels arrive in time for the mailing. We use a combination of first class and bulk mail so knowledge of Bulk Mail Regulations is helpful. In addition to the DCMC and Area Officers Roster, the Registrar produces a variety of reports for the Area Committee and Districts, such as attendance at Assemblies and

group records. The Registrar has to learn the software provided with the Area Registrar computer and become adept at its use within the first month of the panel.

For assemblies, the Area Registrar arrives early, with Assembly Registration sheets, name tags, pens, markers and stickers; and stays until the end; maintains Assembly attendance records, analyzes and reports trends. Prior to the Election Assembly, the Registrar prints a list of people eligible for Area Office, so that those present may respond to their name read aloud saying "available" or "not available" during the third legacy election of Officers.

Over the past 3 panels Area Registrars averaged 35-50 hours monthly doing just the Registrar duties. Note that this does not include other officer duties such as District visits, Assembly Attendance, and ACM attendance. During the first year of the panel, count on an extra eight to fifteen hours per week in January, February and March, for the area wide rotation and your learning curve. In the second year of the panel, extra time is required in the same months for the "Annual Updates"

Time for District Visits varies each month, depending on distance and districts visited. Plan on 3 district visits per month, On the average, each Area Officer visits 3 districts per month

and travels anywhere from about 4,000 miles to 16,000 per year doing district visits. These figures do not include the travel to the 4 Assemblies per year, nor the monthly Area Committee meeting.

The start of the panel will be the most stressful for the new Registrar. It gets easier as you become familiar with the job. I will be available to train you in your new position and there are many templates, forms and computer "Pass It On" tools stored in the Area Registrar's Laptop.


