### Chair Preview

At the March Area Committee Meeting (ACM), the following housekeeping motion passed without objection: "That CNCA present an informational workshop on the options available to groups and districts in respect to organizational structure (or lack of structure) to include material on the associated responsibilities, the workshop to follow an upcoming Area Committee Meeting (tbd) and to be at a cost not to exceed \$500." This came as a result of a two-month ACM discussion about whether there was a need for a workshop on non-profit status and tax ID numbers for groups and districts. The intent is not to give any specific advice, but to offer good information from qualified professionals to help inform the group conscience. The workshop is tentatively planned for the 4<sup>th</sup> Saturday in August, directly following the regular ACM, and is open to anyone in the fellowship who might be interested. Keep an eye out for the flyer and more details!

Every month from now through October we will hear a different Area officer give a presentation on the responsibilities of their position during the first 10 minutes or so of the DCM Sharing Session. Those will also be printed here in the *Comments*.

I hear rumblings of motions coming from our various standing and sub-committees, so things won't be quiet at the ACM for long. Meanwhile, we continue to focus on the business of A.A. as a whole and our Assembly motions. I'm eager to hear all about what happened at the General Service Conference when our Delegate returns, and enjoy the fun and fellowship with all of you at our next assembly in May.

Ok, so I confess. I heard this in another 12 step program. But I have found it so helpful and insightful I can't help but share it. And those who know me know I share it a lot. It's a different way of saying the 4<sup>th</sup> Concept. Participation is the key to harmony. It's so insightful I will say it again. Participation is the key to harmony. How true is this when it comes to our group conscience? If members of a home group do not participate in sharing sessions for the group's business, then a true group conscience may not occur. I have also said that you never know who in the room is going to have the information that might just break your heart wide open. Those of us who have had the experience of being at an assembly where they have heard a heart-felt share during a minority opinion know that this can transform an entire room of people. It does take all of us to come to a true group conscience. And it particularly takes our individual courage to speak up, speak from the heart and speak our truth when we are at a sharing session. We in CNCA are a little bit spoiled. I noticed this at PRAASA when after everyone shared at the mike, people clapped. I know it was just politeness but think of the time that could have been saved by asking people not to clap. The only clapping necessary should be the warm applause when someone went over their time. But the other really good reason for not clapping here in CNCA is to create a safe place to share. (No remarks, no booing, no clapping, no shrugging shoulders, no eye rolling when someone shares.) For some of us, sharing in front of others is intimidating enough without worrying if the group will react to our share. Creating a neutral space helps.

This fourth concept of participation particularly applies when it comes to our assemblies. I want to say especially the Pre-Conference but I am going out on limb here and say it is important the GSR attend all of the assemblies. No exception. The reason for this is that the assemblies are the AA groups' opportunity to express their opinions, thoughts and feelings on business matters that will affect all of AA. This is where the AA groups' responsibility to care for the structure of AA, through participation, is fulfilled. It is a big responsibility to ensure that AA will be here for generations to come. It will not be here in the future if the groups don't take part in the Conference by informing their Delegate. The area assembly is where the AA group, through their GSR, fulfills this responsibility when they participate in the discussion of the business. I can't tell you how exciting it is to just sit and listen at the Pre-Conference assembly. I get to feel your love of AA and the hope for its future.

Participation is the key to harmony. When we talk and talk and talk about an issue, then the vote on that issue results in substantial unanimity, there will be harmony in the group. But everyone's voice matters. I look forward to hearing all of you at the Pre-Conference Assembly in April. Thank you for letting me be of service to Alcoholics Anonymous.

## AREA COMMITTEE MEETING MINUTES FOR MARCH 2018

The monthly committee meeting of CNCA was held March 24, 2018 at the Petaluma Community Center. Jennifer B. opened the meeting at 12:30, followed by the Serenity Prayer. The AA Preamble was read by Lynn K. (District 05). Elvia P. (District 12) read Tradition 3 and Jack A. (District 10) read Concept 3.

There were five past Delegates present: Diane O. (Panel 35), Woody R. (Panel 50, Area 07), Doug G. (Panel 53), Sharon A. (Panel 57), and Ken M. (Panel 61). Doug G. currently serves as an appointed committee member of the Trustee's Literature committee. There were 5 GSRs present and 1 new DCM present. The February 2018 minutes and financial report were accepted as printed. Birthdays: 109/8.

Registered attendance: Voting (53) / Non-voting (47)

### Officer Reports

**DELEGATE – JOANN L.:** At the Remote Communities meeting prior to the Conference, we will be sharing on carrying the message to the armed forces and the military. If any of you have experience on this, please share it with me. Raymundo L. is in Cuba and I look forward to hearing about his experiences when he returns.

**ALTERNATE DELEGATE – TEDDY B.:** I am praying extra hard these days for our Delegate. The Alternate Delegate must be prepared to attend the Conference if necessary. So in addition to becoming familiar with the topics, the set up and the procedures of the Conference I am also looking forward to paying great attention to all that is said at the Pre-Conference Assembly.

**CHAIR – JENNIFER B.:** The officers are putting together an ad hoc committee to look at some of the issues raised in our discussion regarding the *Comments* and *Comentarios*. Do not forget your FM radios for the Pre-Conference Assembly; headphone splitters are one great way to share radios. If you would like a copy of the list of Agenda Topics we will be hearing group consciences on, and in the order we will be hearing them, I can email it to you.

**TREASURER – CHRIS H.:** As of today, we have \$23,500 in our checking account (used for operating expenses) and \$11,140 in our savings account (prudent reserve). We received \$5600 in contributions and spent \$7700.

**REGISTRAR – LAURA W.:** I have been working to restructure our new database to accurately represent the groups and service positions in our Districts and Area. Although we were able to transfer the data, we have to recreate most of the relationships within the database.

Through this process, we have been able to remove 4000 inaccurate records.

**RECORDING SECRETARY – ERIC L.:** Several people have volunteered to help transcribe the Motions Book; we will start this project soon (we waited to give people who thought they could find a technological solution to the formatting problems in the current version a chance to find it).

**ASSEMBLY COORDINATOR – ERICA G.:** I look forward to seeing all of you at the Pre-Conference Assembly. We bought out a large parking lot, and no one will need to pay for parking; look for our volunteers in orange vests holding CNCA signs to guide you to our lot.

**LITERATURE/GRAPEVINE/LA VIÑA – MIGUEL H.:** The *Grapevine* and *La Viña* subscription challenge runs through December this year, and you can monitor each state's progress on the website.

### District Reports

**DISTRICT 01 (MONTEREY) – SUSAN G.:** We discussed three Agenda Topics and will be celebrating Unity Day in June. Our Monterey Bay Intergroup will be celebrating its 50<sup>th</sup> anniversary in July.

**DISTRICT 02 (SALINAS/SAN BENITO) – ELIJAH H.:** We continue discussing increasing our prudent reserve, and have formed a committee to develop a Secretary's Workshop.

**DISTRICT 03 (SANTA CRUZ) – ERIC H.:** Several members from the District attended PRAASA, and we held a successful Agenda Topics workshop that started exactly on time.

**DISTRICT 04 (SANTA CLARA NORTH) – MARIANNE G.:** We elected a new Recording Secretary, discussed different Agenda Topics, and practiced speaking into the microphone. We did not have a microphone, so we used tongs.

**DISTRICT 40 (SANTA CLARA SOUTH) – COREE H.:** We heard a presentation on how the Agenda Topics process differs by Area, held mock group consciences, and discussed the value of non-AAs participating at the International Convention.

**DISTRICT 05 (SAN MATEO) – COLLEEN G.:** The recipients of our PRAASA scholarships gave reports of their experience, and we are discussing motions to increase our mileage reimbursement and to disburse excess funds to GSO.

**DISTRICT 06 (SAN FRANCISCO) – DENNIS H.:** Our Agenda Topics workshop was well-attended, and we took a group conscience on the proposal to publish 'The

God Word.' At our District meeting, a moving presentation on the Hispanic Women's Workshop prompted an emotional response.

DISTRICT 07 (ALAMEDA NORTH) – PATRICK C.: At our meeting next week, members who attended PRAA-SA will report on their experiences.

DISTRICT 70 (ALAMEDA SOUTH) – DON Z.: Our Agenda Topics Workshop was a great success; 40 people attended and it generated a lot of interest in our District. Two previously unrepresented groups decided to elect GSRs.

DISTRICT 08 (CONTRA COSTA) – DON L: We elected a new Special Events Chair, heard reports from our PRAASA scholarship recipients, and continued preparing for the Pre-Conference Assembly with presentations on obtaining a group conscience and using the Agenda Topics summaries.

DISTRICT 09 (SOLANO SOUTH) – CLAUDIA K.: We will be holding a special election to fill three available committee Chair positions. Our Post-Conference Assembly planning committee is having a lot of fun.

DISTRICT 90 (SOLANO NORTH) – GENE K.: We held our Agenda Topics Workshop and we had a good turn-out, great discussions, delicious chili and cornbread, a gaggle of giggles at the skit, and an all-around wonderful experience.

DISTRICT 10 (MARIN) – ROBERT P.: We continued discussing our participation in a Safety Workshop co-hosted with District 06 and the SF/Marin Intergroup. We heard warm and heartfelt reports from PRAASA and ACYPAA, and our PI/CPC committee is encouraged by the response from a podcast made with iHeart Radio.

DISTRICT 11 (NAPA) – CHITRA S.: Our make-up District meeting (complete with pizza) was well-attended. A motion on time limits for reports and presentations passed, and we are now visiting unrepresented meetings.

DISTRICT 12 (SONOMA) – CLAUDIA N.: Several of us were unable to go to PRAASA because of the weather, so we went to ACYPAA instead. It was amazing and wonderful.

DISTRICT 13 (LAKE) – MARY ELLEN R.: Despite the bad weather, three members from our District attended PRAASA, including a new GSR who drove after work, got stopped by the blizzard, slept at a gas station for four hours, and arrived to Reno by Saturday morning. We also passed a motion to re-subscribe to the *Grapevine*.

DISTRICT 14 (MENDOCINO) – ROBIN T.: GSRs have been gathering group consciences and we have also been reaching out to unrepresented groups.

DISTRICT 15 (HUMBOLDT/DEL NORTE) – JOHN L.: Five of us were able to attend PRAASA, overcoming arduous conditions on the high-ways. During our regular business meeting, we allocated \$800 in unused scholarship funds for PRAASA to go toward the Pre-Conference Assembly.

DISTRICT 16 (SPANISH CENTRAL) – FRANCISCO R.: We attended PRAASA. We hosted the Inter-District meeting and are grateful for the participation from everyone.

DISTRICT 17 (SPANISH SOUTH) – MARIO S.: We were very busy this month. 18 members of the District attended PRAASA, we attended the Inter-District meeting, and GSRs continued discussing Agenda Topics.

DISTRICT 18 (SPANISH NORTH) – HECTOR C.: We are grateful for the unforgettable experience at PRAASA. 22 members attended, including six new GSRs. Our District also disbursed \$250 to the General Service Office.

DISTRICT 19 (SPANISH SOUTH SOUTH) – MAGDALENO O.: We heard a presentation about the Agenda Topics and hope to participate in this process. The week following the Pre-Conference Assembly, we will be attending a convention in Watsonville and presenting on the pamphlet 'Three Talks to Medical Societies.'

DISTRICT 20 (SPANISH EAST) – TEODOMIRO S.: We are helping GSRs as they gather group consciences. Our I&T committee received its equipment and is excited to be able to provide interpretation when it is re-requested.

### **Area Sub-Committees and Sharing Sessions**

ARCHIVES – RICHARD W.: If anyone has archival digital pictures, please email them to me. We will be holding our Quarterly Training and Workday on April 14 at our Repository in Walnut Creek; the focus will be on oral histories.

BRIDGING THE GAP – LARRY B.: This month, your BTG committees gave 19 presentations and handled 50 requests for contact. At our committee meeting today, we shared on the Agenda Topic regarding literature for long-term confined alcoholics about to be released.

FINANCE – CLAUDIA N.: We shared on the Finance committee Agenda Topics this morning. We also noted that it costs approximately \$20 per member to put on an assembly.

PI/CPC – TEDDY B.: Two national conventions of professionals are coming to San Francisco, and CNCA members will be staffing the AA presence. The Aging in America convention is in March, and the American Psychological Association convention is in August.

WEBSITE – ROBERT E.: We had two separate ad hoc meetings at the same time this morning; one worked on the new website and one worked on our guidelines. We are working on integrating online contributions on the new site, and we are discussing who to send to the NAATW in September.

INTERPRETATION AND TRANSLATION – MICHAEL Q: PRAASA was a wild experience for some members of the committee and our interpreters. There were avalanches, hundreds of text messages, and one persistent member who managed to ensure that he arrived so that there could be simultaneous interpretation. Our interpreters took a 12 hour detour to arrive just in time. In our meeting today, we discussed possible solutions to our ongoing translation challenges and passed a motion regarding interpreters at assemblies; we will present that motion to the ACM next month.

CNCA COMMENTS – JOSÉ A: 868 copies of the *Comments* were sent via bulk mail and another 116 were sent first class; mailing was delayed because of personal problems. We are sorry and promise it will not happen again.

COMENTARIOS DE CNCA – ERIC H: The *Comentarios* were sent on March 18 to approximately 175 members of our Area; we thank the I&T committee for their translation help.

DCM SHARING SESSION – JUDY W: We heard a presentation on being an effective service sponsor. People shared about how recovery and service sponsors share the same common thread of strong spiritual principles.

ACCESSIBILITIES – CAROLYN MC: We heard a presentation about the Aging in Sobriety workshop in District 12, and we discussed how to use those ideas in other districts.

LITERATURE/GRAPEVINE/LA VIÑA – ALLISON S: We discussed the *La Viña* anniversary, PRAASA, 'The God Word' pamphlet, and social media. The only consensus we reached was that we will likely be discussing God and anonymity for at least another 20 years.

NCCAA – WAYNE B: We will be electing a new NCCAA chair in San Ramon. NCCAA will be held March 30 to April 1, and the continuing success of Al-Anon and Spanish-speaking participation has been

great.

H&I – KAREN B: H&I is accepting online contributions. Literature orders continue to be based on current contribution levels, and we are grateful for the contributions that make it possible to carry the message to the confined alcoholic.

LA VIÑA 22ND ANNIVERSARY – JUAN MANUEL H: I attended PRAASA and registered members for the anniversary. I also attended District 17 and will attend NCCAA.

TECHNOLOGY AD-HOC – SHARON A: We are finalizing our report and recommendations. The plan is to complete our discussions and written report in April and we hope to report our findings to the Area by May.

HISPANIC WOMEN'S WORKSHOP – MARIA LUISA S. AND EMMA M.: We have selected a host committee and have picked December 1 as the workshop date. The event will be held either in San Mateo or San Francisco.

2018 PACIFIC REGIONAL FORUM – DOUG G.: The Forum is 167 days away. We held our third committee meeting and were joined by Ivy Rivera from GSO. More than 200 sign-up forms were received at PRAASA and ACYPAA, and the mass-mailing from GSO should go out soon. Online registration does not start until July 9.

AREA 06 SPANISH FORUM – ENRIQUE M.: We will be hosting a Spanish forum, and the linguistic Districts are sending liaisons. This will be held October 28 from 8 AM to 4 PM, and we are inviting other Areas to participate.

### Housekeeping Motions

The workshop would not give advice, but give information so that groups and Districts can make the best decision based on good information provided by qualified professionals. The workshop could be held in August, immediately following the Area Committee Meeting to allow for maximum participation. The workshop would last a couple of hours, and it would cover options, insurance and tax implications and allow time

for questions. The budget would cover room rental, copies, interpretation, and travel reimbursement for speakers.

Questions: Q: Would the speakers be alcoholics? A: Two of them would be, and one may not be. Q: Could we invite people not involved in General Service? A: Yes.

##### PRESENTATION:

##### Navajo Translation of the Big Book – The 12 Steps

Presentation: The *Big Book* is now published in 71 languages, with another 20 in the works. For many years, there had been efforts to translate the *Big Book* into the Navajo language, which is an oral (not written) language and one of the most widely spoken Native American languages. The challenges of carrying the AA message in reservation areas is great and the dream of many of the people who originally made efforts to translate the *Big Book* was that the Navajo people would be able to find sobriety in their own language. This 20-year translation process is now complete. One of PRAASA's highlights was an audio-recording of the Twelve Steps read in Navajo. A woman of Navajo descent approached the microphone tearfully, reporting that this had touched her heart. "I want to tell my people that I am an alcoholic, and there is a cure for it," she said. "I am so happy to hear the Navajo language because there is hope, not just for me, but for my people."

After this presentation, a recording of the 12 Steps, read in Navajo, was played.

##### DISCUSSION TOPIC:

CNCA Motions Book: How do you use it? How can it be improved?

Discussion: It should be more accessible. It is hard to get copies. // I have used the Motions Book to get information. I wanted to know how CNCA grew from NCCAA. It is a record of our history. I think the index is handy because it lays out topics. I could look and see when the motions were made regarding NCCAA and CNCA. // I have a service sponsor who is very familiar with the Motions Book. There are past records of the discussion we have had. It is an invaluable tool. Using the Motions Book to see what has been discussed before can be a great resource. It would be near impossible to reformat it. // Electronic copies of the Motions Book are available from the Recording Secretary.

If you are an armed service member, please share how the AA message was effectively carried to you within the context of military life. What barriers did you face in receiving the message? If you know any active service members, encourage participation. // We are looking forward to hosting you all the Pre-Conference Assembly. Dinner reservations are still available, and the speaker meeting following dinner is free for everyone. // We will have microphone monitors at the Pre-Conference Assembly. They will remind people to speak slowly and into the microphone, and they will help people adjust the microphones. // I visited District 20 and want to thank them for the welcome. Every person at the meeting came up to me and shook my hand and welcomed me. I want to share that kind of welcome with my District, and perhaps I can welcome people better. // I attended the Inter-District meeting. The warmth and hospitality was astonishing. Thank you. // In May, we will hold a *Comentarios* workshop providing information about this service commitment, at 9AM before the Area Committee meeting. We have had trouble getting people involved in this service work, and we will include members from the I&T committee and people who have been involved in the *Comentarios*. It might inspire you to put in a bid to help with the *Comentarios* next panel. // I invite all women to participate in submitting artwork and logo designs for the Hispanic Women's Workshop. Unleash your inner Picasso before the May 5 deadline. // At the Remote Communities meeting at PRAASA, a newcomer in need of a meeting walked in, and the people there Twelfth-Stepped him. // When listening to interpretation, I hear a lot of static. I do not know whether our equipment needs to be improved, or if other people are having similar problems. // I want to express my gratitude for the support I receive as an Hispanic woman. This workshop has helped us find unity and get to know one another; we are being gifted with unity.

The meeting was closed at 2:55 pm with the Responsibility Statement.
