Chair's Preview

At the last Area Committee Meeting (ACM), we set a new voting record when we approved a series of motions – eight in total – and heard a presentation of new business regarding web conferencing services. We also heard a presentation for an assembly bid in 2020 (that might be presented again next month) and continued discussing a motion to provide interpretation at the officers' meeting. And, finally, we also continued conversations regarding whether Area Assemblies are open or closed and regarding the potential electronic distribution of the *Comments* and *Comentarios*.

Clearly, Panel 69 is engaged in active service. Our next big event comes this September 14, when Districts 10 (Marin) and 18 (Spanish North) host the Summer Assembly in Petaluma. The morning business meeting remains the same – with the same four items of business under discussion (and possible votes on any of the motions). But the afternoon is where the magic happens – when members of our Area present on a variety of workshop topics about issues of importance to AA as a whole, and then the Area gets to talk and share. Past workshop topics have included the modern-day relevance of the *Grapevine* and *La Viña* magazines, how AA helps our most vulnerable members, anonymity in the digital age, whether anonymity is still relevant, how to keep AA safe, carrying the message to alcoholics with special needs, singleness of purpose in a changing world, and the 7th Tradition in the digital age.

These workshop topics are suggested by you – the members of the Area. All workshop topic suggestions are due by July 27, so please email me any suggestions you may have via <u>the web form</u>.

I was told I write too much, and the *Comments* this month are quite hefty. So I just want to thank you for your continued participation, and for enhancing my sobriety.

DELEGATE'S CORNER

Courage, Comfort & Complacency

Conversations about money in A.A. are rarely looked forward to, but when I served as a General Service Representative, I had the realization that it was my responsibility to adequately inform my group of the larger picture.

Over time my perspective and attitude towards money in A.A. has changed. I no longer see it terms of the material vs. the spiritual. For me, it's all spiritual. In and of itself, money is neither negative, nor positive: it's what I do with it that counts. Money is like a river that courses through my life—at times a steady stream, at other times a trickle—and while it courses through me, I have the opportunity to imprint upon it my priorities and values.

One of those opportunities is that hat. Now the hat comes in various guises, sometimes the hat, or basket, is literally a hat or basket at my home group, or another group I might be visiting. Other times, the hat comes as an opportunity to buy a Grapevine Gift Certificate for someone incarcerated or to set up a monthly personal contribution to our General Service Board or my local intergroup. Other times, it can come in the form of the pink can for Hospitals and Institutions. And then, there's the birthday plan when I can make a contribution to mark another year of the gifts of sobriety by sending a contribution to our General Service Board.

I mention these things because, over time, I have lost my fear of talking about money in A.A. Now, in the larger service of us all, it's my responsibility to spread awareness of the myriad ways there are to imbue that stream of money, when it flows through us, with meaning and value.

Step Twelve encourages me to practice these principles in all my affairs. At first annoyingly and now with gratitude, I know this means my *higher power's* money also. I am merely the temporary custodian of the money that flows through me.

So, today I have the courage to talk about money in A.A., in spite of the lure of comfort: surely, I'm giving enough, right? Well, my inventory (as always) reveals that that reasonable, yet insidious, thought is really just complacency in disguise. I need to get into action. It's time to tune up my personal contribution plan to our program of recovery so that it remains here, strong, for the legions of alcoholics yet to take their seats at our meetings.

(District 08). Cynthia D. (District 40) read Tradition 06, Elba S. (District 16) read Concept 06. There were (2) Past Delegates present: David N. (Panel 59) and Joann L. (Panel 67); David N. currently serves as a General Service Trustee. The May 2019 minutes were accepted as printed in the CNCA Comments. The financial report will be reviewed again and reprinted prior to approval. Birthdays: 83 years

OFFICER REPORTS

DELEGATE – TEDDY B.-W.: Thank you District 90 for an amazing Post-Conference Assembly. My inbox (please see the <u>web form</u>) is open to you for questions and requests. I have copies of the presentations made at the Conference if you would like to see them. AAWS and the AAGV are looking for two new non-trustee directors, resumes due on 7/1. I have with me the last hard copy of this year's Remote Communities Communicator.

ALTERNATE DELEGATE – JENNIFER B.: The results of the Agenda Topic Summary Survey is in the process of being translated and we will send that out to all of the DCMCs when it is done. A discussion topic on the Summaries will start in July or August. We having a Joint Committee Communication Meeting on August 24th before the ACM at 11:00am, members from H&I and CNIA 07 will be joining us.

CHAIR – ERIC L.: We have eleven items of business to discuss today. This is the largest number of motions we have had on one agenda since the November 2008 ACM. We have a vacancy on the I&T committee. Anyone interested in serving, please submit your name to any Area Officer by the end of the day. And workshop topics for the Summer Assembly are due by 3:30 PM at the next ACM, on July 27.

TREASURER – LAURA W.: We still have little over \$14,000 in our banking account, in addition to our prudent reserve that is \$11,000. We do have expenses coming up. REGISTRAR – ERICA G.: I'm working on putting together the current roster; something that I haven't been able to do since two ACMs back. I know registrars are looking forward to getting those again. Hopefully I'll have everything functioning properly soon. Assembly Registration was awesome. Attendance was 231 voting, 120 non-voting with the total of 351.

RECORDING SECRETARY – MIGUEL H.: Thank you all for your emails and submitting your written reports. Please make sure you fill the voting/no voting sheet placed at your table – please, don't take it with you. I apologize Karen B. for missing your report from May.

ASSEMBLY COORDINATOR – COREE H.: Thank you District 90 for putting together such a wonderful Assembly. Summer Assembly is happening on September 14th in Petaluma. We will be seeing an assembly bid today from Districts 04/40 for the Election Assembly. I'm excited to see districts making themselves available for the spiritual experience of hosting an assembly.

LITERATURE/GRAPEVINE/LA VIÑA – MAGDALENO O.: We have a copy of the pamphlet AA for the alcoholic with mental health issues for display. There is a new book "Our Great Responsibility" and a new book from grapevine "Take me to your Sponsor". This month's GV special section is "The Annual Prison Issue" featuring experiences from members inside and out of prison walls.

AREA SUB-COMMITTEES AND SHARING SESSIONS

ARCHIVES – DENISE G.: Our next Archives workday will be on July 13th. The position of preservstionist was filled this morning. We had a Third Legacy election to select a member of the committee to attend the National Archives Workshop in Detroit in September. We will be attending unity days in Humbold, San Mateo & Alameda. BRIDGING THE GAP – LARRY B.: The motion to forgo our Annual Forum in 2019 in order to put our efforts in to attending and supporting the BTGWW in Sacramento failed. The committee accepted a bid from Distict 11 to host our 14th Annual CNCA 06 BTG Forum. We also held a Third Legacy election for our primary scholarshop and 2 partial scholarships to attend the BTGWW. This month 9 districts reported 43 presentations and received and responded to 181 requests. We sent 6 request to other Areas including Michigan & New York.

FINANCE – DON L.: We are reviewing the area expenses guidelines for potential updates. The committee budget worksheets are due by July 27th. Our committee has reviewed each of the motions that area on the agenda today. The Area accepts digital contributions with the use of Square. The committee will be meeting in mid July to discuss process

improvements the finance committee.

PI/CPC – JENNIFER B.: I will be making a housekeeping motion to help fund attendance a statewide convention in coordination with another Area. We reviewed parts of the recently revised CPC workbook. We discussed some of the PI and CPC Conference advisory actions and committee considerations. We went over our committee expenditures for this year and our proposed budget for 2020. In July our discussion will focus on outreach and attraction for PI/CPC opportunities.

WEBSITE – DREW B.: Megan was selected to attend the NAATW. Watch the website this month for some new looks and feel, our website is a little text heavy so we are reviewing that text for updating. We are scheduling time with the archives to start the Archives website project.

INTERPRETATION AND TRANSLATION – JAMES B.: We went from 1 missing radio to 11. Thank you Manuel and Juan for providing interpretation. We discussed purchasing an additional 20 radios. The speaker will be in Spanish at the summer assembly dinner so please bring your radio. The committee translated 24 pages of text in the last month.

CNCA STRUCTURE AD HOC COMMITTEE – JUSTIN H.: We are working on out reach to other areas and doing the legal research to find out what type of steps will be needed to incorporate as a non profit, we will inform more next month.

CNCA COMMENTS / COMENTARIOS- KELLY H.: The final mailing this month was Thursday June 20th, after many hours of work from our devoted translator(s). Thanks to everyone on our faithful I &T & Web committees for their help. Seven people came to the Lick & Stick. 125 first class & 1100 bulk copies of this month's Comments & Comentarios were mailed, see your District Registrar if your copy doesn't arrive in the mail by the end of each month.

DCM SHARING SESSION – SARAH B.: We had a presentation on dispelling the myth that General Service is political. We discussed the negative connotations associated with "politics" and the principles of the Traditions and Concepts; we attempt to prevent ego-driven politics from tearing our fellowship apart. The major guiding points included understanding our history, democracy, humility, and our responsibility as representatives of General Service to inform others who may not understand. In July we will have a presentation on Fourth Tradition.

AREA COMMITTEE MEETING MINUTES FOR JUNE 2019 (Cont.)

ACCESSIBILITIES – KRIS W.: We discussed our pending motion to become an Area Sub-Committee, the Area PI/CPC committee is a possible model and we will keep moving forward. In July we will elect our Chair and Recording Secretary and also start discussing guidelines.

LITERATURE/GRAPEVINE/LA VIÑA –MAGDALENO O.: We held a fantastic workshop about how can we make a subscription for the GV or LV online exploring the GV Website. If somebody or some districts are interested in having a GV or LV workshop please let me know.

H&I LIAISON – KAREN B.: The 46th Annual H & I Conference was a success. At our GS Meeting in June we elected a new General Chair and two Finance Committee Members. We sent a representative to the Southern California H&I Conference. The Inmate Visitation/Sponsorship Service has 50 plus volunteers, 31 have been assigned an inmate and matched. We are holding orientation after the Area 53 Alameda H&I.

LA VIÑA 23RD ANNIVERSARY – ABEL M.: The date of the event is July 26, 27 & 28. The committee will have the business meeting Sunday 23rd, we keep visiting groups, we will participate on the convention in the state of Washington holding a writing stories workshop.

HISPANIC WOMEN WORKSHOP – ANA V., SANDRA G.: We been inviting members from several Districts including 07, 70, 17 & 18 to the theme and logo election on June 30th you are all welcome. We are working on the budget and continue receiving contributions from other areas, our next meeting will be at the LV anniversary July 27.

HOUSEKEEPING MOTION(S):

 "That the CNCA Archives committee replace the locks on the two interior doors at the Archives Repository in Walnut Creek, at a cost not to exceed \$100". – presented by the Archives committee

Q: Do you share the space with H&I? A: Yes / Q: how many locks are you planning to replace? A: two locks. No Objections; Motion Passed

 "That CNCA fund one member of the BTG committee to attend the Bridging the Gap Workshop Weekend, September 6-8, 2019, in Sacramento, at a cost not to exceed \$450". – presented by the Bridging the Gap committee Presentation: The BTG workshop weekend is basically CNCA sending a representative and involves other BTG fellowships, we have sent representatives for the last 4 or 5 years.

Q: This and next motion looks pretty similar, the intention is sending three members? A: BTG workshop weekend fell through, and the Sacramento conference came in as a substitute at the last minute. We had \$1000 to send one person originally, but because the conference is so close now, both motions will allow us to send more two more without going over the dollar amount for that was going to cover one person / Q: the cost will depend on the method of transportation? A: the BTG weekend was not going to be held in Sacramento and would have required a flight. Now that it is in Sacramento, we are using the reimbursement miles rate of guidelines for the area, and the \$450 will be an addition to other reimbursable expenses like if the member selected to attend will be traveling from a distance of more than 300 miles round trip. No Objections; Motion Passed

 "That CNCA fund up to two additional members of the BTG committee to attend the Bridging the Gap Workshop Weekend September 6-8, 2019, in Sacramento, at a combined cost not to exceed \$600". – presented by the Bridging the Gap committee

Q: If it cost \$450 for one person, how are we sending two for \$600? A: two of them will partial scholarships since we don't know if both are going to attend the whole event we can always be open to other members to have the opportunity to attend. No Objections; Motion Passed

 "That CNCA fund one member of the Web committee to attend the National AA Technology Workshop, September 20-22, in Bowling Green, Kentucky, at a cost not to exceed \$2100". – presented by the Web committee

Presentation: We have a precedent expending in 2016 with similar amount, and because this is base in logistics the conference is an hours drive from the airport maybe the member has to stay an extra night.

Q: Is this budgeted of the Area: A: yes, this conference has been budgeted for \$1200 on the 2019

budget / Q: Do we have a break down of the budget reflecting expenses? A: Approx. \$650 flight, \$150 car per day with fuel, 3 hotel night \$360, so should be under \$2100. / Q: you are requesting \$900 over of what was budgeted in 2019. A: yes based on the distance of the fly and from the airport. No Objections, Motion Passed

- "That CNCA purchase one (1) microphone stand, at a cost not to exceed \$60". – presented by Coree H., Assembly Coordinator
 Presentation: I broke one of them, for the sake of transparency, that's what happened. No Objections; Motion Passed
- "That CNCA contribute up to \$450 to help defray the cost of an exhibitor booth staffed by CNIA 07 at the California Probation, Parole and Correctional Association's annual training conference August 27-29, 2019 in Lake Tahoe". presented by the PI/CPC committee
 Presentation: It will be staffed by Tom A. and another volunteer from Area 07. The full cost for the exhibitor space at a nonprofit rate is \$900. The finance committee has reviewed the motion and funds are currently available. No Objections; Motion Passed

ASSEMBLY BID(S)

• Election Assembly 2020 – presented by Districts 04 and 40

Presentation: We checked other facilities and this is the only date available, Date was changed from the 14^{th} to the 7^{th} .

Q: includes kitchen trash, etc.? A: yes / Q: can we access the night before to set up? A: yes and we can use the room from 6:00am to11:00pm in case of extra time / Q: Is this whole facility wheel chair accessible? A: no but the majority is and has plenty of seating for wheelchairs / Q: This will be the third time we're having the elections assembly in San Jose and Santa Clara, seems inappropriate to keep having this assembly in only one place, we are not in a rush we can wait to see if other districts would like to make a bid, we are not in a hurry, right? / A: we had one back on 2014 and 2016. / Q:

The \$2,000 for the food- for how many people is the estimate? A: 400 people / Q: District 08 has been working on a bid for an assembly participating with District 20 and we are inviting District 07, can we hold off one month? / Q: The \$5000 showing for rent includes the possible non-profit organization discount? A: Yes the original cost was \$7000. Q: Clarification of the procedure, this means that this bid could be re-submitted next month? A: This never happened before, looked in the motions book. / Q: Are we holding so we can submit two possible bids next month? A: This bid was ready to submit at May ACM and we decided to wait one more month in case other Districts were interested in making a bid. Vote: 20 in favor; 24 opposed; bid not accepted at this time. Note: This bid may be re-presented at the July ACM, if Districts 04 and 40 so choose; other bids may be presented as well.

PRESENTATION OF NEW BUSINESS:

 "That CNCA provide access to a secure web conferencing service allowing for up to two simultaneous sessions at a cost not to exceed \$300 per year". – presented by Richard W.

Presentation: With the legal aspects and using our districts account, we plan to align with the spiritual practice of being self-supporting. This is something the Area can discuss more.

Q: How you came out with \$300? A: 149.80 times 2 is 299.60 / Q: How can you have control and access to this? A: We will discuss this on how to share the information, ultimately will be up to the Area Officers. / Q: Who exactly in the organization will be using this? A: Individual committees make it more accessible to members that a can't get out, will be for area-wide use. / Q: these meetings will be recorded? A: That depends, it could be case by case. / Q: This could help members who live far away? A: Yes, we can take advantage for members that live 5 or 6 hours from here. / Q: This will be two simultaneous? A: This could be available to use in the case of two committees needing to use it simultaneously. Separate it is \$150 per account. / Q: Are you planning to create more specific guidelines? A: we will have to work on this including regulations but we are not there yet. / Q: We can have two users at the same time regardless the number

New Business at the Area Assembly:

MOTION: That CNCA requests that a pamphlet entitled "Experience, Strength and Hope: AA for the Transgender Alcoholic" be produced. – *presented by District 07*

ARGUMENT IN FAVOR OF THE MOTION:

This motion would direct our delegate to write a letter to AA World Services (AAWS) requesting consideration to produce a pamphlet that communicates the experience, strength and hope of transgender (trans) alcoholics. The primary purpose of the Fellowship of Alcoholics Anonymous is to carry the message of recovery to the alcoholic who still suffers. In order to better fulfill that purpose, the Conference has approved numerous pamphlets addressing the needs and barriers to recovery that speak directly to remote communities within our Fellowship: young people, native North Americans, black and African Americans, women, armed service workers, the older alcoholic, and gays and lesbians. But, there is no Conference-approved literature that specifically addresses the needs and barriers to recovery that the transgender alcoholic experiences.

As we heard from a presentation at a recent Area 06 business meeting, those needs and barriers include: confusion within the Fellowship concerning the nature and purpose of hormone replacement therapy for trans people; restricted access to gender-focused meetings; confusion arising from the informal AA tradition in which men sponsor men and women sponsor women; lack of access to genderneutral facilities in AA meetings; the informal tradition of resisting "making big life choices in the first year of one's recovery;" the difficulties of disentangling trans life from alcoholic patterns of action in early sobriety; confusion concerning trans people's identities; gendered language in AA scripts that can be offensive. The current gay and lesbian pamphlet does include stories of people who are transgender. However, a transgender person's sense of personal identity and gender does not correspond with their birth sex: while a day or lesbian person's sense of attraction is to someone of the opposite sex. So, it makes sense that a new pamphlet, rather than a revision to the Gay and Lesbian pamphlet, would better serve this remote community. Further, it is imperative that a pamphlet be considered by the Conference, as our purpose it to accurately and consistently carry the AA message of recovery to everyone who wants it; and we know that this remote community is suffering acutely. Within the trans community, about 30 percent have a problem with substance abuse, compared to 9 percent of the general population. If this motion passes, CNCA Area 06 would be taking an truly impactful step forward to spread the message of recovery among this remote community within our fellowship of alcoholics.

ARGUMENT AGAINST THE MOTION:

While the intent of the motion – requesting a pamphlet for the transgender alcoholic – comes from a good place, the motion, as presented at the Pre-Conference Assembly of CNCA in April 2019 seems to be in conflict with some of our AA traditions.

Tradition 10 immediately comes to mind. "Alcoholics Anonymous has no opinion on outside issues; hence the AA name ought never be drawn into public controversy."

Not only does "confusion within the fellowship concerning hormonal replacement therapy" fall squarely in the realm of "outside issues," the creation of a transgender pamphlet could give the impression that AA has an opinion on what is unfortunately a very politicized issue. Society has yet to resolve some of the confusion about gender, and AA should not take a lead ahead of society. Possibly subjecting AA to a cauldron of debate surrounding politics, medicine and religion seems misguided and dangerous.

The proposed pamphlet could be in direct conflict with Tradition 4, concerning group autonomy. Some groups may only want cisgender men or cisgender women to participate – and this pamphlet could signal that what they are doing is "right" or "wrong" for AA. Every group is free to make any decision it wants, and our pamphlets should not tell them they are "wrong." Tradition 3 states that "the only requirement for membership is a desire to stop drinking." And our Responsibly Statement reminds us that "when anyone anywhere reaches out for help, I want the hand of AA to always be there and for that I am responsible." This ensures that any alcoholic, in need of a meeting, should be welcome at any meeting of Alcoholics Anonymous. Group anonymity states that the final voice in who is welcome to what meeting is dictated not by AA but by the group conscience. In 2018, the pamphlet once geared primarily toward gay men and lesbians was renamed and updated to include stories of transgender AA members. There is currently representation in our literature for the transgender community. It seems too soon to be requesting new literature and to ask groups to shoulder the cost of new literature – when we could simply update the new pamphlet. Finally, same-gender sponsorship is not an AA tradition, but rather a suggestion made by members and is not printed anywhere in our basic text. Our Big Book reminds us that "we want to stay out of this controversy. We do not want to be the arbiter of anyone's sex conduct." Nor do we want AA to make decisions on stillpoliticized issues. Again, the intent of the motion is kind and welcoming. But Bill often reminds us that the good is often the enemy of the best.

Presentation: Dispelling myth that General Service is political by Barbara from District 04. Political is a multifaceted word with multiple meanings that run the connotative gamut from good to bad. Connotations produce and support myths hence we ought to question and clarify how we use each word in our communication. Rejection of General Service is often due to lack of knowledge. The traditions guide the principals through which we operate. Our Great Responsibility is a valuable resource. We are not born leaders, we become leaders through continuous learning and sharing. Our leaders are fallible, not superior and practice communication of the heart. Certain gualities and experiences make us more useful, not more important. Principles that fortify us: 1) petition: an ancient device to protect minorities; 2) appeal: protection against the tyranny of the majority; 3) participation: delegates, trustees, directors are voting equals at the conference level; at the headquarter level members' authority is commensurate with their actual duties and responsibilities: and 4) the definite power of decision. Since we live in a society, our decision-making is democratic in its structure. Our uncompromising honesty may clean up politics. The usual election troubles were often caused by personal nominations, whether from the floor or from some committee in the back room. Another cause of trouble was in close elections. These always left a large and discontented minority. A.A. is a counterpoint to the current politics.

Members Share: Chair asked volunteers to share, each person had 90 seconds to share on the topic. Highlights: Many people shared that they perceived General Service as political until they got involved and participated in General Service; local business meetings are often much more political than meetings in General Service.// Politics are about biases, power, and trying to get others to see our way. Understanding our history, listening to new people, and trying to respect one another helps protect A.A. from negative effects of politics.// The difference between politics and democracy is in the outcome or goal; ours is love and service.// The importance that everyone votes to ensure the democratic nature of A.A.// People have different perceptions of what "political" means, which influences their perceptions of the extent that General Service is political.// Practicing the principals (Traditions and Concepts) protects us from getting involved in politics and protects us from ourselves; especially keeping my mouth shut and keeping it simple.// Hearing the A.A.
