Chair's Preview

As I write this at the end of August, I have been reflecting on the spiritual change I have experienced as a result of AA. I was once terrified of an honest self-reflection. I had no principles upon which to stand, and I did not know how to communicate clearly, fairly, and directly with the people that I loved. I have changed a lot in my nearly 10 years of sobriety. And I am so profoundly grateful.

By the time this is mailed out, we will have held an election for the position of Area Treasurer. This has been a challenging time for the Area, and I am grateful for the opportunity to participate in our Area Inventory this coming November. I have often found great relief when I am disturbed or hurting in a fearless and searching inventory, because with transparency and honesty comes freedom and joy.

As an Area, we have started to take steps toward that freedom, starting with a sometimes difficult discussion that we had during the afternoon business meeting of the August Area Committee Meeting. Much of that decision centered on the reasons the election was called for by seven of the Area Officers (after months of deliberation, prayer, and meditation), as well as information from our Treasurer and several other trusted servants.

These discussions – about finances, health, trust, and responsibility – can sometimes be very difficult. In AA, much like in life, we do not necessarily get to choose what we discuss – but we do get to choose how we discuss it. We get to choose to be honest. We get to choose to be loving and compassionate. And we get to trust the process. While the conversation at the Area Committee Meeting was sometimes difficult, it reflected the principles of AA and was a true test of character for us all.

Now we move on, hopefully in unity, and hopefully trusting that nothing, absolutely nothing, happens in God's world by mistake. Our next opportunity to meet all together will be at the Fall Inventory Assembly in San Francisco on November 2, where we will get to have more sharing and more soul-searching. Suggested inventory questions are due by September 28.

We will also get to keep talking about the numerous motions at our assemblies, including the request for a pamphlet for transgender alcoholics and our newest motion – requesting the production of a one-page summary of the warranties (which can be found in Concept 12). This was originally presented at the August ACM, where we also unanimously approved a request from a local AA member to write a letter of support for her bid to present a play about remote communities at the International Convention of Alcoholics Anonymous in Detroit.

This next month, we might hear more bids for assemblies in 2020 (three assemblies remain open for bidding). We will also keep discussing whether to purchase web-conferencing accounts for the Area, how to reach out to African American alcoholics, and the Agenda Topic Summaries (and their purpose, use, and future). We might also hear a final report from the ad hoc committee exploring our Area's structure (as an unincorporated association) and whether the committee has any suggestions for us in the future.

"During the production of that [big] book, I saw human nature at its most sublime, and I also saw it at its worst and most sordid. [...] We had quarrels about money; we had quarrels about prestige; we had the bitterest quarrels over the most magnificent passages in that book. [...] If we hadn't had any trouble, we wouldn't have gotten any book. So, it takes the absolute and the relative, the divine and even the sordid, to make this very important product: progress."

I have faith in our higher powers to show us the way.

The AA Preamble was read by Merine (District 07), Jeff D. (District 11) read Tradition 08. Russ A. (District 03) read Concept 08. There were (9) New GSRs, (7) past Delegates present: Diane O. (Panel 35), Bob D. (Panel 36, Area 28), Woody R. (Panel 50, Area 07) Doug G. (Panel 53), David N. (Panel 59), Ken M. (Panel 61), and Vicki R. (Panel 66, Area 07), David N. currently serves as a General Service Trustee. The July 2019 minutes and financial report were accepted as printed in the CNCA Comments: with a correction regarding the date of the previous ACM. Birthdays: 236 years. Registered attendance: Voting (53) / Non-voting (54)

OFFICER REPORTS

DELEGATE - Teddy B.-W.: First, thank you to all the districts I have visited to present my report on the 69th General Service Conference. Registration for the 2020 International Convention in Detroit. opens 7am on September 9. The installation of the new Enterprise Resource Planning software (ERP) has now occurred, if you were a monthly contributor to GSB you will need to sign up again. Pacific Region Trustee, Kathi F. and the General Service Board took place at the end of July, our Area motion that AA produce literature on meditation is now pending with the Trustees' Literature Committee. Also, Michelle Greenberg, our General Service Board Chair, the Trustees' Literature Committee and the Trustees will review a request for a plain language translation of the first 164 pages of the Big Book. If you have a conference theme suggestion for 2021, I am accepting suggestions until December 10th. The pamphlet 'A.A. for the Older Alcoholic' is being updated. ALTERNATE DELEGATE – Jennifer B.: GSO is looking for up to 21 non-A.A. speakers to invite to Detroit in 2020, at A.A.'s expense. These panel demonstrating Cooperation with the Professional Community work for A.A. members in attendance. The hope is that you might suggest professionals who could also be considered as possible future Class A Trustees. Julio at GSO is requesting that names be submitted by Wednesday, September 25.

CHAIR – Eric L.: We will hold an election for the position of Area Treasurer at the Summer Assembly. Calling for this election was a difficult decision made by seven Area Officers as a last resort after considerable and careful deliberation over the course of the past several months, and was made because of numerous concerns regarding contributions, payments, and reimbursements.

TREASURER – Laura W.: I met with the Finance committee earlier today and reviewed our finances.

REGISTRAR – Erica G.: As I've been reporting I'm dealing with technological issues. This month I'll start giving sign-in sheets to the Districts. I could be wrong but we can try to fix them soon as possible. I received an email from GSO and the packages are going to take little be longer due to a new system. I have the link to get all this material directly from aa.org website.

RECORDING SECRETARY – Miguel H.: Thank you all for providing me with email and hard copies of your reports. Please don't take the sign-in sheet at the table. Those help us to figure numbers on the voting vs non-voting members at our monthly ACM. Thank you Chelsea W. for helping with the editing of the minutes.

ASSEMBLY COORDINATOR – Coree H.: I know that there are a few assemblies open for bidding for 2020 and I have been helping a few districts put together bids. Currently, the open assemblies are the preconference, post-conference, and election assemblies. We will hear a bid today for the Summer Assembly in 2020, so please be nice to them.

LITERATURE/*GRAPEVINE/LA VIÑA* – Magdaleno O.: The revisions of the Big Book, "Twelve and Twelve" and Living Sober are already finished / approved. The audiobook archives in French are in the editorial review phase. Twelve Concepts for World Service audio project, the English, Spanish and French versions are approved and are in the post-production phase for publication at aa.org. Youth Videos (DV-10) is now titled "Young and Sober in AA" and should be in stores in 4-6 weeks. New GV / LV "Mini catalog" is available. This month's special section is on Young and Sober.

DISTRICT REPORTS

We purchased an additional 20 radios and want to thank you for your support in making that happen. The committee translated 14 pages of text in the last month and in process of translating an additional 21.

CNCA COMMENTS / COMENTARIOS- Kelly H.: Ten faithful volunteers spent three hours stuffing and stamping so first-class plus 1103 bulk-mailed copies of the Comments and Comentarios were sent out by August 13, and posted on the CNCA website August 16. We will have stamps, labels and envelopes at the Summer Assembly, so come by our district tables if you want to participate & help. Next Lick & Stick is 9/7, noon—4 at Park St. Center, 1510 Oak St., Alameda.

DCM SHARING SESSION – Sarah B.: The DCM Sharing Session held a group inventory in which we discussed what the basic purpose of the sharing session was and how it relates to the primary purpose, our sharing session is democratic and how we could make it more so, and how we can bring more fresh and innovative topics to our sharing session which allows DCMs to better support and provide ideas and information to GSRs and/or groups to better carry the message. Suggestions and ideas on how to be more democratic included an anonymous means of selecting topics and how to have greater diversity in those who attend.

Accessibilities – Allen W.: Our conversation continues about outreach to the senior residential care community. We reviewed "Accessibility Inventory" document created by District 12, 14 and SF/Marin Intercounty fellowship. We decided to request a table at the summer assembly to distribute this and related resources. We have scheduled a guest speaker at the September Sharing session to discuss how they offer daycare at AA meetings. At the October Sharing session a representative of the SF Sunshine club will present on how their committee works.

LITERATURE/*GRAPEVINE/LA VIÑA* –Magdaleno O.: We had good reports from some people who attended the 23rd Anniversary of La Viña, held in Fresno CA. We also had some positive comments from some previous members that served on this Committee. We have a flashlight motion and we will start discussing it the following month.

H&I LIAISON – Karen B.: We had a great Joint committee meeting. Our General Service Meeting is October 13th in Contra Costa County. I do not have the address information yet. General Committee Meeting attendance is open to all alcoholics. Thank you for your contributions to H&I.

LA VIÑA 23RD ANNIVERSARY – Abel M.: We attended the 23^{rd} anniversary; it was a great success with the final number of 1263 subscriptions and 120 subscriptions sent to the Jail in Soledad. We will be electing a new liaison at the September ACM to be the liaison for the 24^{th} Anniversary that's going to be hosted by Area 04 Arizona.

MUEJRES WORKSHOP – Ana V., Sandra G.: July 27 we had a meeting with other liaisons and we voted and elected one from the 25 drawings presented from Area 06, we are still waiting for the final format to start printing and distributing. We have a date for the 4th workshop, December 7th. The budget for the event is \$4,200 including \$540 contributed by Area 06.

HOUSEKEEPING MOTIONS:

 That CNCA write a letter of support for a group of volunteer A.A. members in our Area to perform a play about the AA Grapevine and Remote Communities during the 2020 International Conference in Detroit, MI. – presented by Jackie B.

Presentation: This is a play based on Grapevine stories written by AA members. It will be called "People like me" and the theme will be for AA members in remote communities. At this coming International Conference, there is a new protocol that requires a letter of support. This will be one step and will be transparent, we can't be sure that all the infor-

mation will be approved information, not just entertainment. Questions: Q: can you tell us little of the bidding process A: This is about the Grapevine; it can help people with language barriers; The Area will have the last word. Q: you said other plays are being submitted as you are trying to do it? A: yes New Jersey and other areas are doing it. Q: How can we voted on something we haven't seeing? A: we haven't performed this play yet, YPAAs also have done a submission before, this letter is more about the support, rather to promote the play - it is up to the area to vote and support the intention. Q: Does this play look similar to "I am responsible" I mean on the quality? A: This will have more text from The Grapevine using speaker tapes and other materials; will be based on the history of the meeting on print. Q: I want to know if this is going to be part of the Conference like the one in Atlanta? A: Yes. Q: You guys have a time line when this letter needs to be submitted? A: This is a time sensitive matter; other Areas have submitted theirs; we have approximately until December. Q: Is there a way to show some part of the play before we voted? A: I will be holding the practice in SF, everyone is welcome to participate. Q: If the areas provide the letter who will pay? A: Volunteers will be part of this, like in the past, it will be a service to the community. Q: All actors are AA members? A: Yes. Q: Are you compensating those members? A: No. Q: Are you working by your self? A: It is a good idea to open to other members at the area; it wasn't so specific in other years to submit a request; it is a whole new process now and yes I am doing this part. Q: This will be a tradition 9th a service from you to AA? A: We are trying to carry the message within the AA fellowship; not promoting beyond those who are already AA members; we're providing another way to carry the message and access the message; in the sense that we are helping members engage with the history of AA and getting members to identify with other members' stories, and get inspired and more educated. Q : Are you planning to submit this regardless of whether or not we give the letter of support? A: Yes, it was suggested to me by GSO to do so.

An objection was made to the Housekeeping Motion; the motion was moved to old business due to the time-sensitivity of the request.

Discussion: GV is not conference approved/ I have seen every play, my issue is are we using the area to support or promote an individual's work? I feel like there is a problem of traditions here, promoting vs attraction I would like to take this to my group / I have been a participant and I can say that this is not about promotion, this is about attraction within the fellowship, there's a way to bring to this production to the members of AA who choose to come and see it, members who do see plays have moved and touched; this has been the highlight of my sobriety this is more than a spiritual question, this is based in research all about GS, this is a way to be of service, we are over thinking it; it is just letter / for me is difficult question, there is problem with tradition promotion vs attraction or are we supporting Jackie as an individual? / this has been happening all ready, as a group or member, other areas have already given support to people from their areas, this is because of the new protocol that a letter of support is needed/ our area is not just one person, we're lucky someone wants to give our area the option, the possibility, I would like to see this happen / there actual is precedent for this, we were in support of it before, when we hosted the 2016 archival workshop, everything was amazing, she has the experience we should support it.

Vote: Unanimous vote in favor; 0 opposed; five abstentions. Motion passed.

ASSEMBLY BIDS:

Presentation: Has a full kitchen, has break-out rooms, and accommodating tables with enough chairs. Questions: Q: is this an accessible place? A: yes we checked including bathrooms – which are in the same facility - and wheelchair parking (4 spaces). Q: That is what you saw from the walkthrough? A: yes looks really good from the walk; formality and comfortable. Other events have been held there for 300-500 people. Q: is the parking adequate for 400 people? A: Yes, has good space. We have about 197 spaces available Q: Has anyone had a walkthrough ? A: Yes we have had an area officer, we held unity day, people have been there. Brakeup rooms are available too, the number of people

TREASURER ELECTION DISCUSSION

Talking about warranties, after we heard discussion today this is something that can't skate on concept 10, she's always there and willing to serve / Decisions are being made by the area officers and they can decide to put the position up to election with a protocol: the officers have done research on precedents on our Area but can they do this without the ACM participating or knowing? / Q: If panel 67-69 officers are eligible, what happens if we have a current officer make themselves available? how we will cover this position? A: We asked and other officers are not making themselves available, but Laura is eligible. / It feels like we are making a decision with out having enough information available, I feel uninformed about what's going on and feel like that can bring on gossiping; I hope that we can have more support in our commitments. Q: Is there any possibility we can have in writing what was just read by our area chair? // To have significant information, I remember an officer that died during her commitment and I didn't even know she was that sick based on her performance, it didn't seem like her illness influenced her ability to serve at all; I'd like to hear from the finance chair, then we might be better able to inform our GSRs and I have faith on the decision that we all be making. / Issues like this arise when people are having difficulties and could be difficult to decided because, we love one another and we are trying to support each other, but there is a hard ship when work is not being done, emails not been replied, lots of things that interfere with my task to do a good job has a DCMC, I have to put my faith in the officers who came to this decision because they are closer to the information / we can't vote on personality or it will become a personality contest / How can we make this fair? I heard about the situation, I'm making conclusions, I'd like to see her have the opportunity to speak and be fair/ Q: she was present at the officers meeting? Chair: Yes she has been involved with the decision; we started this conversation back in March and we have been having conversations every single month since; then about this issue she wasn't at the officer's meeting when we made the final decision so we got everyone on the phone and had a meeting giving our treasure the right of participation on August 17th in Concord for two and a half hours for this specific reason. / Treasurer: I take full responsibility, I did not anticipate not being able to serve when I made my self available, all the challenges that are sometimes hard to share in public, during my learning phase was hard to have the ability to perform, I was to consider in an informal conversation but I was asked to resign and the decision made by the officers was one day after my diagnosis, and they didn't have the all information, I want to make clear they didn't make this decision with all the knowledge they have now, and the email went out, but I am responsible for not informing them, don't blame them for that. I also take full responsibility for all the delays, I would like to keep my position because I am truly available now that I'm getting appropriate treatment. I spoke to my sponsor I want to make amends to all the treasurers, at the special meeting I had the opportunity to listen to all the Area Officers and they had the opportunity to listen to me. I want to take the time to answer questions. / Q: For the officers, instead of just opening up and having an election, can we hear full transparency at the assembly, have a vote of confidence, then hold the election? This is a program of principles and amends are one of our principles. We should give her the chance./ Chair: At that special meeting Laura asked the officers what she can do to make it right, to make the amends, and she was asked to resign, and she declined; about the vote of confidence, she is available to make herself available at the election, and since we didn't know what to do, we are going to let the fellowship decide; this is what happened at CNIA four panels ago / thank you our officers for having courage conversations. / It was

tough to see the email and I had so many questions and I can't give good information at my district, they are the ones who are going to elect the new treasurer, Laura has my vote of confidence since she's willing to serve / Q: this is question directly to treasurer, as someone working on the interpretation and translations committee, there are many payments still past-due, this has also been impacting me in my own personal commitment, are those members going to get paid on time? Laura W.: I been sick for long time, I should have asked for help earlier, everything has been difficult but I want to say that the interpreters and translators have all been paid, we planning to have a shared email were we can have access with the finances chair so this doesn't happen again / Q: I been hearing that all finances are current and have been caught up, I don't know how tell that is the case, there is no current finance report that is accurate, also, people mentioning emails haven't been replied, how I can trust is going to be different? We heard from the finance chair during the finance report saying if you need anything then referencing members from the committee, not the treasurer, there's not clarity, I want all to get better but I can't go for another month like this, without answers./ Laura W.: I been having a lots of support from the finance committee, that's part of the job to help, is hard to do everything by myself and Chelsea can help with checks etc. to be more efficient / I still have confusion about Laura's availability, some members have issues when trusted servants are young and people think they are not taking their job seriously; so we might want to ask ourselves if we would be doing the same if an older trusted servant were taken ill. / Q: I believe we have just bypassed third legacy procedure by giving special time to this candidate because she is in the position currently, the bottom line is that the job wasn't done right, we have 7 trusted servants who are our officers and they are trying to serve us best, they sure didn't decide this lightly, but now that they decided, let's move on we have good candidates / I believe this discussion is punitive, lets have an election and let the Area decide / As a member of the finance committee, indeed I help to prepare things to sign, I have to admit that we have are not all paid up for our translators - there are many invoices still to go; I don't want the translators in the room to think I am lying to you, I know you are still yet to be paid/ we have to take the motions to the side, and decide for what's the best thing for the Area. / as a member of the General Service Board I am legally responsible that if we see ineffective manager we are responsible to do something about it, if our general manager is not taking action, is ineffective or incapable, we have to ask them to leave, and we have to find another one capable, this is our legal responsibility, the Area is not a corporation, but the Area officers are carrying on the responsibility, since we understand there have been significant incidents with our funds not being managed, and as unfair as it may seems, the Officers have called for an Election this is the Areas decision. if the area feels the treasurer should stay the Area will elect that member / Q: I'd like to hear from our treasurer if she is available to performance her position / Laura W .: Yes / in the spirit of transparency, I have personal experience of lack of communication with multiple emails that took weeks without being responded to, I had to communicate with other officers to be able to have answers, with our interpreters not been paid for over 60 days, I think they do a fantastic job and they been treated poorly, I trust our trusteed servants, don't take decisions lightly, we got to the point to almost lost our summer assembly that we worked very hard, we shouldn't be doing that, is inappropriate.

Right of participation is also the right of doing it right and I have had to step down from my position, I can always come back and make it right / general service is right if you get to work with new people / preassembly dinners still available / sobers and free will take please on May 2020 in San Jose / District 18, 26th anniversary on September 21st, and thank you all the officers for the clarification on the finance / don't forget to return radios and welcome to bring your own at next Area meeting / we should use this financial experience for our Inventory, our treasure has my vote / greetings from Japan so glad to be here please visit AA45.org for the 45th anniversary in Japan in March 2020. 3:30 P.M. -CLOSING

10am - Sharing Session Opened with Serenity Prayer by Coree H. Chair. DCMs, visitors, and GSRs attended. Our meeting is open to everyone to learn and participation on the topics. Please bring radios. Translation by Juan. Thank you for your service!

Announcements: Marianne announced availability of radios, please return them at the end. Recording secretary announced providing your email to be included on the email list.

DCM Sharing Session Inventory: Chair explained purpose of a group inventory and possible formats; suggested roundtable discussion; group decided on 60 second timer.

Inventory Questions:

What is the basic purpose of the sharing session and how does it relate to the primary purpose of carrying the message to the alcoholic who still suffers?

Involvement in General Service is to better meet the needs of the alcoholic who suffers, and the purpose of the sharing session is to learn from each other how to better fulfill our roles as DCMs to that end. It helps us to improve in relating to our groups, supporting our GSRs, spreading positive feedback and a message of hope and enthusiasm, sharing information, and explaining how General Service and the program of recovery work. S31 of the Service Manual is helpful. This sharing session teaches us how to get people and groups involved to better understand what our fellowship actually wants and what's going on in the larger world of A.A. It bring to life being of service, gets us involved, which helps to get others involved. "It's the most fun and informative of any meeting in the area."

Does our sharing session feel democratic? If not, how could it be more democratic?

The group unanimously agreed that our session is democratic based on the idea that everybody's voice counts and has an opportunity to be heard. Members shared about how they have learned about how to be inclusive through participation in the sharing session. Members feel safe to share, and the traditions are followed. Members credited the roundtable format, voting for presentation topics, and use of a timer as facilitating that. A member mentioned it's very democratic, however it's also very white; they would like to see/hear more in our meeting that represents a more diverse group. A member shared it's up to us to enthuse others from different backgrounds to participate by going to where they are. A member shared that being democratic means everyone has an even vote; that allowing non DCMs to vote can stack the deck. A member shared concern about selecting topics, noting it can be intimidating to bring up a topic in the group, and suggested perhaps submit topics to the recording secretary anonymously. A member shared that we can email, text, or slip a note to chair.

How can we bring more fresh and innovative topics to our sharing session?

Members suggested: 1) Don't be afraid of suggesting topics, especially new DCMs. 2) Submit topics anonymously. 3) Ask your groups what they would like for a topic. 4) Breaking up into groups of 5 or so; having a representative from each group share about discussion, bringing more ideas together and encouraging more collaboration. 5) Go to other committees and ask them if there is anything they are struggling with and if they want us to bring them to the DCM sharing session. - another member liked this idea, and also suggested discussing motions from the Area 6) Invite some controversy; get ideas from the quiet conversations that happen outside the meeting. 7) Bring problems from our group to this session to discuss and bring experience to help the groups. A member was in favor of expanding our topics, but noted that certain topics very generic to the sharing session (*i.e.*, what is valuable from one panel to the next) are helpful for those coming in and out of the meeting.

Chair suggested when you run an inventory to ask the questions and shut up. The recording secretary reported back to the group on the general themes that came out through discussion.

Next Month's Topic: (decided in July): Reaching out to remote communities— presentation by Beth S. from District 06.

Meeting adjourned at 10:55 AM with the Responsibility Statement.
