PREVIEW OF THE AREA COMMITTEE MEETING June 2012

At the May 26 Area Committee Meeting ("ACM"), we passed a housekeeping motion ("HKM") to continue funding an Area BTG Chair representative for travel to the H&I General Committee Meetings, though the reference to H&I Steering Committee Meetings was not included. The latter was included in the latest motion that addressed this issue in 2004. This intention of this current HKM is to align the motions books to reflect CNCA's current practice, rather than to change policy.

The Interpretation and Translation ("I&T") Committee presented their revised I&T guidelines for approval. Since there was an objection this will be new business in June.

We finished discussing the report addressing electronic distribution of the *CNCA Comments*. The report will automatically be added to the motions book. The Web Committee informed the ACM that they will post "anonymized" *CNCA Comments*. After consulting with the ACM later in the day, they confirmed that the newsletter will be posted in its entirety as a PDF, which the report suggests. Implementing other portions of the committee's recommendations besides those regarding the website requires motions because the other recommendations differ from the relevant motions already approved. Future motions could request implementing all the recommendations in their entirety, only some of the recommendations, or perhaps all recommendations with the exceptions of others. Anyone considering a motion should contact me ASAP. Please join me in thanking the ad-hoc committee for researching the issues and compiling the report.

We discussed two items of new business. This first one requests reimbursing the PI/CPC Chair for travel expenses to PI/CPC exhibit events. The phrase "when possible, a HKM will be provided" was deleted from it via requests for and acceptance of an amendment. One might suggest that the amendment was "organic" as it were. I suppose you had to be there to appreciate it fully. The second motion is Marin's re-sub-districting request.

The motion about the Preamble as printed on the Post-Conference Assembly's agenda had typos. Please refer to the correct wording in the *CNCA Comments* and on the website.

The deadline for submitting ideas for Summer Assembly workshop topics is the June 23 ACM. Please submit suggestions to any Area Officer.

We must get a bid for the 2013 Pre-Conference Assembly soon. Interested districts should contact Agustin.

The 62nd General Service Conference is in the rear view mirror, as is the Delegate's Conference Report as delivered at the Post Conference Assembly. Of course all the Advisory Actions, Additional Committee Considerations and non actions are available from you local DCM or DCMC. For me it's always been the story behind those actions that is most interesting. I hope everyone takes the opportunity to attend their local version of the Conference report, be it at the regular District meeting or at a Special Event such as the Unity Days scheduled in many Districts in the upcoming months. These reports are an excellent opportunity to invite the AA member who may not currently be involved with General Service to "have a listen" to what's going on in AA as a whole. As everyone who has heard the report on this year's Conference already knows; items of financial consideration were at the forefront of many of the decisions made at the Conference. There was a committee recommendation to spend \$75K to update the "It Sure Beats Sitting in a Cell" video that failed because the cost seemed prohibitive at this time. There was another recommendation to remove a line of dialog from the "Hope" video that failed for similar reasons; the \$9K cost could not be justified. The Conference Finance Committee proposed recommendations that could enhance revenue and also embrace financial prudence. While these recommendations were not supported by the Conference I believe they have started a much needed dialog within the General Service Board and within the Fellowship they serve.

For the reasons stated above I was quite excited to learn that the Area Committee voted to include a Finance Section to the CNCA06.org website. This newly added area on the website provides tools to better inform the fellowship about the importance of being Self Supporting through contributions. I hope everyone takes the time to look at the "Self Support Challenge 2012" and share with their fellow members. The real challenge still being; how do we get this vital information to the 57% of AA Groups that are missing out on the spiritual connection that comes with contributing?

Please remember we have a very special event happening within our Area next month. The Spanish Speaking Linguistic District's, with help from several English speaking Districts, will be hosting a Local Forum in Daly City on July 7th and 8th (see CNCA 06.org website for flyer). The purpose of Local Forums is to bring Forum information to A.A. members in remote, sparsely populated areas, urban neighborhoods or underserved A.A. communities. The Forum will be an excellent opportunity to get better informed while sharing with GSO staff member Eva S. and Regional Trustee Rod B. and a host of other past and present General Service Trusted Servants. AREA ASSEMBLY BUSINESS

PRESENTATION OF NEW BUSINESS: MOTION:

"That Area Officer travel to each district be limited to twice per year, unless otherwise requested by the district." (Presented by District 07, Alameda North)

QUESTIONS: To open officer participation to more members, to ease the area with reduced expense of area officer travel, foster autonomy and leadership among the districts especially regarding officer visits. Q. was the consideration about the process of the district to request a visit? A. No Q. Who is going to be paying for the Officer for visits over the period of a year? A. We are still going to pay. Q. If I was an area officer could I go to a district mtg. A. Yes Q. This won't be able to vote on this until Preconference assembly. A. Yes Q. Call on the guestion according to Roberts rules of order and why are we going to move this to old business A. We want every one to voice their opinion. Q. Why can't we "call the question"? A. We would like everyone to have a voice in this, and calling the question would not allow everyone to hear about this motion. Calling the question would not work here. Q. Does this include Delegates visit. If it does then that limits us to the number of visits. Q. If this limits Officer Visits to twice a year. A. No, it should not include giving the delegate

report only district meetings. A. An area officer is required to attend district meeting each month, if the funds are not there then we cancel for the entire month. Q. what is the requirement now. A. Every district meeting has an area officer as funds allow every month if the funds are not there then we cancel for that month. We have not had to suspend any officer this year, we did last year, Q. 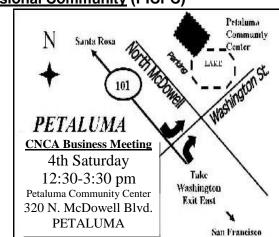
