PREVIEW OF THE AREA COMMITTEE MEETING

March 2013

Hello, new and continuing trusted servants. Welcome again to Panel 63.

During February's ACM we passed one of the housekeeping motions that we had: That CNCA allow and fund the H&I liaison \$114.40 to attend the H&I General Conference scheduled for April 5, 6, and 7 in Foster City (presented by CNCA BTG Committee). There was an objection for the other housekeeping motion: That CNCA purchase a ¼ watt transmitter for use at Assemblies and the ACM. It will be new business for our March ACM, please make sure to share this with your groups during the month. We also decided to rescind the motion passed to receive the CNCA Comments via email. District 01 presented a Bid to host the 2014 Pre Conference assembly at the Monterey Fairgrounds and the bid was unanimously accepted. District 40 will present a bid for the 2014 Election Assembly next month.

We would like to thank everyone who participated on the English/Spanish Agenda Topic Summaries translation team. They were finished in record time! If you haven't received a copy, please ask your DCM or DCMC, as they are an important resource for our groups to participate in the Pre-Conference process. In the summaries, you will find information about the topics that require a group conscience and those that will not be heard at the assembly.

This year we will be meeting in Antioch on the 6th & 7th of April and our theme is "The General Service Conference Takes Its Inventory – Our Solution In Action." After orientation, there will be a business meeting. There are two items of business scheduled on the agenda; one is a presentation of new business, the other is old business. During the assembly, please remember the microphone etiquette: avoid long introductions – representatives should aim for around 2 minutes. This year we will continue the process of peer encouragement for timing shares; a red-light timer will begin the applause. *Remember to bring your FM Radios!*

In closing, I would like to share part of Concept 3 from the Service Manual that comes to mind when I think about this process that we are participating in: "Our entire AA program rests squarely upon the principle of mutual trust. We trust God, we trust AA, and we trust each other." (S14)

As I write to you this month, I sit amongst 1000 A.A. service friends from the Pacific Region of the U.S. and Western Canada, here in Boise, Idaho. There are newcomers with 62 days, long timers with 45 years, and many attendees are here for the first time. The diversity of the folks in this room is so amazing. We are certainly a group that "normally would not mix" but we have one language in common "The Language of the Heart!"

We have been sharing together for 3 days in workshop sessions, panels, and a two part, 3 and a half hour business meeting! There are GSRs, DCMCs DCM's, Past Delegates, Delegates, GS Trustees, members from the Grapevine, La Vina, and other service committees. Folks from 15 different General Service areas, including visitors from Japan and Canada were represented here this weekend. It was like a Mini International.

Love and laughter filled the rooms and halls. The late night workshops brought together members that serve on similar committees or jobs. They shared on what works, what hasn't and what's new in their districts. The air was full of electricity; except during the business meeting where we had many power failures. Even during the most enormous business meeting ever (700 plus folks) the chaos didn't dampen our spirits. There was a sense of levity and learning during the loving debate and decisions. Some members even called it the late night entertainment.

I felt loved and supported all weekend, as I put into practice what you have taught me. My greatest was joy watching so many new members, (here at their first PRAASA) change right before my eyes! I have learned more through our discussions, about the inventory questions and the agenda topics. The open mic brought forth many terrific questions, suggestions, and comments, with expressions of love, gratitude and hope for our future. I will share much more about "this PRAASA" later.

Now to the topic of the sharing at Pre Conference Assembly in Antioch on April 6 & 7th, are we there yet?! If you are finding it difficult to prioritize or select what to share at the mic, you are not alone. I remember standing in line to give my groups conscience many times. Being a GSR and a bit shy I was never first. Often by the time I got to the mic one of 2 things happened: 1) everything was already shared that was on my 5x7 card, or 2) the delegate had gotten a good sense of how the groups were feeling, and suggested we take the opportunity to move on to the next item. It was in that moment that I realized as AA members are not so different; our groups are not so different either.

The main focus for all of us is to do the work to ensure A.A.'s message of hope is shared in a "Loving Spirit" and with AA's worldwide future in mind.

I am so excited about hearing the different ideas and concerns your groups have. I will do my best to assemble the information and bring it all into my heart before the General Service Conference begins.

DCM SHARING SESSION February 23, 2013

Phill B opened the meeting at 10:00 with the serenity prayer.

Ginger O – District 15 gave a presentation on "How do I introduce myself to the sub district and how to approach groups without GSR's.

Ginger's presentation started with the two different introductions that we can use. The formal and informal. When speaking to a group, be sure if the GSR is there to put the spotlight on them, and present yourself as a support to the GSR and the group. Always include the GSR when you are advising a group of your service. When problems in the group come up be sure to tell the group, "It is our experience......"

Be sure when speaking to any group to state that there is a business side of AA. You are the communication link, and not a person of authority. When making a report at a district meeting for your sub district be sure to have a written report to give to the recording secretary.

Always say something at every group you attend about District or Area business. Be sure to be short with your announcement an make yourself available to the group for further information.

The group was very happy with the layout that Ginger gave us in writing. Some of the comments included:

Step back at a group that has a GSR present. Be more present when the group has no GSR, encourage the group to participate in the business of AA. Remember your excitement is attracting.

Encourage your GSR's to attend the sub district meeting. It is an informal way to discuss current business at district and areas, express your encouragement.

This outline give me a great starting place with groups with no GSR's

Guiding new GSR's is a treat. Step back and enjoy.

Never use short forms of GSR's, DCM's, and DCMC's. Always state the long form. It helps the group understand and identify. They will feel a connection with your announcement and be a member of the whole.

Make sure when giving any report or announcement that your attitude is a helpful one and not a person of authority.

Sometimes I am out of my comfort zone when speaking to groups. This will help me to stay on target.

Most of the time I have no idea what I am doing but it is exciting and everything is unexpected.

Being a DCM is exciting for me. It is a way to stay in service. Keep prepared for rejection, but that is cool too. This will help me to remember I am a servant to the GSR and the group.

Remember and remind the group that this is not New York communicating to us. This is our way of communicating to New York.

Balance the information you give. Don't give all at once. Deliver a little at a time.

Next month's presentation will be presented by Jeff D of District 11 - "How to obtain a group conscience."


