### **DCM SHARING SESSION**

Phil B opened the meeting at 10:00 with the serenity prayer.

Presentation by Cathy P. District 10 on "How to help the GSR's share information from the Conference final report back to their groups". Cathy started her presentation by having a member read Page S20 from the service manual written by Bernard B. Smith (nonalcoholic) on "Why Do We Need a Conference?" stating that she believed this was a good place to start.

Number one, be sure to make sure all your GSR's receive the handout passed around our area called "How to read the Final Report". This is updated each year with correct page numbers. The GSR's should know what their group is interested in. Make sure the group knows the final report represents the conscience of the entire fellowship. Be sure to cover all agenda topics that your group covered in their group sharing sessions and have a general knowledge of all the agenda topics. The DCM should make sure that all GSR's can find the Advisory Actions, Additional Committee Considerations, Recommendations that did not result in Conference Advisory Actions and Floor Actions for the agenda items their group discussed and carried a group conscience to the delegate. Be sure to show the groups the annual contributions amount to allow GSO to be self supporting. Inform the group also about the Financial Report, the Literature Distributions, Area Highlights and Presentations given at the conference. Always remember we have a wealth of knowledge in our area from our past and present Delegates. Tell your groups about some of the people you have met at area.

- I now understand we do not have to do all the agenda topics. We can pick what is interesting to our groups.
- My group is now use to a GSR report. Knowing what the group is interested in can be very helpful.

Discussion: Rent is going up; that scares the bejesus out of me (l163)//Q If our income is 99k why can't we present a budget that is balanced at 99//A. We'd like to, but you see all the needs if we were to spend the money. Expenses are based on expected income, not actual. We'd like to have a limit. If our income is greater than our expenses, then we are doing an injustice. Last year's budget was embarrassing. People don't understand. Is it doable to present a balanced budget?//A. Some expenses may not happen. We cut back as we need. We are constrained by motions. Individual groups don't have all the wheels to work that we do.//Q. Has there been a budget in recent years that is NOT a deficit budget?//A. No.//Q. Why are we budgeting so much for I&T translation and 166/167, translation traveler? I'm confused with 131 and 167. Then we have I item 179/180.//

## AREA COMMITTEE MEETING MINUTES NOVEMBER 2013 (Cont.)

A. 131 is other travel for the committee, 179/180 are for ACM.//We haven't discussed and voted on the standing motion which Bob told us would save \$1100 per month; we need to vote to solve this problem//I understand how hard it is to do this. Looking at a deficit budget means we are looking at varied income, so it's better to plan a deficit budget. When we have a deficit it is up to me to become more prudent.//192 makes me sad. I'd like to see the PR on our budget so I know what we have in the bank.//I think I'm the only past area treas., and I want to thank the committee. I want to address some comments made about this budget. The committee does not control the budget: YOU do, it represents all the services you want. They can't cut expenses, you can. The committee can only do what you tell them to do. If you want to see changes, make motions: YOU are responsible.//L8 is that right, \$16 for misc contributions. Shouldn't you be projecting \$2500?// When I was a member of the finance committee I attended the roundtable at PRAASA: someone said there's never a shortage of money in AA: there's a shortage of communication. Perhaps we should better communicate what we need.//There is a proposed rate change by the post office for 2014, so perhaps we need to stock up on stamps. Great job.//We get a lot of people talking about this being a deficit budget, but it's an honest budget because we make the best possible estimate we can. Income is also based on estimates. The two don't always match and it's become a deficit. Look at our past and you will see we have managed. We cannot spend what we don't have. If the committee doesn't want us to do something, tell us. We need to be honest about what we expect as income and what we expect to spend. I think the big issue is trust. Trust that the process will work. This stuff we do is worthwhile and needs and should be done and the money will come, or we make adjustments.//I don't know how we do this. I'd like to see a line item for repairs of equipment.//The PR is 1/12 of the projected income.//Our Comments show what our PR is every month. Together, the Comments and budget are pretty darn accurate tools. What's in the Comments are so key to the groups.// Thanks so much for your work and for stepping in and supporting us as a team Doug. This is teamwork. Each committee has to come to us with budget proposals and to ask for more \$ if needed. We include the committees in the budget to help us be accountable. I learned through my experience not to be afraid of deficit budgets. There are no secrets here: passing it on and bringing it forward are our experience. We don't predict assembly bids and can't control overruns: we can only guess, not plan. It's the same in my personal life: I can't plan on a flat tire or other unexpected deficit budget expense. I have learned not to fear but to trust and thank you all for that.
