There were 0 new GSRs present and 0 new DCMs present. The March 2016 minutes and financial report were accepted as printed in *CNCA Comments*. Birthdays: 74/7. Registered attendance: Voting= 66, Non-voting= 34.

Officer Reports

DELEGATE Raymundo L.: Absent – At Conference in New York

ALTERNATE DELEGATE Phil B.: Thank you District 10 for a wonderful Pre Conference Assembly. It was one for the record books. It was a wonderful opportunity for all of us through our interaction to grow spiritually. From my viewport sitting next to our Delegate gave me a unique and wonderful opportunity to sit and listen and take notes of each group conscience. I enjoyed it when some of you would give a big smile and the thumbs up, after giving your group's conscience. You all were well prepared. Great Job. I invite you to attend the Post Conference Assembly in Burlingame, Saturday May 14. The Delegate will give his Conference Report for the 1st time after returning from NY.

AREA CHAIR Joann L.: We have several umbrellas and a few reader glasses left over from the Assembly. Please

TREASURER *Teddy BW*: We received \$13,925.53 in revenue, including just under \$4k in 7th Tradition contributions received at the Pre Conference. Thank you to all who contributed. This leaves us with \$7,205.88 in the bank, plus our prudent reserve of \$9,192.96. Thank you to the Finance Committee aka the Finance Elves for their help today; we will be sending out 330 receipts today.

REGISTRAR *Ray W*.: The final numbers for the Pre Conference Assembly are – Day 1, 389 voting members (65%) and 210 non-voting members (36%) for a total of 599. Day 2 – 201 voting members (72%) and 80 non-voting (28%) for a total of 281. 599 is a new record for CNCA Assembly: the old

tal of 281. 599 is a new record for CNCA Assembly; the old record was 589. Only 14 returns from the Comments/ Comentarios. At the start of the panel, there were 30-40 each month. This is due to the diligent efforts by District Registrars

and members to get address changes in.

ASSEMBLY COORDINATOR Michael Q.: Many thanks to District 10 for a wonderful 2016 Pre Conference. I have received nothing but positive feedback and personally experienced several spiritual moments during the process. In 3 weeks we will be having the Post Conference hosted by Districts 04 and 05 in Burlingame. Flyers are available in English and Spanish on the table. The Delegate's report will be translated live in ASL and also recorded on DVD which will be available at the May ACM. The report will also be recorded on CD's in English and Spanish, which will be available at the end of the Post Conference. We still have 7 open dates for assemblies in Panel 67. Please take this opportunity to discuss hosting an assembly. I have packets of guidelines and suggestions available. It's amazing what the experience of hosting can do for fostering participation for a district.

Discussion Topic:

Should our assemblies have a standard rotation similar to what PRAASA had done? Right now we use the Bid process and there is no one saying that they did not have a chance to have the experience, and there are never many districts making the bid for the same assembly. There seems to be no need.// I am not in favor of doing something like this. There is spiritual growth to the District in this process. Our district is spiritual growth to the District in this process.

Our district is very expensive and would have to pass every time, as to not cause a financial burden to the area.// I like this more than I don't. If would provide some structure for some districts to have the avariance to do this. There is no many districts to have the avariance to do this. some districts to have the experience to do this. There is good flexibility that can be put in that all district could participate.// The cost of the facility have doubled everywhere. We are going to have to get used to assemblies costing more. This is a problem in all districts and we are going to have to address the issue of assembly cost as a whole.// My area is expensive, and you would have a lot of time to plan, but maybe the chair of the area could look around for facilities that would be acceptable. Right now we have Districts coming together to prepare for assemblies. If we were told we need to do something, this would make me want to say no.// My understanding is that you will have the ability to say no, or ask for help from another District. This may give a district the push they need to participate // Like the idea or long or the push they need to participate.// I like the idea as long as it is flexible. Some Districts don't have facilities that would work for certain assemblies, but it would give all districts the ability to participate.// If we adopt a pattern of rotation, we would need to be careful the order we assign. We need to make sure we take into consideration the cost of each

district and to not place all expensive areas in one year.// How do you define rotation? I think it is a good idea, but would like to have the rotation defined.// On the rotation process, this would eliminate the current panel making a commitment for a future panel.// I thought this was a good idea, but after thinking a little more, there are many different assemblies. To have a rotation it is going to be an assigned assembly, and if there is not facility the district would have a problem. The current process allows the District to choose the assembly they can host. We are thinking about making a bid for next year, but we are wondering which assembly we could have.// How does PRAASA do it, I think we need some background has to how it is done. // It feels a little like a third legacy process for each district to experience and allow a district to participate that just needs a little push.// Maybe money could be a problem for Districts and maybe they think they don't have enough people. I think this might make it easier for them to participate.// This process starts with putting up your hand and saying let's do an assembly; then you are committed and you have to follow through. But I do like the idea of rotation, it would be a long lead time for the Districts. The cost and clumping expensive districts together could be worked out in the process. Maybe it is a good idea to have an assembly reserve set aside to cover expensive assemblies.// To have a set time to have an assembly may be helpful for districts. We can think of all the reasons not to have one; the reasons could be worked out if there was a lot of time for the Districts to prepare.// This would help Districts participate in this process.// We have hosted a lot of assemblies in our District and we would have some problems with rotation as far as the district having an assembly scheduled that they do not have a facility available.// There are some districts that are small, and do not participate in this process The rotation would encourage the district to host an assembly. We need to have some motivation for these districts and this is one answer.// I can't think of anything more that would freak my district out other then holding an assembly, and I think that would be a good thing. With the rotation process this would give the districts a little bit of the responsibility theory.// There are challenges to this process: the money, the facility and other things. We just hosted an assembly and there was a lot of growth to the problem-solving at our District. An access committee can be thought of as a special needs committee. Our district works with members who have barriers to attending a meeting. Wheelchairs, small children, hearing problems, etc.// Sometimes these committees are done by local Intergroup; this would be a great idea for getting people together to discuss solutions to these committees.// We were discussing our inventory at the I&T committee today, and one of the discussions was about what barriers are out there for members that are unable to show up & participate at the General Service level as to ACM & assemblies.// We need to focus more on us continuing to participate. If we keep participating this would attract others to participate.// This was discussed in Panel 55, and at that time there was no help from GSO as to a committee. Now there is a committee at GSO that participates in the conference committee. We would have help from NY now. Maybe we need to combine with our I&T committee. It has brought up great discussions at my district regarding this topic.// We had time today in our committee & have some time to discuss. I think

we need to do some research if there is a need for members to get to the ACM and the Assemblies, that the districts are not able to help, maybe we could contact the I&T committee. If there is a need right now, let the committee know.// There is a group in my district that takes meetings to members at their home. This seems to be a nice idea that we provided a place for these members who provide this service to share ideas.// The first thing we ask, is there a need? Second, who would fill this need? We don't have any information on how much of this is being provided at a local level and are they adequate and not fractured. We need to get a picture on what is taking place now, and define what that committee would actually do and how it would interface with the local districts.// Access involves more than just being sure people attend meetings. We have had workshops on special issues in our District and, as a result, there are meetings that are starting to meet these needs. This would be a great place for us to share ideas and solutions. If I have gone to a couple of workshops at District 12, and I think it would be helpful to us to have a resource for this information and how we can facility to have a resource for this information and how we can facilitate these needs.// Maybe if something comes out of this discussion, we could form an ad hoc to find out what the needs are and what can be done and not done, and where it would be solved.// The concept of access vs special needs can be as easy as "Do I have enough money to attend this event?" Babysitting and mental health issues could be involved. The more you look at this service, the more you find out what is needed. I think this a great idea.// I have been to some of these workshops and I have gotten to know members who have special needs. This has made me aware of the needs, and creates fellowship and unity.// I am hearing two different things: one is attending meetings and the other is attending General Service events. The access part of this service would be the same, but the issues would be different. We would have to look at what issues the area committee would get involved, or if we are just looking for a place for members to share ideas.// The responsibility statement comes to mind for me about reaching out our hand. The primary message to carry the message. We only have one signing meeting at our district. Lyander how many people are missing out on the power of the primary mentions. district. I wonder how many people are missing out on our message because we don't have access.// At my district I never had an issue with babysitting, someone always was available to help me when I was attending. I never had to ask for help, but I received it. I let go of all the excuses of participation and the barriers that occurred, but I really think this service needs to stay at the district level. << Discussion to continue next month. >>

BRIDGING THE GAP *Bill B.:* Our committee has handled 388 contacts, vs. 440 for Panel 63 2014 pre-conference assembly. The ACM approved extending the short-term correspondence pilot program for 6 months from March 26, 2016. This is intended to match members on the inside with sober members on the outside who correspond with them about AA recovery while they await release. At present there are 21 active AA members inside participating in the program. 8 A curve As members inside participating in the program. 8 had asked to participate and either been denied parole or have stopped writing. We have had training at District 8, and volunteers from Districts 04, 40, 06, 08, 10 and 15. We would like to have more districts recruiting volunteers. We are having our forum on 10/15/16 in San Jose. More information will follow at a later date.

FINANCE Russ A.: Newly revised Expense Reimbursement Guidelines for the Area were completed and presented to the ACM last October. Following vigorous loving discussions, the revised Guidelines were approved in February at the ACM. Our Treasurer successfully completed the migration of our accounts to the online version of QuickBooks in January. This has been worth the effort and will facilitate better cash management and smoother budget planning going forward. We will be updating the CNCA website with information about the duties of the Finance Committee. Financial statements are now published on the website and are easy to read and understand. Contributions continued to improve through the end of Panel 65 and have remained steady through the first quarter of this panel.

PI/CPC Phil B.: The committee has been busy with monthly discussion topics, including one that would be considered outside the box. Taking an actual AA meeting into a Sheriff's Department. After some pro and con discussions, the meeting took place. The report back was positive and it created an interest in other departments. We are looking at the current equipment again and preparing for this next year by inventorying equipment and purchasing what is needed to have it all up and running for the many requests we have had. Our committee has come up with a good start to a glossary to help our translators keep our message clear. District 16 Spanish Central is requesting that CNCA 06 restructure District 16 by removing sub-district 02 from District 16.

Discussion: My group feels that we need to keep this subdistrict. This gives us access to closer leaders that are closer and encourages participation.// This is an issue that needs to be resolved within their District. It seems to be punitive on the surface.// We are not in support with this motion. We understand that Sub District 02 does not want this motion.// Before this motion became Assembly Business, District 16 officers and the area officers discussed this issue. The decision at that time was to make this Assembly Business. This separation should have taken place in 2003, when sub-district 002 of District 16 became Sub district 006 of District 07. I believe that the Area Officers and District Officers failed to follow through at that time. We have been working on this for a long time ago, so when this panel started we felt that it needed to be finished and the follow through needed to be completed. We are not asking or kicking out any group from District 16, but we want to work in unity, but now the groups from this sub-district 002 have not attended our District meeting for 3 years. So now we would like to act as one subdistrict and follow our guidelines to participate in unity to carry the message to the still suffering alcoholic.// My subdistrict felt that this should not be done at this time. Although there have been changes to the structure of District, this needs to be worked out at a district level.// We have restructured in order to live the traditions, and we have attended meetings, assemblies and PRAASA and we are against this motion from what we learned at these events. // Under Warranty 5 of the Service Manual it states that "No Conference action ever be personally punitive or an incitement of public controversy."// Our Group feels this is punitive and under Warranty 5 is against our principle of service.// Our sub district is opposed to this motion, because we think they need to work in unity. We consider this punitive.

That CNCA 06 expand the area officer eligibility to include Alternate District Committee Member Chairs and current members and chairs of Area standing committees and sub-committees who have served as a DCM and/or DCMC.

Discussion: We are opposed to this as our District. Here are some of the reasons I heard: We should trust the process. There is already an abundance of members available for this service. This would extend the assembly length of the election. This could take away from members being available to serve at the district level and as district committee chairs. There is already a large absence of DCM's at districts. Anyone could come back and become a DCM if

they feel they are ready for area service. This sounds like it is principles before personalities. This is too general; it sounds like members can come back that are not active in service now and make themselves available. The minority was, that there are always great people in service. This motion would allow them to come back and be of service.// This motion should pass, we would gain a lot of valuable experience, and this would eliminate the moving around to a position to be available as an area officer. It may increase the election assembly time, but you would get a wider more qualified people.// We think we should not include the Alt – DCMC and we should include to the committees and sub committees.// I feel safe with the current way this is done. If I don't see members active in a position, I don't have confidence making a vote without knowing who the person is. We need to trust God. Maybe if they are not in that position, they are not ready.// When we discussed this at the ACM, it was not about being moving out of service. The motion states that they must be current. Currently if someone is a DCM and does not make themselves available as an officer, but goes to a standing committee, they are not eligible. As we consider this, we need to consider the member that is currently active through committee participation at Area.// I have experience at District at going into a committee, and I am not available to be of service somewhere else. When we listen at the election assembly, I hope we are listening to the qualifications of the member. In the Concepts it states that we do not vote for someone that is not qualified

Minority Opinion: I don't disagree with this in principle, but the motion is letting members be elected as officers when they are not voting members currently at the ACM or assembly. The alternates that it is allowing to be elected are not part of the voting members; that's kind of strange. It would also be also the part of the voting members. so change the spirituality of our election assembly as we currently do it. In order to implement this, we would have to establish a system of registration. If you were going to have to be eligible, you would have to turn in a resume, you would have to be registered. You would also have to register in the morning of the assembly to let us know you were here, to be part of the roll call. As we do it now, we had 135 members eligible at our last assembly. We were able to call each one of their names and they were able to say they were available or not available. I know several officers that did not make they were driving to the assembly. We decision until the day they were driving to the assembly. We would lose the spiritualty of that process and it would become more of a bureaucracy. Unless we could bring a new motion to allow all those members that are going to be eligible to become voting members, I don't think this is a good idea.// In the prior panels I was an alternate to a position; this motion came to us during that panel. I question the motive it makes when you need to be concerned to what position I need to take to make myself available. That's sounds like ego.// Our literature talks about the process of voting going to the hat and in that process by the time that person would the hat, and in that process by the time that person would come to the hat, they would surely be qualified. I think we would lose that if we change to this policy. On page S24 of our current service manual, under spirit of rotation states, " step out of an AA office we love can be hard. If we have been doing a good job, if we honestly don't see anyone else around willing, qualified, or with the time to do it, and if our friends agree, it's especially tough. But it can be a real step forward in growth -- a step into humility that is, for some people, the spiritual essence of anonymity."// I don't think we

should change this. It would increase the time of the election, and in the current election process, there is always members available. This would add to the amount of voters at the assembly, and dilute the power of the group's vote.// I can see members talking about the future of our area; if we open the process too wide, it would be opening our area to members available that are not ready to serve.// This would cause some problems with the election process. We don't have the availability of tracking past DCM's and DCMC's. We would have to establish a process that people would have to let us know in advance that they are available in order to manage the process, unless you want to a 10 to 14-hour process to hold elections.// I think this would take away the opportunity of the active member in service to be available. The past members may be good at service, but they might not be current with what is going around now. The 9th Concept talks about choosing people that are qualified to do service and not the most popular.// There is a lot of needs in the District to service, not the areas. We need more help with encouraging the members to service at the District, not widen area service.// If everyone had the right to vote, including the inactive member, are they taking away from the voting member that are now active.// I believe that those of us who step back and choose nothing will still be of service. Those who like the power would continue to rotate in service until they were elected to area.

There is too many things that could happen and the pamphlet could not cover them all. One good thought was that maybe we could add a column to the GV.// I have learned that this is an issue but it speaks to the heart on AA's appendix (I We feel that it is the group's). the heart on AA's anonymity.// We feel that it is the group's responsibility to make a safe environment. Each group has different environments, and with monies we don't think we need to spend the money right now.// We are in favor because it states the "we develop." This shows that it is not rules and there are so many different things that could happen, it would show things that my group never thought of. It is more dangerous than in the 30's.// We were opposed; if it does get done, group safety is not a good name. Elders will show us the way.// We are heading down a fear-based slippery slope.// Those in favor said it would help identify different safety issues.// We are in favor of this motion at our Sub District, but the minority voice stated that Tradition 4 states that each group is autonomous.// Tradition 10 has no opinion on outside issues. Others stated that group safety is not an outside issue, it is important to provide a safe group.// We have literature at our group for group safety that we have denave literature at our group for group safety that we have developed for our group. We are always seeking more information from other groups and members so we are in favor.// We feel that group safety should be handled on a case by case basis.// Maybe we could add something to the woman's pamphlet about this, and maybe adding a question about safety to the group inventory questions.// My group stated that "group safety" was not a good word; maybe safety in AA // "group safety" was not a good word; maybe safety in AA.// They seemed that the motion was too vague to get an information decision.// Maybe not a pamphlet, this might scare people off, but maybe workshops, something in the GV. Business meetings can get very angry, maybe a guideline to the secretary would be better.// This seems that maybe this

is a group inventory question instead of a pamphlet.// Throughout the year, this has been a discussion point at PRAASA. We could put this information in a pamphlet that is just exchanging experiences through it. This would give the new members an ability to express how they feel.// Most secretaries don't know how to handle this, and we deal with it after the fact. That is too late. Most people don't know how to handle an emergency; this might help with guidance in these matters. // Our society does not respond as warm and fuzzy as they used to. There have been law cases where members have sued AA for members being hurt in AA. There is a problem, and we would be showing as a society as a whole we do have a problem and we are working on a solution.// Ir my home group we often have problems because there is not a lot of security in our group. We talk a lot about this in business meeting, and there is no reference we can use; it becomes a personal issue at that point.// This is a good idea, the title is a working title. It is the personal responsible of the group but that is easier said than done. Having experience written down would be helpful to members that need anwritten down would be neighble to members that need answers.// We don't want newcomers being 13th stepped in a meeting.// This would discourage people from staying.// Violence could have a good general suggestion on how to handle this. If the group is not safe, people do not want to come.// In my group we had some old-timers talk to the member about their behavior in a positive way // Maybe if we had a pamphlet it would not be so ugly.// Secretaries and members would have a better understand on how to let people know that this behavior is not acceptable.//I think each group is autonomous. In every group there is old-timers that can inform all newcomers about this. It is the responsibility of every member to take responsibility for this.// When a newcomer comes into a group it is important that they have this knowledge to be sure they don't become a victim of other members.// I work in the mental health field, and we take classes and are educated in safety. When groups come together there is always a chance for safety issues. We need to be sure everyone is secure about their personal safety. // As my group grew we developed safety issues. I looked to other fellowships and other groups because there was not any literature on this. We have developed a policy on these issues. Most of these are handled by the secretary. I am glad for elders that can help make suggestions that can be followed.// I would like to see this added to our existing pamphlets, like the "AA Groups," "Sponsorship, "The Newcomer Asks." It would put this information where people would look. I would like to see something that says if there is a crime, call the police.// I was involved in an unsafe situation and it was dealt with by the senior members of my fellowship. I was grateful for this. I like the idea about articles in the GV.// I don't like the pamphlet because I would not like it to be seen by outside people. If they are not familiar with AA this would give them the wrong idea. I do like the GV, workshops, along with strong training for our secretaries.// When I was a secretary in a group that was in a large homeless population, and a member who was a chair and a homeless member verbally assaulted him. I don't think a pamphlet is a good idea, but I like the conversa-tion taking place in the GV.// There are lots of ways to injure

a member.// I had seen members assaulted at an AA facility, someone that was assaulted by a member never returned to AA. This goes to the heart of Tradition One. We need to inform secretaries about behavior that is not acceptable and against our traditions.// Sometimes I think we can be bottom heavy with our structure and looking to GSO for pamphlets. Maybe local level would be more helpful.// This is not just an AA issue; I think it takes place in the world. I don't know that a pamphlet would help.// Newcomers don't have the language or the skills to open a conversation.// I don't want to see law enforcement involved in a meeting. Each group should to be autonomous. // A pamphlet would be helpful. It is not something that is not known. I was at a meeting once where I was threatened. I called for strength, and the man did come.// I think the message would get out better if we directed this to a publication that could deal with it.// I think we need a pamphlet that would deliver the safety message for members.// I was a secretary at a meeting where it came to my attention that there was a member threatening other members. After talking to the group it was crystal clear that we needed to call the police.// I don't think a pamphlet is a good place for this. I think this is a discussion that could take place in the GV.// We have a statement in our group that no member should interrupt the group or another member. member should interrupt the group or another member. "Some alcoholics require medication.

We recognize that alcoholics are not immune to other diseases. Some of us have had to cope with depressions that can be suicidal; schizophrenia that sometimes requires hospitalization; bipolar disorder, and other mental and biological illnesses. Also among us are diabetics, epileptics, members with heart trouble, cancer,

allergies, hypertension, and many other serious physical conditions. Because of the difficulties that many alcoholics have with drugs, some members have taken the position that no one in A.A. should take any medication. While this position has undoubtedly prevented relapses for some it has meant disaster for others. A.A. members and many of their physicians have described situations in which depressed patients have been told by A.A.s to throw away the pills, only to have depression return with all its difficulties, sometimes resulting in suicide. We have heard, too, from members with other conditions, including schizophrenia, bi-polar disorder, epilepsy and others requiring medication, that well-meaning A.A. friends discourage them from taking any prescribed medication. Unfortunately, by following a layperson's advice, the sufferers find that their conditions can return with all their previous intensity. On top of that, they feel guilty because they are convinced that "A.A. is against pills." It becomes clear that just as it is wrong to enable or support any alcoholic to become readdicted to any drug, it's equally wrong to deprive any alcoholic of medication, which can alleviate or control other disabling physical and/or emotional problems." • "That language similar to the following be added to the section "How Decisions Affecting A.A. Are Made" in "The A.A. Group" pamphlet at the conclusion of the following sentence: Annually, groups from the U.S. and Canada elect delegates (serving two-year terms) from their areas to the yearly meeting of the Conference in New York -- to hear the reports of the board's committees, G.S.O. and Grapevine staffs, and to recommend future directions, mainly in the form of Advisory Actions.

"Prior to the annual General Service Conference a list of important issues to be discussed during the Conference is published and made available to each and every Group in the U.S. and Canada. Because these issues make up a part of the entire General Service Conference Agenda, they are referred to as Agenda Topics. Every Group in the U.S. and Canada has the opportunity to review, discuss, and develop an informed Group Conscience on these Agenda Topics. The Group's GSR then carries the Group's Conscience on Conference Agenda Topics to the Area's Delegate, usually at an Area Assembly prior to the General Service Conference. The Area Delegate then represents the collective conscience of the Groups in the Area at the General Service Conference on these matters vital to A.A. as a whole." Presented by District 11
