Chair's Preview — January 2019

I hope I can use this preview as a way of letting AA members in Northern California know what is going on in our Area. At our December Area Committee Meeting ('ACM' for short), we heard final reports from outgoing DCMCs, committees, sharing sessions and Area Officers. You can read some snapshots of that day in the minutes. We also made some decisions that will impact the Area in the future, including approving guidelines for the Web and Finance committees, approving a bid from Districts 07 (Alameda North) and 20 (Spanish East) to edit, print and mail the Area newsletters, and voting to allow the Bridging the Gap committee to support the Pre-Release Contact Service on an ongoing basis. (CNCA Treasurer); Interpretation and Translation: James B., Hector C., Patrick C., Colleen G., Marianne G., Eliyah H., Linda T., and Juan T.; Website: Drew B., Bill B., Ed G., Megan M., Michael Q., Robin T. and Don Z.

I am looking forward to attending PRAASA in March in Irvine, CA. For more information on this oncea-year event, which aims to develop unity within the Pacific Region, encourages the exchange of ideas and experiences, and provides an opportunity for members to discuss pertinent aspects of AA, visit the PRAASA website at www.praasa.org.

I am also excited about our upcoming Pre-Conference Assembly, on April 13 and 14 in Santa Rosa; it is the only two-day assembly of the year, and we will be discussing several motions, including one to create new literature regarding meditation and another to request a fifth edition of the Big Book. Now is a good time to start gathering group consciences on these motions, as the busy Agenda Topics season is nearly upon us. Final Conference agenda topics and background information will probably be available in mid-February, and your incoming Area Officers already have a plan to create the Agenda Topics Summaries as soon as the information is available.

I know this seems like a lot – and it is. But AA is magic and we get through things together. So please come visit us on the third Saturday in January in Petaluma, before we resume our regularly scheduled fourth Saturday meetings in February. I am looking forward to this adventure with all of you.

#### AREA COMMITTEE MEETING MINUTES FOR DECEMBER 2018

The monthly committee meeting of CNCA was held December 15, 2018 at the Petaluma Community Center. Jennifer B. opened the meeting at 12:30, followed by the Serenity Prayer. The AA Preamble was read by Amy B. (District 12). Gary D. (District 04) read Tradition 12 and Alan W. (District 04) read Concept 12. There were five past Delegates present: Bob D. (Panel 36, Area 28), Woody R. (Panel 50, Area 07), Doug G. (Panel 53), David N. (Panel 59), and Ken M. (Panel 61) David N. currently serves as a General Service Trustee, and Doug G. serves as an appointed committee member of the Trustee's Literature committee. There were 13 GSRs present and 18 new DCMs and DCMCs present. The November 2018 minutes and financial report were accepted as printed in the CNCA Comments. Birthdays: 129/9. Registered attendance: Voting (51) / Non-voting (55)

#### OFFICER REPORTS

Delegate – Joann L.: The report from the Pacific Regional Forum is now available. The Literature Department at GSO gave me (and I sent out) a list of when each item of literature was last updated. I have every confidence that Panel 69 will be in very capable hands, I am grateful to the trusted servants of Panel 67, and I look forward to seeing what happens next.

Alternate Delegate – Teddy B.-W.: It has been a joy and I am so very grateful that you gave me this opportunity to serve as your Alternate Delegate.

Chair – Jennifer B.: I learned a lot at the Hispanic Women's Workshop and I appreciate everything the Area contributed to help make that a success.

Treasurer – Chris H.: As of today, we have \$9,400 in our checking account (used for operating expenses) and \$11,140 in our savings account (which represents our prudent reserve). Please thank your groups for their continued contributions.

Registrar – Laura W.: I am wrapping up the last project in the database, which will allow us to update records directly from spreadsheets from the Districts.

Recording Secretary – Eric L.: The Motions Book project is complete. Once a few last reports are turned in, I will send the 2019 edition of the Motions Book out for translation and printing, so that it can be distributed (hopefully) in January.

Assembly Coordinator – Erica G.: I have done a Pass It On, and the Area is in good hands.

Literature/Grapevine/La Viña – Miguel H.: I completed my Pass It On. We have a wonderful document on Country to Country Sponsorship, and the Grapevine website has a lot of helpful information.

#### District Reports

DISTRICT 01 (MONTEREY) – Susan G.: We continue to grow, and we look forward to Panel 69.

DISTRICT 02 (SALINAS/SAN BENITO) – Eliyah H.: Proceeds from our Gratitude Dinner totaled \$14.55, and half of that was sent to GSO. We will have a full slate of Officers next panel.

DISTRICT 03 (SANTA CRUZ) – Eric H.: A motion to add a Technology Coordinator Area Officer position was introduced. We also elected four new DCMs.

DISTRICT 04 (SANTA CLARA NORTH) – Marianne G.: We held a Pass It On dinner, and we passed our 2019 budget.

DISTRICT 40 (SANTA CLARA SOUTH) – Coree H.: We will hold a speaker meeting later this week.

DISTRICT 05 (SAN MATEO) – Colleen G.: We are in the process of doing our Pass It On. Most positions are filled.

DISTRICT 06 (SAN FRANCISCO) – Dennis H.: Ten people stepped up to be DCMs in Panel 69. This is up from two active DCMs currently. We will discuss the 2019 budget and elect co-chairs for BTG (most likely) in January.

INTERPRETATION AND TRANSLATION – Michael Q.: We will be presenting two motions today. We will meet as a committee one more time in January (at 9 AM) to facilitate elections and Pass It On.

DCM Sharing Session – Jacqueline P.: We heard a presentation on being a DCM for the first time. People shared about being enthusiastic, using a service sponsor, learning how to find an answer, and asking for help.

LITERATURE/GRAPEVINE/LA VIÑA – Miguel H.: We held a cool sharing session, with a presentation on how to read the Conference Report.

H&I – Karen B.: The H&I Conference will be held in May. We are in good shape financially, and we continue to purchase literature in accordance with contributions.

YPAA– Krystal M.: Upcoming events include a game night in Petaluma, a Rocky Horror Christmas Show in Danville, and a New Year's Eve Dance in San Jose. Yeah!!!

LA VIÑA 23RD ANNIVERSARY – Rafael R.: The next anniversary will be celebrated from June 26 to 28 in Fresno. We will next choose a theme and logo for the anniversary.

HISPANIC WOMEN'S WORKSHOP – Nora H.: The workshop was a great success, with amazing energy. About 174 people registered, including three men who were allowed to help. Next year, the workshop will be held in Area 09

FORO HISPANO – Jorge O.: We held the Foro Hispano, which exceeded our expectations; more than 170 people attended. Our sober community was present with spiritual, moral and financial support. District 17 will host the next Foro Hispano.

GUIDELINES: Updates to the Web committee guidelines. – presented by the Web committee

Presentation: We made changes based on the input we heard last month, including adding language to the purpose of the committee to include the public. We added (for transparency purposes) two appendices, one with job descriptions and another that detailed security guidelines.

Questions: Q: Are the appendices considered a part of the guidelines? A: Yes.

#### Seeing no objections / Guidelines updated.

GUIDELINES: Updates to the Finance committee guidelines. – presented by the Finance committee

Presentation: We made updates to the guidelines, which had not been updated in many years. We arranged the guidelines so that they would make more sense. We created new language about the committee being able to set its own procedures. We also made updates based on motions that have passed since the guidelines were last updated (like with digital contributions).

Questions: Q: Is there language about inactive service workers? A: It does note that new members can be appointed through the same process as those who are initially available to serve. Q: Can the ACM actually disapprove of the Chair of the committee? A: Yes. The entire committee is presented to the Area for disapproval, if any. Q: Could there be something added to the primary purpose of the committee to state that the Finance committee reviews the budget and Treasurer's report? A: Yes.

#### Seeing no objections / Guidelines updated.

**NEWSLETTER BID:** 

Districts 07 and 20 bid for the Panel 69 *Comments* and *Comentarios*. Total bid cost of \$9916.90.

Presentation: We hope that by presenting a bid for both newsletters, we will be able to use economy of scale to save money on the price of mailing (and first class mail). The printing will continue to be done at the Central Office in Santa Clara County, which offers printing rates that are more affordable than most commercial printers. The goal is to use the bulk mail permit to send both the *Comments* and *Comentarios*. The cost of producing and mailing the *Comments* totals \$8546.50. The cost of producing and mailing the *Comentarios* totals \$948. There is also \$422.40 budgeted for mileage

to and from the printer.

Questions: Q: We had previously been told that the *Comentarios* was a different document, thus not qualifying for the bulk mail permit. Has the Post Office been asked if we can do this? A: I will ask. We are also now using envelopes. Q: Why are you printing in Santa Clara County? A: It was the most affordable option. Many local printers were very expensive, and our Central Office did not have the capability to print our newsletters. Q: Would the *Comentarios* arrive to people on time? A: The bulk mail may be delayed. But the *Comentarios* have sometimes already been sent out very late and not arrived on time.

# The Area Committee accepted the bid by show of hands.

COFFEE BID:

No bid has been presented.

Presentation of New Business:

That CNCA compensate the translators of written materials, pursuant to the I&T committee guidelines –

- At the rate of \$180 per month for the complete translation of the Comments/Comentarios; the agendas, minutes, and presentations of the area's standing committees, subcommittees, and sharing sessions; and the agendas for the Area Committee Meeting and CNCA Assemblies.
- At \$20 a page for all other written materials.
- presented by the Interpretation and Translation committee

Presentation: We have been discussing this for 18 months, since we discussed the newsletters and it became apparent that the way we have been doing the translation is not sustainable. We have been using the same small group of people for the past five years. We looked at suggestions like using software programs (which do not work) or hiring professionals (which could be too expensive, since there would be fees for proofreading, editing and rush jobs). We looked at Tradition Eight, but since professional services would not be affordable, this is what we have come up with.

Questions: Q: Would this be a contract situation? A: This would be with our AA volunteers. Q: Would this last one year, or would it be renewed each

year? A: This would go on until it was amended or repealed.

Motion remains Area Committee Meeting Business. (35 to remain at ACM; 6 to forward to the assembly). Motion will be New Business.

PRESENTATION OF NEW BUSINESS:

That CNCA compensate the translators of the Agenda Topic Summaries, pursuant to the I&T committee guidelines, at the total annual rate of \$500.

— presented by the Interpretation and Translation committee

Presentation: The Summaries range from 30 to 40 pages and translation takes approximately three to four days to get this ready. This involves compiling the documents, researching the background information, and making sure we are using the right wording. The Summaries are time-sensitive.

Questions: Q: Would we ask other Areas to provide finances for our translation? A: No. Q: Has this been looked at by the Finance committee? A: No.

Motion remains Area Committee Meeting Business. (Decision made by show of hands). Motion will be New Business.

**OLD BUSINESS:** 

That the CNCA Bridging the Gap subcommittee conclude its Pre-Release Contact Service pilot, and support this service on an ongoing basis.

- presented by the Bridging the Gap committee

Discussion: This bridges a gap between what the General Service Office does and what is not being done. // While this is an importance service, it diverges from what Bridging the Gap does. I would love to see additional guideline and procedures. // This practice has already been in place, and it is working quite well.

The Area committee was asked if they were ready to vote, and members were ready to vote. Substantial unanimity (2/3) was required for the motion to pass.

Vote: Yes (Substantial Unanimity, No Count Taken) / No (1). Motion passes.

Thank you for the past two years, Eric L. CNCA Panel 67 Recording Secretary We now will continue with our tradition of Pass It On by turning over this portion of the meeting to our incoming Chair.


