Chair's Preview: March 2019

And that busy, busy time of the year is now upon us. Much of General Service revolves around the annual Conference in New York, so these next two months, as our Area prepares to send our newly-elected Delegate to New York to represent us, are pretty exciting. And somewhat hectic. Navigating through PRAASA, multiple business meetings, Agenda Topics Workshops, and the numerous other things that help prepare all of us to ensure an informed group conscience can be a daunting chore to those new to General Service.

But that energy which emanates from these discussions will guarantee my sobriety for at least another 24 hours. These topics are the manifestation of the Fellowship identifying an unmet need, and attempting to find a solution to help save someone's life. In AA, the discussions we have today may not always be stimulating, but they do refocus our sobriety on how to ensure that our message is accessible to anyone that needs it.

I am writing this at PRAASA, thinking mostly about how we in AA carry the message – and about how our message saves lives. And also thinking about these next six weeks and the multiple business meetings we will now navigate – and how to remind myself that the business we discuss helps facilitate the ability to carry our live-saving message.

At our most recent Area Committee Meeting, we continued discussing two motions about compensating translators of our written material (including agendas, minutes, materials in the *Comments*, and the Agenda Topic Summaries), a motion about requesting the Delegate for specific events, and a motion about providing group consciences to the Delegate electronically. We also continued discussing potential changes to the structure of CNCA.

Those discussions will continue – along with the many discussions we will have at the Pre-Conference Assembly's business meeting. But one discussion we will very likely table is our current Area motion to request a Fifth Edition of the *Big Book*. Because it is currently an Agenda Topic – and we expect a lot of people to share group consciences on this topic – we will probably delay discussion on our specific Area motion until we see what happens at the Conference. Other business – including a request for literature regarding meditation and a request to form a Technology committee – remain on the agenda, and we might even vote.

The afternoon will be dedicated to the Agenda Topics; the Pre-Conference Assembly flyer lists what topics we will discuss each day. I can't wait to hear all the loving discussion on both area business and the Conference topics. This is an experience you absolutely must not miss.

If you are a new GSR, welcome again to Panel 69 and the adventure that is General Service. I think we will have a lot of fun, and that we will do a lot of good.

What remote communities exist in our Area and in our districts?

This question has been on my mind for a while and I share it as I sit here reflecting on the inclusive and loving experience many of us had attending the Pacific Region Alcoholics Anonymous Service Assembly (PRAASA) in Irvine. The multiplicity of languages and experiences we received from the podium made me reflect on the enormous opportunity that faces us as we refine not our *message*, but the *methods*, by which we carry it.

What has become clear to us in California Northern Coastal Area 06 over recent years is the extent to which Spanish-speaking women are a remote community. What others exist and, how will we discover them, receive their input, and act upon it? In short, where does responsibility rest in our Area for remote communities?

At the most elemental level, the answer can be found in our Responsibility Declaration, which declares, "*I am responsible...*" For me, this means to be welcoming to all those who seek us out, whether they look like me, or not. But what then? Just as an individual and a home group lack the resources to meet all needs, how will these needs then be met?

One of the reasons we have districts, intergroups, areas, and other service committees is to coordinate services that members and groups cannot do by themselves.

Last year the Treatment and Accessibilities Committee for the Conference (which I now get to serve on) added Remote Communities to its scope of responsibilities. This year the Treatment and Accessibilities Committee gets to review the draft of the proposed Remote Communities Kit (Treatment and Accessibilities Committee: Item E). To help me do that I am asking you to let me know at our Pre-Conference Assembly, what your groups think about the contents of the kit. To do that requires us to think about what remote communities exist in our districts and Area.

So, I come full circle. What remote communities should we be serving? Once we know that, we can begin to figure out how our current structure facilitates that, or not.

The monthly committee meeting of CNCA was held February 23, 2019 at the Petaluma Community Center. Eric L. opened the meeting at 12:30, followed by the Serenity Prayer. The AA Preamble was read by Mark H. (District 13). Ashley J. (District 04) read Tradition 02. Josephine C. (District 90) read Concept 02. There were five past Delegates present: Joann L. (Panel 67), Bob D. (Panel 36, Area 28), Woody R., Doug G. (Panel 53), and David N. (Panel 59). David N. currently serves as a General Service Trustee. There were 7 new GSRs present, 9 new DCMs and 19 DCMCs present. The January 2019 minutes and financial report were accepted as printed in the CNCA Comments. Birthdays: 67years Registered attendance: Voting (52) / Non-voting (62)

Officer Reports

DELEGATE – TEDDY B.-W.: Agenda topics background arrived and then additional background for a Literature item and a Grapevine item both arrived this week. Area 06 will be participating in the Remote Communities meeting held prior to the official start of the General Service Conference this year.

ALTERNATE DELEGATE – JENNIFER B.: Area 09 (Mid-Southern CA) is hosting the next Hispanic Women's Workshop. The host committee has asked the other areas to appoint liaisons to the event and the officers are asking any interested women in your districts (preferably those who speak Spanish or are bilingual) to submit their names by the March ACM.

CHAIR – ERIC L.: Area Officers have started to prepare the Agenda Topic Summaries, which will be available by March 1. At the Pre-Conference Assembly business meeting Saturday morning, we will probably table the motion requesting a fifth edition of the Big Book until after we see what happens at the Conference.

TREASURER – LAURA W.: We have \$12,084 in our Checking Account for Operating Expenses, \$11,140 in our Savings Account, for our Prudent Reserve. Please thank your groups for their continued contributions.

REGISTRAR – ERICA G.: Last month I asked everyone to be patient with me. Everything that I have received is current now so you don't need have to be patient anymore.

RECORDING SECRETARY – MIGUEL H.: Reports on all formats are welcome. I'll continue recording our monthly Area business meeting as a tool for the typing of minutes; these will be deleted after used.

ASSEMBLY COORDINATOR – COREE H.: We're gearing up for the Pre-Conference Assembly. We still do not have a bid for the 2019 summer assembly. We haven't seen any actual bid forms.

LITERATURE/GRAPEVINE/LA VIÑA – MAGDALENA O.: Spanish speaking women stories submissions are doing great. The new La Viña issue "Mi peor día sobrio" suggested the topic for the next issue: "How are we treating others in AA."

District Reports

DISTRICT 01 (MONTEREY) – SUSAN G.: We continue to have an Agenda Topics discussion. There was a brief discussion concerning an anonymity break with a full face and name included in the local newspaper.

DISTRICT 02 (SALINAS/SAN BENITO) – BRIAN MCG.: We discussed co-hosting an assembly 2020. Elected a representative to attend PRRASA. We are planning an Agenda Topic sharing session, a Safety in AA workshop, and a Secretaries workshop.

DISTRICT 03 (SANTA CRUZ) – MURIAS O'C.: We are working with District 02 & 19 for an assembly. More to come. The Web Committee is finalizing password protection for distribution of background materials. Agenda Topic Workshop date is March 9th.

DISTRICT 04 (SANTA CLARA NORTH) – JULIE N.: We had a rousing and informative talk from our area officer about PRAASA we also broke in to Sub-Districts to ponder the upcoming assembly. Unity day will happen in Santa Clara this year; we have a date and venue. Our Agenda Topics Workshop coming up in March, translation will be provided.

DISTRICT 40 (SANTA CLARA SOUTH) – MANUEL R.: We had a busy month. We had a new business presentation “that literature be developed for the LGBTQ Spanish speaking alcoholic who is potential remote community within our fellowship.” We are giving scholarships to attend PRAASA with up to \$100.00 each.

DISTRICT 05 (SAN MATEO) – MATT D.: Received request from Area Member to bring a meeting to a homebound man in our district. Central Office forward request to Sunshine Group.

DISTRICT 06 (SAN FRANCISCO) – JUSTIN H.: District 06 met for the second time at our new location. We have a record number of DCMs registered as we start the Panel with 12, which is up from only 3 registered last panel. We voted to grant a scholarship for PRAASA and report back to the District.

DISTRICT 07 (ALAMEDA NORTH) – VIVIAN K.: Looking forward to the Agenda Topics Workshop in March. The Comments & Comentarios mailing happens on every 2nd Sat.

DISTRICT 70 (ALAMEDA SOUTH) – NORA H.: Our Agenda Topics Workshop is coming up on March 10th. This event is being organized by the amazing Alternate DCMCs from D07 and 70.

PI/CPC – JENNIFER B.: We talked briefly about the GS Conference Agenda topics under PI and CPC. Item under Public Information came out of the Panel 67 PI/CPC committee here in CNCA. (Item C4 about creating a PSA using full face actors) It's always fun to see the full process when an item from here makes it onto the agenda at the Conference.

NEWSLETTER AD HOC – RAY W.: We met this month and discussed the preparation of the final committee report. We expect to have it ready to present and distribute by the April ACM. I will also be presenting a housekeeping motion.

DCM SHARING SESSION – SARAH B.: We had a presentation about "Everything you need to know about being a District Committee Member (DCM)."

ACCESSIBILITIES – KELLI E.: We had a great discussion on wheel chair accessibility after a really great presentation and check list from GSO from their website.

LITERATURE/GRAPEVINE/LA VIÑA:– MAGDALENO O.: We had a fun sharing session with 15 different representatives, and two visit. We had a presentation on how submit subscriptions for the GV & LV. In March we going to talk about Agenda Topics related to GV & Literature.

OLD BUSINESS:

That CNCA compensate the translators of those written materials as are specified in the I&T committee guidelines – A. At the rate of \$180 per month for the complete translation of the *Comments/Comentarios*; the agendas, minutes, and presentations of the area's standing committees, subcommittees, and sharing sessions; and the agendas for the Area Committee Meeting and CNCA Assemblies. B. At \$20 a page for all other written materials. – Presented by the Interpretation and Translation Committee

Discussion: We are in favor on both we believe labor its worth as is a higher, we need this material cause our language is Spanish and we are in favor of this, has a finance member we don't have a opinion on this but I have an observation to stay in the budget and how this will impact, the budget calls for 10,800 short this year that will live us at the end of the year at 3000 in our checking account if this, motion passed along with the other motions, this will make us go to out prudent reserve, a could be variation this is just budget it's a big expense, basically giving our budget as it is and everything goes as a predictive we will go to our prudent reserve, what we will be paying is about 180 dls a month more in translation and 20 dls an addition total of 3,000 dls at year. What happened in the past we had problems getting translation done by compensating this to our translators will help us get the documentation done faster. They are not even charging even 30% of the total cost, every year we have a motion to send money to GSO we have to pay our servant to be able to demand a little be more. There's thing I cannot be train to do something like translating, this is a special skill that deserve some kind of compensation. This kind of skill cant b passed on. We are not going to be able to

compensate this at the level to get out there and get a translator I think this is a danger area by setting a precedent for our future panels. I not only think this is inappropriate for the I&T committee, we been compensating out interpreters for 15 years. We need more time its new in the panel, we need to do more research. I understand that if we have volunteers doing this work it's the law to have some one always doing it. We have employees doing this at the GSO, the far as I can see it's a only job that a could be done by some members only, not something a could be done by anyone that likes to help. When we start preparing this motion took us about two years to do all the research, base in the contributions coming to area the number that we came out with was 5,320 per panel, that's not the price for compensation so we area changing for this service, we are not getting pay this is just a compensation, the price for professional with a contract will be around 20,000 per two panels. This is not a question of economics or money it's more about quality and fairness. Us as Hispanics we need the translation we have the fortune of been part of Area 06.

Discussion will continue next month.

That CNCA compensate the translators of the Agenda Topic Summaries, pursuant to the I&T committee guidelines, at the total annual rate of \$500. – Presented by the Interpretation and Translation Committee.

Discussion: My District supports this motion. Has a GSRs needs to have this in two languages its crucial communication having it available. I'm in favor in of having translation, the summaries started it because the background was not translated, so we needed it for the Delegate to be able to have the information for all the groups that need Spanish version of it, now we have the background translated so the purpose changed a little be just something to think about. We do pay fro interpretation in our assemblies. This is a bilingual state and we should have this compensate, if they require mileage lets give it to them. My District not even know what an agenda topic summaries are, can we continue discussing these next month.

Q: It's there any area that does this job and how they do it? A: They do compensate for this service, Arizona is one of them.

Presentation – EVERYTHING YOU NEED TO KNOW ABOUT BEING A DISTRICT COMMITTEE MEMBER (DCM)– PRESENTER LINDA T. DISTRICT 10

Having been a GSR prepares you to be a DCM because your primary role is to support GSRs and keep them informed. Suggestions: get a service sponsor; attend PRAASA, explain acronyms; attend Assemblies, DCM Sharing Session, and Area Committee meeting; visit the General Service Office; read your minutes, newsletters, and other communications (Comments/ Comentarios, Box 459); read your service manual and study the concepts; let GSRs know how to get in contact with you; email GSRs in subdistricts regularly; support GSRs in facilitating agenda topic sharing session; support GSRs taking inventory for their groups; visit meetings in the subdistrict (both homegroups and meetings that are not represented); visit other districts and areas; orient GSRs to a panel calendar. Resources: Your DCM pamphlet, D.C.M. Kit from General Service Office, and Agenda Topics Timeline.

Members Share

Chair called on members who raised their hands to ask questions and share for no more than one minute.

The chair reminded members that everyone has something valuable to share.

Q: Is the DCM kit is provided to DCMs by GSO? A: It may not be, but you can order it yourself

Discussion about the role of DCM for groups that don't have GSRs

Someone shared that people sometimes don't understand that General Service needs the group, not the other way around, but some groups are just not interested in General Service.

Someone shared concern about the burden for GSRs supporting multiple meetings and having many meetings that are not represented.

Someone shared about the power of one alcoholic talking to another within the context of DCMs connecting with GSRs (e.g., going to coffee)

Members shared about possible formats for subdistrict sharing sessions (e.g., inviting area officers, a private Facebook group, GSR workshop)

Discussion about addressing the myths about being a GSR// GSRs losing enthusiasm for role due to being intimidated about the responsibilities;

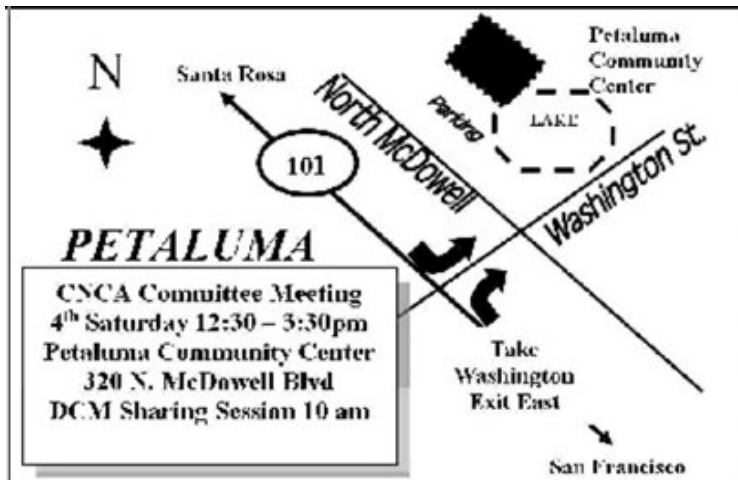
