Chair's Preview

I want to welcome our newest Area Officer, Dennis H., who will be serving as our Treasurer for the remainder of Panel 69.

To update our readers, our previous Treasurer resigned because of health reasons just prior to the Summer Assembly. Several candidates made themselves available to replace her, and Dennis (a previous DCMC and Finance Chair) was elected on the Fifth Ballot. The minutes from the remainder of the business meeting are included in this issue of the Comments, including a summary of all six afternoon workshop topics.

At the Area Committee Meeting two weeks later, we passed four housekeeping motions (to purchase a new microphone cable, to move the date of the August 2020 ACM to avoid conflict with the Pacific Regional Forum, to provide a letter of spiritual support to Santa Clara County's young people committee for their bid to host ACYPAA, and to reimburse the travel costs of our inventory facilitator). We also approved a bid (by four Districts!) to host next year's Post-Conference Assembly, and we passed a motion to purchase secure web conferencing software.

We heard two heartfelt reports from the National AA Archives Workshop and the Bridging the Gap Workshop Weekend from members from the Area who were funded to attend. And a motion to request a pamphlet for the LGBTQ Spanishspeaking alcoholic was forwarded to the next assembly.

That next assembly - on November 2 in San Francisco - will include that presentation of new business. We will also continue discussing all of our Area Assembly motions, and possibly even vote on one (or more). In the afternoon, the Area will hold its biennial inventory.

The inventory process is a profound and spiritual exercise, during which we assess what we as an Area are doing well, and what we can do to improve our service to the Fellowship. I encourage everyone to participate in the inventory discussion; from these discussions, the Area can learn how to best help new GSRs, ensure that our DCMs and DCMCs are wellinformed, and provide guidance to officers and committees on how to best serve the Area. There were (7) New GSRs, and (3) New DCMs (4) past Delegates present: Bob D. (Panel 36, Area 28), Woody R. (Panel 50, Area 07), David N. (Panel 59), Raymundo L. (Panel 63) David N. currently serves as a General Service Trustee. The August 2019 minutes and financial report were accepted as printed in the CNCA Comments. (The August financial report was not published on the September's issue of Comments nor Comentarios). Birthdays: 294 years. Registered attendance: Voting (52) / Non-voting (52)

OFFICER REPORTS

DELEGATE – Teddy B.-W.: Registration for the 2020 International Convention in Detroit, July 2-5 is now open. Registration for PRAASA 2020 in Tucson March 6-8 is open via mail but online registration has been delayed. www.praasa.org. Meeting Guide 3.0 is now with us, the app has been updated to include: Search and Daily Reflections. You can download it for free on the App Store or on Google Play. The pamphlet 'A.A. for the Older Alcoholic -Never Too Late' is being updated and we're seeking stories from a broad cross section of older A.A. members to make the pamphlet more representative of the Fellowship. And finally, if you have a conference theme suggestion for 2021, next year is 2020: A Clear Vision For You, then I am accepting suggestions until December 10th.

ALTERNATE DELEGATE – Jennifer B.: About AA Newsletter contains news of Alcoholics Anonymous intended for professionals who might benefit from knowledge of A.A. as a resource for their patients or clients, the lead article is about the success of "Sobering Centers" around the country, including here in San Francisco. One of our Class A (nonalcoholic) trustees, is quoted extensively in the article. Elsewhere in the newsletter, another Class A Trustee, Leslie Backus, is pictured in front of a display booth at a professional conference like the one we had a few months ago in our area. Just last week, a third Class A, Christine Carpenter, joined Nancy McC. on a six-day, 7 city, 1000 mile "Friends of Montana Trustee Tour" where they spoke with various professional communities in conjunction with the Area 40 CPC committee. This is just another example of their incredible passion and commitment to service for Alcoholics Anonymous.

CHAIR – Eric L.: I want to welcome Dennis, our new Area Treasurer. We now have a vacancy on the I&T committee; if you are interested in serving on this committee, please submit your name to any Area Officer.

Treasurer – Dennis H.: I have been in contact with Laura and working on the pass it on. We checked the banking account, please if you have any questions about checks or unclear deposits feel free to contact me. I will have a financial report for the next month's comments.

REGISTRAR – Erica G.: Thank you to the registration team at the Summer Assembly, the totals of attendees were 292 voting / 121 non-voting, 413 total, 179 GRSs & 24 Alt GSRs. Our registration information as been moved in to a new database which we've been working on and we have received positive feedback about the update.

RECORDING SECRETARY – Miguel H.: Thank you to all the members available to work on helping with the edits of the minutes. Also thank you for all the love the Area shown on the past few months.

ASSEMBLY COORDINATOR – Coree H.: Speaking ofplease give a round of applause for all the hard work that the host committees put in the Summer Assembly. Really looking forward to the Inventory Assembly in November, District 06 has had some really cool ideas for the event and it's an assembly venue that is very near and dear to my heart. Finally, we're still going to need a bid on the Election Assembly next year.

LITERATURE/GRAPEVINE/LA VIÑA – Magdaleno O.: Literature: GSO sends 14,000 pamphlets, and other items including close to 5,000 issues of the Big Book and other materials. GSO also answers about 40 phone calls and replies to about 250 emails on a daily bases. *Grapevine*: October issue "Is AA Accessible to all?" This month's special section is on accessibilities including folks in wheel chairs, those with sight challenges, or issues with hearing loss, etc., and members who have done service with accessibilities committees. *La Vina*: September/October's issue will be: "Sober with out God."

PI/CPC – Jennifer B.: Over the past 9 months, the

various committee members have shared so many resources and ideas for ways to inform the public and professionals about Alcoholics Anonymous. Putting Living Sober books in those little free libraries you see in residential neighborhoods, looking into ways to reach alcoholics in the deaf community, discussion about creating a committee position to focus on outreach to African-American alcoholics, and starting more joint committee meetings with other service entities. Today members from Marin demonstrated for us what a PI presentation to high school students might look like. Next month our roundtable discussion will focus on media outreach. Also, next month, I will bring our display to the BTG Forum in Napa on October 12th.

WEBSITE – Drew B.: We have begun the archives pages. Keep an eye on the website this month. Web vs. Tech- Had a lively discussion about the duties that the web committee carries out that the fall outside the scope of the website (like projectors, screens, and Wi-Fi). We are working up our Finance budget worksheet for 2020, and making adjustments as we consider the next years plans and services. Next month Megan M. is going to give her report on her experience at the National AA in Tech Workshop that was last month in Bowling Green, KY.

INTERPRETATION AND TRANSLATION – James B.: We had a fun time providing interpretation and assisted listening at the "fun assembly". Speaking of inventories, we are making our plans to have ours at out November meeting. The committee translated 19 pages of text in the last month. STRUCTURE AD-HOC COMMITTEE - Justin H.: Thank you all the members that participated, we will have

something finalized to present next month.

DCM SHARING SESSION - Sarah B .: Today we had a presentation and discussion on reaching out to remote communities. We were educated on who remote communities are and their challenges with accessibility, the history of remote communities, how the traditions tie into the importance of reaching out to these communities, and how we can better carry the message to these groups of people and encourage their participation. Beth also shared some valuable resources with us. Some helpful reflective questions that the group considered to guide their thoughts and actions were: "who is not here and why," "what can we do to welcome them," "what can we do when we're not a part of the remote community we're trying to reach," and "what can we do to reach them when they're not in the rooms?" Next month we will discuss reaching out to different ethnic groups within A.A.

ACCESSIBILITIES - Jennifer K.: We had an access sharing table at the Summer Assembly. We prepared materials and hand-outs with accessibility related sources. We also facilitated conversations on starting dual-diagnoses workshops in other Districts. Some other discussions were based on child care, using experiences from members at District 12.

LITERATURE/*GRAPEVINE/LA VIÑA* – Magdaleno O.: We talked about our internal motion on the creation of a Lit/GV/LV Sub-Committee and we will continue to talk about this next month.

H&I LIAISON – Karen B.: Our next General Committee Meeting is Sunday, October 13th, at 11:00am in the Central Park Community Center, Terrace Room, 12501 Alcosta Blvd, San Ramon, CA 94583. H&I Area 52 hosts this meeting. Lunch will be served. On the agenda: changes to our policy manuals, the approval of our budget for next year and the election of a Finance Committee Member, via the 3rd legacy procedure. General Committee Meeting attendance is open to all alcoholics.

NCCAA – Robert G.: San Jose Conference in March and the planning committee meetings are on the 2nd Saturday of the month. In San Jose the delegates will be electing a chairperson.

YPAA – Vanessa C.: SCYPAA Our group inventory was surprisingly smooth for 5 hours. We are help-

ing CRUZYPAA to get back together by contacting prior members and attending their business meetings. Bay "Y" is happening on October 25th with a group of YPAA meeting together for a Halloween event.

PRESENTATION OF NEW BUSINESS

We passed this motion at District 40 unanimously. It is for members that speak Spanish. Within this community, there are historically a lot of cultural taboos on sexuality. For example, many who come out as gay face rejection from family. This is in the same spirit as the pamphlet for the LBTGQ in English. We consider this a remote community. We contacted several GSO in Spanish Speaking Countries like Mexico, Colombia & Spain and none of these countries confirmed the existence of this kind of material or pamphlet.

Q: are we making a little amend as you read it LBTGQ instead of LBTG: A: yes was typo / Q: statics mention South America, this pamphlet is intended for all this countries- Is this material directed to members in South America or members from the United States? A: If this material is produced, we will share it with all those who need it. / Q: Who will be sharing Stories for this material? A: It will be up to the General Service Conference. Will be presented as New Business at Fall Assembly.

Substantial unanimity / 1 opposed / abstentions 1 Minority Opinion: I don't feel comfortable to vote on continuing financial obligations when the Area doesn't have guidelines and it's not clear how access to the service will be managed, how people will request to use it. AA is for everybody, that thought has come to me, when they come in - we welcome them, that's the first thing we can do / pamphlets are making differences, the geographic areas makes a difference / cultures vs race concept of dealing with the problem / east Oakland has significant number of people, where in this room are we trying to promote AA? / if we can't communicate, we have to do what we can do / it is very interesting. I'd like to know what happened to us, we speak about race religion etc. / we are diverse people, if we come we stay sober, we know people that some people have more privileges than others / I have the pleasure of bringing this topic to my group to discuss, people felt welcome cause of the bay area has multi-cultural vibe, I always had good feedback from people attending assemblies / there seems to be lots of diversity in young people meetings, we need to work on this but young people are doing a good job keeping more diversity, the future of AA is in good hands with them / we need to use caution saying 'out reach' / my home group has good involvement, providing the message to everyone / my daughter is half black and half Hispanic I had the opportunity to talk to a friend of hers, we can connect to them and still relate.

OLD BUSINESS

 "That the Trustees' Literature Committee add to its agenda to consider publishing a Fifth Edition of the Big Book, Alcoholics Anonymous, with updated stories to more broadly reflect our current fellowship, as well as updates or additions to Appendices III and V". – presented by District 40

Discussion: Our group feels pretty much in favor of changing the stories, minority only in favor if the 164 stays the same / in favor of updating the stories as well as the chapter To Employers / our group is in favor of stories to being updated / all in favor changing stories, we would like to know more about the appendices changes though / we are grateful to have so much diversity / majority in favor, not comfortable about changing the appendices / all in favor of it, we need a fifth edition, focus on young people / we need more changes, rather than just the stories and the two appendices / divided opinion, stories and appendices for reference and younger people stories / needs more reflection of LBTGQ / anonymously in favor on getting more stories / split conscience, minority like to see other parts of the big book updated / in favor of what would be changed through this motion and also voiced that most of the book should be changed as well / majority in favor, need to make a whole new book to reflect our fellowship and update the language / yes we should change stories, in 80 years from now we are going to need to update the doctors opinion/ the big book was made when the fellowship was basically all the same religiously, also not all ethnicities are reflected in the stories / group in favor of all the additions and changes, believe that editing the book will make it more accessible / in favor unanimously, specifically the wives chapter / voted in favor, add more stories from other races and members with variety of socio-economic backgrounds / we are in favor, please include stories in the back reflecting mental health issues / most in favor, there's fear to

be the last print of the big book / in favor, want to see stories covering mental health issues and young people stories / we are in favor for adding stories but also eliminating irrelevant stories / more trans stories, updates on medical transition process / more representation on current sobriety, as far as references in the appendices, might help make the program more able to help a broader range of people if on experience from courts and other professionals and not limit to religious entities / in favor in changing the back of the book but also change the front / stories in the back with a need for more stories of Hispanic members / we are in favor on changing those subjects / more new stories from members with deferent backgrounds could be beneficial / all in favor for modernizing the stories but we are against the revision of the 164 pages / lots of members have problems with how the appendices look, in favor of change / most members don't like the idea of a 5th edition / in favor / all in favor, making the personal stories more gender inclusive / wants religions represented other than Christian and have better language throughout the big book / generally in favor of change and modernization, especially chapter to the wives / a question about whether producing a 5th edition will cost money or will generate money? / Stories need to be more relevant, groups need to know more about how the 5th edition would look before they decide yes or no / in favor members feel and think all appendices need to be updated. Will continue at Fall Assembly.

"That CNCA establish a standing committee on Technology". - presented by Dennis H. Discussion: How would this committee be utilized? and there's concerns on how much work it will be for the committee members / in favor of the idea. but won't the web committee do all these jobs? / There's lots of confusion what the committee will do. But we are in favor / disagree on why the tech committee is needed / cons: web committee all ready exist / the rotation on the committee could be helpful, to serve better / in favor but please give us more information how exactly it will work and what it will do / need more info on how this will serve / tech is beyond website, feels like can't work together, we feel we don't need more people on the committee / unclear we don't have the whole idea of how the technology committee will function

and we think the area is doing well as it is / we are against, will be too big and need to define the scope and function of this committee / we need more information, we don't see an actual need for this, motion is not clear / we are in favor. AA needs to keep up with tech / The word technology could be extensive, not clear what is going to be responsible for and also if is going to be any cost? / what is going to be responsible for? / we are confused in the responsibility and handling, licensing, usefulness / if we have a need go for it / group is against, we have a committee, we should just update and have more members on the web committee instead of having a whole new committee / my group wonders what is this for and had lots guestions about anonymity, an example is that there are a lot of on-line forms nowadays and data mining could be an issue, motion is not clear / we need more information on this / we need to define what the committee will be and see if there is a need for this, are we sure we have a tech need? / we need to see what we have and what we do not have, then discuss more once all members understand, then we should have a special worker guiding us and help explain. Will continue at Fall Assembly.

WORKSHOPS

1. TRUST, GROWTH, AND UNITY AS A FELLOWSHIP IN THE DIGITAL AGE

Presented by Tatiyana S., District 09. Open the door to more by developing a social media platform / to trust the Alcoholics Anonymous Board of Trustees and Conference with how to work in the digital world / reinforce service work within the digital age / reinforce the reaching out using social media and technology by teaching the Traditions to keep our program intact/ using technology appropriately could be a good guide to future generations and a way to be more inclusive / we have to trust AA will survive this digital world, more than reaching out, we need to be there.

2. ARE WE INCLUSIVE? WHO'S MISSING FROM OUR MEETINGS?

Presented by Marisol A., District 03. Experience as a person of multiple minority status / shared some examples of situations that limit accessibility and inclusivity, such as, circumstances limiting ability to attend / expectations about behavior and expression of gender; sexuality; race/color of skin; mental illness; ability; and language / these are issues and conversations that are being discussed widely: Questions about this topic are very much spiritual questions, designed to raise our level of consciousness / Diversity itself is a useless word itself without inclusion. It takes work to be inclusive, and the way we achieve it is to participate / A member reminded us that the alcoholic who still suffers is just the one that isn't in the room. Feeling different from others is what keeps us suffering / A member shared how bringing up discussions of inclusivity and accessibility and how to combat it leads some members to be weary, that this borders on promotion / Several shared their experiences of being judged and feeling unaccepted due to their mental illness / A member shared her observation of a lack of newcomers in her homegroup, a "dinosaur meeting," consisting mostly of old-timers / suggestions on going to meetings where you feel uncomfortable (e.g., straight people going to LGBT groups), because that's what makes us grow.

3. OUR 12 TRADITIONS AND LOCAL CUSTOMS Presented by Alma L., District 18. 1957 convention presented the traditions to protect our selves from prestige and money / some members don't like the religious accent of our program and some groups do – either way it still works/ Hispanic speaking group formats could hurt members for profanity and sexual behavior, some members talk and use the AA language with poor motives, cross talking almost always happens in Spanish speaking groups / traditions are suggestions just like AA suggest that we should stop drinking / only listening and translate everything to the best use, everything can change depending on the way we practice our program / groups vary in the way we use the 7th tradition, I learned that today / we can do better in the way we act toward all AA members, not just newcomers / there's a stigma in Hispanic mix meetings about females / at my group we don't talk about great sponsorship we talk about great sponsors / the members split the cost for the events we organized, all the money and all the cost and expenses, are all these celebrations necessary?

4. WHAT COMES AFTER THE GROUP INVENTORY? Presented by Chase C., District 70. Conduct group inventory as our group can tell us about our personal inventory / speaking about fall assembly and what to expect and implementation at my homegroup/ group inventory can seem not personal, but can we say 'it is not our job'? / where do we focus as a group for the solution, and for our primary purpose / how to work with the results of a group inventory and take them into action items if indicated / lots of discussion, not much action / group inventory is not personal, the group decides, we just give the tools, how we could stay focused on our primary purpose?

5. IS AA STILL RECEPTIVE TO BOLD NEW IDEAS? Presented by David S., District 40. AA is not what used to be / today it may seem that AA does not welcome new ideas / there are things like technology motions and other ideas that suggests that AA is open to new ideas based on the content of the motions / new ideas will materialize over time with new needs / there's more sources in the AA literature that reflect lots of bold ideas / AA should not change in welcoming new bold ideas, we have helped so many people as it is / GS could make a motion and everyone is welcome to participate, so in many ways we are open to bold ideas / AA is what it is already for welcoming all those ideas.

6. MY PERSONAL CONTRIBUTION PLAN Presented by Justo T., District 18. Share about contribution plan, physical, mental and financial contribution / 38 people attended / as a newcomer's sponsor educated them and gave them an envelope for the yearly contributions and avoid unnecessary expenses / once the basket pass around and if it doesn't hurt when you put the money in the basket put more than 5 dollars in the basket until it hurts / making a group conscience in our group on how money is expended at GSO.

WHAT'S ON YOUR MIND?

Please return radios and bring radios at next fall assembly / 2020 international registration is open at aa.org / letter of support for a play update, we spoke to the executive editor of the international convention and a was approved / I'm scared about where AA is going, also nowadays traditions seem like we using them with a guestion mark, should we do them? / We always had a printed big book with all the stories we need / I just want to thank you all for your support and next month will be lots to report, I've already heard of concerns for us on the finance committee, officers thank you for your support / thank you for the best assembly ever, I attended the multiple workshops and it was really great / fall assembly coming up Nov 02, dinner will take place on Nov 01/ co-chair summer assembly thank you for al your help and the assembly committee / thank you Francisco A. for coming all the way from México / please help with your own garbage, thank you all, you're the result of all we have done this time and district 18 for helping and being a part of this wonderful experience / sorry for being late, I see here that the spirit hasn't change, your spirit coming with me now to help the AA members in Tokyo, we are sponsoring members in Japan they're celebrating their 45 years / Mahalo for everything you do, thank you for letting be me part of this assembly.

10am - Sharing Session Opened with the Serenity Prayer by Coree H. Chair. DCMs, visitors, and GSRs attended. Our meeting is open to everyone to learn and participate on the topics. Please bring radios. Announcements. Marianne announced availability of radios, please return them at the end. Recording secretary announced providing your email to be included on the email list.

Presentation - Reaching Out to Remote Communities by Beth S. from District 06: Beth reminded us of the responsibility declaration and the definition of remote communities, which is marked by difficulty carrying the message because of language, culture, or geography. She discussed the history of remote communities, who has accessibility issues (e.g., physical, mental, emotional, spiritual; religious, ethnic, gender identity, parents/caregivers, and political beliefs), how the traditions tie into the importance of reaching out to remote communities, and how we can better do so today and in the future, emphasizing welcoming those who come into our meetings and encouraging participation. Finally, she shared a list of resources which included AA Literature: AA Guidelines on Accessibility for all Alcoholics (Beth suggested using the accessibilities checklist as a means to take inventory with our homegroups), the Accessibilities Workbook, A.A. for the Alcoholic with Special Needs, a pamphlet available in audio format and A.S.L, Pre-Conference Remote Communities Meeting, the Communicator, and Loners Internationalist Bulletin. Discussion followed. Highlights included:

Some questions to guide us are

- "who is not here and why," "what can we do to welcome them," "what can we do when we're not a part of the remote community," and "what can we do to reach them when they're not in the rooms?"
- A member suggested making an announcement during the meeting and having those raise their hands that are available to speak to the newcomer
- Our responsibility of welcoming the newcomer, and failure to do so, contributes to the lack of diversity in our membership
- A member shared an experience of inadvertent discouraging of newcomer participation and correcting that

- A member shared about not feeling a part of and using that experience as motivation to make others feel welcome
- Many members shared their desire to reach out to remote communities and appreciated the presentation as a means for guidance and motivation to do so
- A member shared how she tries to talk to people she wouldn't normally talk to, suspending her judgments, and focusing on what they need
- A member suggested thinking of the groups in your area that are poorly attended, because those are the meetings that need the message of A.A.
- A member shared difficulty with reaching out to newcomers because they come in late and leave early
- A member shared the value of technology in facilitating access to A.A. for remote communities
- A member shared about a group called "Birds of a Feather" to get an immediate, unscheduled meeting
- A member shared how her group has childcare, wheelchair accessibility, and bilingual members to reduce barriers to access
- A member suggested thinking about involving our districts and GSRs in these discussions.

Discussion of topics for next month: 1) Reaching out to the African American alcoholic, 2) Best practices for communication and service, 3) Difficulties with recovery due to departing from our basic text and too much discussion of opinions, and 4) Homeless newcomers. A member suggested covering the topic over two months to gather feedback from groups and report back. Next Month's Topic: Reaching out to different ethnic groups within A.A. (Vanessa C.)
