#### Alternate Delegate's Corner: May 2023

During this month (April) a members from my home group with one month of sobriety that currently holds the coffee position expressed to us how hard was to share in the meeting, how shy and difficult was to talk to anybody. Few days later we had very small attendance 4-5 of us, one person walked our room and in to his very first AA meeting, he looked lost, confuse and desperate. Our one month coffee maker approached this gentleman and offered him a cup of coffee and a piece of sweet bread, after we read the Bill's Story the few of us shared on the discussion on that chapter, when we were about to close the meeting earlier this guy finally spoke, he share for about 5 minutes the pure message of AA mentioning the word "hope" more than once, making the perfect and necessary connections and phrases encouraging the new guy to come back, between these unperfect alcoholic hearts the meaning of having the solution available made perfect sense.

This is how sobriety becomes possible. Days turn into weeks, new members sparks with a new language, new thoughts, new tools just as early AA members dreamed and saw our their future as our present today in sobriety.

We continue to be a physical part of this magnificent program. These new members continue to be my direct link to the pioneers of AA, the AA Structure and the principals as we see it today since 1935. The Conference process, is the continuing discussions from our earliest members. Should we publish a new book? What are we called? Can women and others join AA? What about Atheists? # CALIFORNIA NORTHERN COASTAL AREA COMMITTEE MEETING MINUTES April 22, 2023

The monthly committee meeting of CNCA was held using a hybrid format on 4/22/23 with some members attending virtually and others attending at the Petaluma Community Center. Chitra S. opened the meeting at 12:30 pm, followed by the Serenity Prayer. The AA Preamble was read by Julie S. from District 06, John K. from District 90 read Tradition Four and Liz from District 10 read Concept Four. We welcomed five new GSRs, and one new DCM, and there were five visitors. There were seven past Delegates present: Teddy B. (P69), Raymundo L. (P65), Bob D. (P36 from Area 8), Jennifer B. (P71), Barbara M. (P41), Diane O. (P35) and Jim M. (P45). The March minutes and the financial report were accepted as published in the CNCA Comments and Comentarios. Attendance: 47 online: 72 in person (119 total). Birthdays: 10/120.

# OFFICER REPORTS DELEGATE - ERIC L.: No report.

ALTERNATE DELEGATE – MIGUEL H.: The delegate arrived in New York for the General Service Conference feeling well-informed by our Area's sharing and electronic submission of group consciences on agenda topics. He will meet with his conference committee on Monday and Tuesday, which will then make recommendations to the entire Conference later in the week. Those recommendations will form the basis of discussion by the entire Conference. After the Conference, he will return and prepare for his report at the Post-Conference Assembly on May 13<sup>th</sup> in San Francisco.

CHAIR – CHITRA S.: At the Pre-Conference Assembly, I watched GSRs choose to put the needs of their group first. I witnessed a collective stepping out of self and caring for the greater whole of AA. I am excited to join all of you at the Post-Conference Assembly to listen to our delegate's experience of what he saw, felt, and heard as he connected our voices with the larger community of AA.

TREASURER – CLAUDIA N.: Our checking account has \$33,176, and our prudent reserve has \$13,001. March's actual contributions were \$9,917, and the budget was \$8,167. March's actual expenses were \$22,939, the budget was \$11,084. We came in over in

Assembly expenses/deposits, rental for the ACM, which increased, and the GSC Contribution of \$5,500.00. Please spread the word about our updated address, as well as online contributions at cnca06.org/contribute

REGISTRAR – DREW B.: GSO has statuses of "active," "inactive," or "unknown" for groups. Those statuses are about GSO's ability to communicate activities with groups. If your group does not have GSR or a contact person- the status of your group becomes inactive or unknown. Registration is the remedy. Over the entire two-day pre-conference assembly, 538 members registered: 352 on Saturday, and 186 on Sunday. There were 237 GSRs, 21 Alternate GSRs, and 48 DCMs. I'm hosting our first district registrar sharing session on May 5°. The group of the month is one I attended in Area 17 Hawaii: The Defective Characters, the home group of the Area 17 delegate.

RECORDING SECRETARY – SARAH B.: I'm grateful for getting to listen and take notes during the preconference assembly. I loved hearing members express their gratitude for being able to participate in the assembly both online and in person and their faith in our delegate to do what's best for AA at the Conference. Our assembly business meeting minutes stand at 6,514 words of love and service. Starting this month, whoever gets closest to guessing the word count without going over will win a prize. Please submit your guess in the week following the ACM with the subject line "word count competition." For reference, the last ACM minutes were 4,601 words.

ASSEMBLY COORDINATOR – JACKIE B.: The actual expenses for the pre-conference assembly exceeded the bid estimate by only \$358; they were anticipated to be over by much more. We are tracking the actual costs of food, paper goods, coffee, and decorations for assemblies to help create more accurate bids and practice more financial prudence. There were 42 responses to the hybrid assembly survey. We will hear bids for 2024 from D14, D17, and D19 in the coming months. The Fall 2024 Election assembly does not have a potential host district yet.

**LITERATURE/GRAPEVINE/LA VIÑA – MATT E.:** This month is the 30° anniversary of the Grapevine book, The Home Group. A special new edition is available

with new stories and a new chapter on virtual meetings. The first few chapters of the Plain Language translation of the Big Book will be available for attendees of the General Service Conference to review, including our delegate. He will not be able to take any pictures or written notes, so he will share his experience of reading the translation. There will also be screenshots of the new Grapevine and La Viña mobile apps and a progress report. Development is still on schedule for those apps to be released in September of this year.

#### DISTRICT REPORTS

**DISTRICT 01 (MONTEREY) – ANETTE C.** - We heard a presentation on Concept Four and played a Kahoot game to test our understanding of the concept. We prepared a bid to host the Fall Assembly. Our Literature/GV chair told us about aagrapevine.org and created a flier for GSRs and Grapevine Reps to present at their meetings. We passed a motion to contribute a Carry the Message gift certificate. Our intergroup is hosting a "Deserts and Dancing" event.

**DISTRICT 02 (SALINAS/SAN BENITO) – BRIAN M:** D02 continues to meet remotely only and encourages greater participation from GSRs. We had an informative experience at the pre-conference assembly and await the report back from the delegate.

DISTRICT 03 (SANTA CRUZ) – DEB A. (RYAN A.): D03 is working on increasing participation in general service with an emphasis on virtual meetings. We discussed having a liaison to the Area Accessibilities Committee and creating a DCM roundtable or sharing session to increase group participation and awareness about contributions not recovering as expected after the COVID drop. Our Treasurer shared a presentation about the spiritual aspect of self-support.

**DISTRICT 04 (SANTA CLARA NORTH) – AMARA G.:**Nearly two-thirds of our GSRs attended the Pre-Conference Assembly either online or in person and everyone participated in gathering and submitting group consciences. Through discussions, a need has arisen to address the topic of safety. A committee has been formed to organize safety workshops.

DISTRICT 40 (SANTA CLARA SOUTH) – KAREN C.: We began a discussion to approve the updated 2023 District Guidelines. This project began in February 2022 with two district members. The DCM from sub-district 004 Spanish overlay will be inviting district members to a

Spanish-speaking meeting for fellowship, dinner, and a speaker, with interpretation.

**DISTRICT 05 (SAN MATEO) – BRENT M.:** We are focusing on planning our Unity Day. We had over 100 people attend in 2022. Less than 20% of groups that have GSRs attend our district meeting. The GSRs have been asked for input on improving participation. The importance of service sponsorship was emphasized during the area officer presentation.

**DISTRICT 06 (SAN FRANCISCO) – DANIEL B.:** We are hosting the Post Conference Assembly Dinner on Friday, May 12. At our business meeting, we elected a DCM for Duboce Triangle, and a proposal was presented to purchase 30 closed-circuit radios like the ones that District 20 uses.

**DISTRICT 07 (ALAMEDA NORTH) – MANISH G:** We had about ten members of our district at the assembly, and several others participated online. In our officers and liaisons meeting, renamed the meeting as an agenda planning meeting and opened it to the entire district. East Bay Intergroup is having a spring picnic.

**DISTRICT 70 (ALAMEDA SOUTH) – TERESA.:** D70 has been meeting in person and voted to go hybrid. We have a new Tech Host position open. We had a presentation on what to expect at the pre-conference assembly and the difference between Area business and Assembly business. A member of the Accessibility Committee from another district is coming to talk about accessibility.

**DISTRICT 08 (CONTRA COSTA) – MEG B.**: We heard reports about group issues and requests for info sharing on topics ranging from handling kids at closed meetings, to what to say to group members not wanting to hear announcements and hybrid meeting struggles. Our CPC officer is bringing CPC back to life. Our special events chair attended the pre-conference wrap-up session at District 20. We are discussing purchasing a WiFi hotspot. We discussed the GSB chair's resignation. The consensus is that we trust the delegates to represent us and can't wait to hear a report back.

DISTRICT 09 (SOLANO SOUTH) - No report

**DISTRICT 90 (SOLANO NORTH) – STEVE B.:** We had a lot of participation at the Pre-Conference Assembly. There have been a lot of emails and text messages regarding the resignations from the General Service

Board, and I am very grateful to see so many people interested and concerned about the future of AA.

**DISTRICT 10 (MARIN) – DYLAN R.:** Al Anon's District 11 Stepped Up Alanon Family Group is hosting a Night of Family Recovery Event at the San Rafael Community Center on 5/13/2023.

DISTRICT 11 (NAPA) – SANDY S.: We continued discussing holding our district business meeting hybrid, including where to meet in person. We had good participation at the Pre-Conference Assembly. Our Unity Day is June 17th at The Crosswalk Church in Napa. PI/CPC will be at the Napa Town Hall meeting concerning Fentanyl abuse. BTG is forming its committee and presenting at local facilities. The Intergroup/District web committee added electronic literature order forms. H&I meetings are returning to Napa State Hospital and the Napa Women's Jail. Juvenile hall meetings will open soon.

**DISTRICT 12 (SONOMA) – DENISE G.:** D12 is trying to increase participation in service. We elected a D12 to D18 liaison position and a DCM. We had good feedback on changes to our business meeting format. We are discussing allowing subcommittee chairs the right to vote and be eligible for officer positions. We are planning our Delegate's BBQ in June in lieu of our regular business meeting and Sonoma Unity Day in October.

**DISTRICT 13 (LAKE) – EDEN N.:** We are coming together as a group and settling into our service roles. We are looking forward to all the events happening in and outside our District, setting the example to the newcomer that we are not a glum lot. We are inspiring hope through service and fellowship.

**DISTRICT 14 (MENDOCINO) – MICHAEL Q:** Our district operates with 3 rotating DCMs. The hybrid meeting in Ukiah was well-attended and for the first time had no online participation. We had a PRAASA report back from a member who received a scholarship to attend and a report back from a GSR who attended her 1st assembly (the pre-conference) and who also made a visit to GSO in New York. We will be bidding to host the 2024 Post-Conference in Willits and elected an assembly chair. Our visiting area officer spoke on service sponsorship.

**DISTRICT 15 (HUMBOLDT/DEL NORTE) – MEGAN M.:** D15 had several new GSRs. Participation at the pre-

conference assembly was good. We are asking for volunteers to give a short presentation on a concept at the beginning of district meetings. We are wondering whether we should remain virtual after six months of looking for a hybrid venue. Humboldt County Intergroup, H&I, and D15 are preparing for our Unity Day on June 10th. All the meetings which closed during Covid have come back to life. Redwood Coast Roundup is coming back.

**DISTRICT 16 (SPANISH CENTRAL) – PEDRO M:** We were happy to see GSRs participating in the preconference assembly. We hope to see you all at the post-conference assembly on May 13<sup>th</sup> in San Francisco.

**DISTRICT 17 (SPANISH SOUTH) – LUIS R.:** We have a new A.A. group in Half Moon Bay, which has a GSR. We continue visiting groups to encourage participation in service. CPC will have a business card presentation and plans to send letters to the Hispanic professional community to inform them about A.A. PI continues to have workshops to be ready for the response of the CPC committee. La Viña is keeping groups informed about the magazine. BTG has a workshop and continues to make presentations in Pathways, Salvation Army, and Casa Vida. We have a coordinator for the Foro Hispano and are still looking for a new treasurer. We will have Unity Day celebrating the 37th anniversary of the district on June 25th.

**DISTRICT 18 (SPANISH NORTH) – RODRIGO Z.:** There was great participation to deliver group consciences. Our study board is having great results. We have more members coming in interested in knowing more about our third legacy of service.

**DISTRICT 19 (SPANISH SOUTH SOUTH) – SARA N.:** We are working to carry the message to our district's 26 groups to tell them that the district is there to serve them, and that service isn't hard, it keeps us busy and in service.

**DISTRICT 20 (SPANISH EAST) – FRANCISCO Z.:** Accessibility had a safety workshop, carrying the message to unrepresented groups. We were aware that people felt uncomfortable with the small space at the preconference assembly, but if the district is given another opportunity to host an assembly, we will find a more suitable location.

#### AREA STANDING & SUB-COMMITTEES, SHARING SESSIONS, AND LIAISON RE-PORTS

**Accessibilities - THOM H.:** The committee will provide input to the Ad Hoc Assembly committee as they update guidelines. D12 is developing a mission statement and a workshop and survey for Accessibilities. D07 is reaching out to D70 to create a common outreach community. D15 is looking for a place to hold a hybrid version for the remote communities in their district, is working with the Hispanic communities to hold Spanish-speaking meetings, and is investigating how to reach out to Native Americans in their district. The Deaf Access Project discovered that the Spanish as first language Deaf and Hard of Hearing community uses either Spanish (SSL) Sign Language or Mexican Sign Language (MSL). We discussed supporting the Hispanic Women's Workshop by providing a forum within Accessibilities.

ARCHIVES – CAROL H.: Our display at the pre-conference assembly generated interest in completing group histories. Please contact me if your district is having an event (e.g., Unity Day, founders' Day) and would like a CNCA display. We discussed our roles and responsibilities during the sharing session. The D14 Archives chair received a tiny card of meetings in North Mendocino Coast in 1989. We have moved our workday in May to the 3rd Saturday, May 20<sup>th</sup> at 193 Mayhew Way, Walnut Creek. All are welcome.

BRIDGING THE GAP – JOHN O.: In April BTG received 92 blue cards, did 13 presentations,

and made seven bridges. Districts are reporting an increase in volunteers; one district has 40 active volunteers. This year's BTG Forum is in D13 Lake County; date, and location to be determined, likely in November.

FINANCE – RUSS A.: The committee reviewed the current financial condition of the area and approved the treasurer's report. We discussed the motions being presented today at the ACM. Most of our discussion addressed concerns regarding the projected increase in costs through the rest of the panel. We accept credit card 7th tradition contributions via Square at the ACM and all future assemblies.

**INTERPRETATION AND TRANSLATION – JOSE**L.: Our committee facilitated interpretation and assisted listening at the pre-conference assembly and ran out of FM radios lent out. A few radios may have damaged jack connections, and we will be discussing how many may need to be replaced. We have about 23 documents and six emails for translation. Remember to bring your FM radios to the post-conference assembly.

PI/CPC - MIGUEL H.: We discussed where AA information/literature tables would be appropriate, such as health fairs. Discussion occurred regarding IRS affirmation (determination) letters, which confirm an organization's non-profit status, often required for reduced rates at facilities and events. The letter is typically available through the intergroup office, and it can be from a fellowship based anywhere in California. We discussed the need to staff the upcoming booth at the

American Psychiatric Association May 20th to 23rd at Moscone Center in SF. Next month we will discuss reformatting contact letters.

TECHNOLOGY – JACQUELINE P.: The Committee wants to know what the Area might need for a workshop on Technology and welcomes ideas. We are trying Discord for communication. We have a laptop to "unlock" for the Archives Committee. The Hybrid Sub-Committee wel-comes comments on our hybrid /live meetings via a survey that our Area Chair sends to DCMCs. We have commitments available for people excited about technological growth in our Area. Please pass the message to your GSRs and Districts.

Website – JAMES B.: There were about 131 group consciences on agenda topics submitted on the web form, with 121 in English and 10 in Spanish. Liz filled the tech person commitment. She will help with keeping Word-Press, plugins, and the host up to date. We are creating a checklist to ensure the repetitive tasks are documented and tracked making sure nothing is missed. We upgraded WordPress 6.1 to 6.2. We welcome feedback on the website on the web form.

ASSEMBLY AD Hoc – ELBA: We are gather-ing information about the expenses, looking at assemblies from the last panel, and have talked about venue accessibility.

AD Hoc Newsletter Distribution – JACQUELINE P.: The Committee is examin-ing how the Comments/Comentarios newslet-ter can move to a digital format and publish-

ing process, assuming Area members who prefer a paper copy of will receive one in the mail. We are examining efficient and simple communications and an easy way for members to "opt-in" for a paper newsletter. We are looking into email servers for distribution. We discussed the possible role of the Technology Committee in the new publishing process to pass on to future Area panels.

CNCA COMMENTS / COMENTARIOS – CHUCK B.: Our assembly team met on for a couple of hours and everything was ready to go by the next day. Just under 500 issues were mailed out. We are working to improve the print quality of the financial reports.

PRAASA 2024 – TEDDY B-W: This month I attended the final wrap-up meeting of the PRAASA 2023 committee and will be sharing some of the key takeaways. The final reports of all the committees are due and I await a curated older to share with you. Budget worksheets for the PRAASA 2024 committees are being submitted. For more information email.

DCM SHARING SESSION – MAUREEN G.: We had a presentation about accessibilities from Thom H. of D11 guided by the 2019 Accessibilities workbook. Four accessibility designations were discussed: deaf and hard of hearing, elder, parents and other caretakers, and underserved and remote communities (including distance, language, culture, and physical barriers).

**LITERATURE/GRAPEVINE/LA VIÑA SHARING SESSION – MATT E.:** We heard a presentation about the process of planning and carry-

ing out a writing workshop. The presenter gave tips on how to structure it, how to get people involved, and the success they had in submitting around 30 stories from members to GV/LV by the end of a single 3-hour workshop. Next month we will have a past non-trustee Director of GV share their experience of service at that level, with Q&A.

H & I - KAREN B.: Our meeting is moving to the 4th Sunday of the month. Our H&I Conference is May 19th-20th at Wyndham Sacramento. Flyer available on our website HandlNorCal.org. and will help future GSRs. // In the meeting there are lots of questions due to a lack of information about service, and in the meeting, those questions were answered. There are a lot of new people this panel coming here wanting to learn. // This separates Spanish-speaking from Englishspeaking members. We have a sharing session for DCMs with interpretation already. // My first time attending the ACM, I didn't know what meeting to go to. This sharing session isn't just for GSRs, it's for anyone from the area. // I see the value we have of the DCM sharing session which has interpretation. All are welcome there. If that was more attractive, that may meet the need. // I learned and shared so much of what I learned after attending this sharing session. When I work with the Spanish-speaking community, they don't have information and are hungry for it. This sharing session gives them the information they are seeking. // I agree with what was said about the difference between going somewhere where you must rely on interpretation and being among people speaking the language. // I'm with the accessibilities committee. I hear a lot of people wanting this to happen. Our district has always had a focus on educating new participants at every level. I don't understand how this should be an area responsibility and expense. The DCM sharing session used to be packed. // This sharing session sounds casual and isn't going to take the place of other sharing sessions. Perhaps Englishspeaking participation could be done later. // The topic of how to get people interested in General Service comes up constantly, and this sharing session is accomplishing that. I would want to do everything possible to get people of any language involved in service. // When English-speaking GSRs come to me and wonder what they're doing, I encourage them to come to the ACM to hear the experience of others, and I think this sharing session is a very wise way to do this for Spanish speakers. // We have seen increased participation from the Spanish-speaking community over the past few years. They should be able to attend either the DCM sharing session or the proposed one to maintain unity. Perhaps in the

future, we could expand to other languages. // It's easier to speak with others in my language. // This meeting has been going on for seven months, but we've been doing it for free. The members will now pass a seventh tradition basket to pay rent. It doesn't interfere with the DCM sharing session. It helps as a filter before you get into the business of the ACM. // In my district we hardly study the concepts or general service positions. This is a good opportunity for people from the Hispanic community to start learning. Our area tries to be inclusive. This sharing session is giving them the opportunity to fall in love with service. // I attended an H&I NCCAA conference. I attended a Hispanic Women's meeting, and it changed the way I look at service. I learn the most when I learn from people that are different from me. I would like the opportunity to attend as an English speaker to learn from you. // I'm in favor of this if it's at a different time from the DCM sharing session. I'd like to go as an English speaker to listen and learn from you. // When I arrived here for the first time, my sponsor had to do his service and he sent me to a different meeting. I was very shy and did not know what to do. I felt bad and I didn't feel a part of it. This is why it's very important that we all welcome each other and learn to communicate in Spanish and English. I love the sharing session because there is a lot of participation. I got to present something from my district, and we are growing. I am in favor of finding a solution for

Discussion: Group consciences: None. // Per-

sonal opinions: The tech committee chair provided the motion's estimated financial impact. Assuming two assemblies per year at more than 175/200 miles of travel (which includes four hotel rooms), the current five members' transportation to ACMs, assemblies, and area events at current reimbursement guidelines (49 cents per mile, bridge tolls, and \$150/night lodging for assembly hotels), the annual cost would be \$8,172. The maximum annual cost if the five members originated from the farthest part of the area would be \$10,297. The committee sought a bid to have our hybrid needs provided by Tech12. For a one-day assembly providing the same services we currently provide, including using some of our equipment, it would cost \$8,100. // I'm concerned about the sustainability of the cost and the lack of job descriptions, it's too broad. I'm concerned that we're setting a precedent by it being reimbursed retroactively. // The committees are new, and we are still working on our draft guidelines. // I was on the tech committee previously. It looks like it's running smoothly now, do we still need the number of people we have in person now? // The hybrid subcommittee looks each month at whether they can do their service with fewer people. This month we have five and we're looking at trying three. We're building the car while trying to drive it. // We have multiple hybrid meetings happening in several rooms at once. If the committees weren't hybrid, we could do it with fewer people. // The assembly coordinator shared current commitments on site: sound/AV person, two people in each of the committee rooms, online host, liaison to the interpreter that listens to interpretation in Zoom, and the person who runs the projector. We would like to have one person in each committee room. We could have a smaller team, but that would decrease quality. // I'm a former area treasurer, and the numbers don't seem higher than they should be. We are shifting how we spend money in the area. We are spending more money on technology because there's a need. We are moving away from mailing the Comments/ Comentarios of about the same amount of money. It puts us into the modern world. // Q: Are the subcommittee members also setting up the equip-

ment? A: Yes. The five members get here early and do a lot of work in the morning. // I'm from a hybrid district. It is very time-consuming and complicated to set up equipment and get things running. I can't imagine the difficulty for the area. // I served on the ad hoc hybrid committee. This same conversation came up for reimbursement and it was approved. This book is 56 stories from the first three editions of the book Alcoholics Anonymous translated into Spanish for the first time. The print version will be available soon. AA Grapevine Inc. and AA World Services have both increased the price of printed books. AA Grapevine Inc.'s increase has been applied to the top ten best-selling Grapevine books (including Language of the Heart and Emotional Sobriety) and will be applied to all other Grapevine books as they are reprinted. AA World Services' price increase goes into effect on April 3rd. The increase will be about 20% for books and about 30% for pamphlets. Since covid, the costs associated with distributing our literature have gone up. The increased costs have resulted in a revenue loss of over \$1.2 million per year.
