The Ad Hoc Newsletter Committee presented two housekeeping motions, which passed, to facilitate the change of our Area Newsletter moving from a primarily paper format to an easily distributable digital format. The paper format of the August Comments/Comentarios will contain a 'postcard' outlining the procedure to opt-in to future paper versions of our Area Newsletter. The default method to receive the newsletter from now on will be digital-ly, and our editing team will use Mailchimp to create and distribute the newsletter beginning next month.

Our Area passed a motion for our I&T Committee to purchase 120 new digital radios to assist with language gaps at our Area Assemblies and ACM's.

I wanted desperately to fit in, and since I didn't know how to talk to people, a service commitment would let me be around people without having to actually talk to people.

I stayed involved in service because it felt good. Sometimes, it was noble. I actually was able to help people, make meaningful connections, become a part of the group. I even got invited to the lunch that all the cool kids went to (well, everyone went to, and I just wanted so desperately to fit in).

Service eventually took on new meaning for me. It shifted gradually from what I could get out of service (connection, a sense of ownership, self-esteem) to what I could put into service. Not to say that I don't still get ego-driven rewards from service. But I at least now try to be more humble about it.

Recently, I've been thinking about service outside of AA. My parents are getting older, and I've noticed that they sometimes need extra help with things. It's honestly a bit terrifying. But I am finally able to be of service to the people who took me in when I destroyed my world and helped me rebuild it by making me go to AA. For so long, I wanted to give back to my parents what they had done for me. And now, through service, I get to.

#### CALIFORNIA NORTHERN COASTAL AREA COMMITTEE MEETING MINUTES July 22, 2023

The monthly committee meeting of CNCA was held using a hybrid format on July 22, 2023, with some members attending virtually and others attending at the Petaluma Community Center. Chitra S. opened the meeting at 12:30 pm with the Serenity Prayer. The AA Preamble was read by Laura from District 11, Manisha G. from District 07 read Tradition Seven, and Vivian K. from District 07 read Concept Seven. We welcomed three new GSRs, and two new DCMs. There were eight past Delegates present: Jennifer B. (P71), Teddy B.W. (P69), David N. (P59, past trustee), Bob D. (P36), Joann L. (P67), Jim M. (P45), Diane O. (P35), and Barbara M. (P41). The June financial report was accepted as published in the CNCA Comments and Comentarios. A correction was made to the June minutes regarding the presentation of new business from the Technology Committee. Attendance: 77 in person; 53 online. Birthdays: 58/5.

### **OFFICER REPORTS**

**DELEGATE – ERIC L.**: I have shared Conference reports at 17 districts; this helps make sure what happened at the Conference is not a mystery to people. I shared information with DCMCs about a non-trustee director vacancy and about inaccurate quarterly contribution statements from GSO that are now being fixed. Beta-testing has launched for the Grapevine App; early reviews are enthusiastic. The first draft of A.A. in Plain Language: A Tool for Accessing the Big Book has been completed. A working group is now reviewing it.

**ALTERNATE DELEGATE – MIGUEL H.:** The General Service Office is looking for new staff members including a French-speaking Canadian residing in either the U.S. or Canada and willing to relocate to New York. Fluency in English and excellent English writing skills are required. This position is responsible for work specific to each of

our 12 service desks, rotating to a new office and assignment every two years. Assignments include Treatment/Accessibilities/Remote Communities, Conference, Cooperation with the Professional Community, Corrections, Group Services, International, International Convention, Literature, Nominating, Public Information, Regional Forums, and Staff Coordinator. Candidates should have at least six years of continuous sobriety, strong writing and communication skills, and a good understanding of our service structure to be a "special worker." Contact me for information on duties and responsibilities.

**CHAIR – CHITRA S.:** In the book Our Great Responsibility (pg. 162), Bill W. speaks of the requisites of leadership, including love, understanding, forgiveness, and communication of the heart. The Summer Assembly is an opportunity to practice developing our voices on issues related to our primary purpose. It is our responsibility to participate thoughtfully in discussions. How does your group feel about creating literature that would combine the Twelve Steps and Twelve Traditions with the Twelve Concepts for World Service? Bring your group consciences to the Assembly for the morning business meeting.

**TREASURER – CLAUDIA N.:** Our checking account has \$31,063.64, and our prudent reserve (one month's operating expenses) has \$13,001.40. At the end of June, our actual contributions were \$6,716, and our budgeted contributions were \$11,167.09. Actual expenses were \$8,461.33; the budget was \$8,492.69. Our budgeted expenses were right on, but our budgeted income was more than what came in in contributions. Almost every month this year our actual income was greater than what was budgeted, so all is well! Please thank your groups for their contributions. Please spread the word about our updated address and online contributions at cnca06.org/contribute/. Our old P.O. Box will close on November 30<sup>th</sup>. We will gradually be replacing paper receipts with emailed receipts, with a complete phase-out by December 1<sup>st</sup>.

**REGISTRAR – DREW B.:** With two new district registrars starting this last month, (welcome Jan from D13 and Patty from D04) every district has a registrar. GSO has asked me to assist in an initiative to update "unknown" groups in the Area. It's called the "Data Integrity" project, and I will be working closely with our district registers and the Member Services Team at GSO to ensure we are efficient and accurate with updates. This month's meeting of the month is Dolphin Quest, which meets Thursday nights at 8 in Oakland.

**RECORDING SECRETARY – SARAH B.:** I continue exploring the Area motions book for history about our assemblies. The first summer assembly of record was in 1966. The first motion passed that was introduced at a summer assembly (in 1989) was to write GSO a letter asking that a topic regarding charging fees at AA events be added to the national agenda. More trivia at the summer assembly. I'm accepting guesses for the summer assembly word count competition. The 2022 summer assembly minutes were 6,646 words. The agenda had two items of old business that were both acted upon. You may submit your guess by email or by coming to talk to me.

ASSEMBLY COORDINATOR – JACKIE B.: I've attended planning meetings for the upcoming summer assembly (in Eureka, hosted by D15 Humboldt Del Norte) and assisted prospective bidding districts on site selection for the 2024 Summer and Fall Assemblies. The venue database I've compiled has been helpful in site selection and will save bidding districts time. Feedback from the venue survey has been added to the notes section of the database. Volunteers are needed to expand the listings; please email me if you are available to be of service. Pass-it-On assembly reports have been helpful, and I hope assembly committees continue to create and share them.

**LITERATURE/GRAPEVINE/LA VIÑA – MATT E.:** New printings of the Soft Cover Big Book (in all formats) will have a new "soft velvet touch" finish. This is a common cover finish in the publishing industry and eliminates the need for ordering highcost, low-availability materials. The deadline for applying to join the working group on the updated pamphlet "A.A. for the Native North American Alcoholic" is July 31<sup>s</sup>. I'm excited to hear about the experiences of La Viña reps that attended the La Viña Anniversary in Oregon. Grapevine and La Viña are always seeking to hear from you. #### DISTRICT REPORTS

**DISTRICT 01 (MONTEREY) – ELENA B.:** District 01 is thrilled to announce we have a DCM! BTG continues to open meetings in facilities. MBAR had a very successful fundraiser as they continue to plan for 2024. A GSR created a flier inspired by the Delegate's report to inform and encourage group treasurers to contribute digitally.

DISTRICT 02 (SALINAS/SAN BENITO) - BRIAN M .:

We look forward to our Delegate report on August 2nd. We have discussed Area motions and are looking forward to the Summer Assembly. Salinas Valley Area Intergroup is hosting the Coastal Rally August 18-20. There will be meetings, BBQs, ice cream, brunch, and fellowship.

**DISTRICT 03 (SANTA CRUZ) – DEB A.:** We welcomed six new GSRs. Intergroup added a donation link to their webpage that includes District, Area, and GSO. We are entertaining the possibility of hosting an Area Assembly. We heard ideas for a Unity Day to include all service arms within Santa Cruz (i.e., CRUZYPAA and the Joint Committee on Safety). GSRs were encouraged to ask their groups about other ideas.

**DISTRICT 04 (SANTA CLARA NORTH) – AMARA** *G.*: Santa Clara Intergroup organized Unity Day for 8/6. We created a website (district05cnca.org), thanks to the examples set by D06, 07, and 08. One helpful feature is the entire discussion around District and Area motions. Working groups have formed to organize Safety Workshops to continue conversations and create more guidelines for groups to address safety issues.

DISTRICT 40 (SANTA CLARA SOUTH) - KAREN

**C.:** Our district business meeting heard the delegate's report. We have representatives from BTG, PICPC, and SCCYPAA now in regular attendance. Our Unity Day is coming soon with a great slate of activities, speakers (Father Tom), delegate report, food, and fellowship.

**DISTRICT 05 (SAN MATEO) – BRENT M.:** We held our annual Unity Day. The event included presentations about the importance of service, sobriety BINGO, a report by the delegate, and a presentation by our Area archives who also provided an awesome display at the event. It inspired a volunteer to consider filling our District archives chair position. We discussed the plain language translation of the Big Book at our business meeting. PI-CPC worked with Districts 04, 40, and 17 at a Veterans Stand Down event in Santa Clara County.

**DISTRICT 06 (SAN FRANCISCO) – DAN B.:** Our visiting area officer (VAO) facilitated elections. We elected a DCM for Subdistrict 245: Alamo Square/ Hayes Valley and a new BTG Chair. We passed the proposal to purchase 30 closed-circuit radios to facilitate communication with our Spanish-speaking districts. In breakout sessions, GSRs discussed presenting our Delegate's "Top 10 Takeaways from the General Service Conference" to their groups. I visited a new meeting for the transgender alcoholic at the SF Castro Country Club called "Tea4T." They elected their first GSR and were happy to hear that discussions are happening in our Area about paths forward for a pamphlet for the transgender alcoholic.

**DISTRICT 07 (ALAMEDA NORTH) – MANISHA G.:** We trialed a hybrid meeting format with about 10 people in person at Sacred Heart Church in Oakland. We will continue this format in the July meeting and vote on whether to continue hybrid. Our VAO presented "GSR Tips on Distilling Information to prepare for reports to their group & the importance of service sponsorship." Teddy B.W. presented on the Grapevine app, fostering discussion. We voted to jointly place a bid to host an assembly in 2024. Our district now uses LinkTree with a special section called GSR Corner. We now also can collect group contributions through Venmo.

**DISTRICT 70 (ALAMEDA SOUTH) – THERESA M..:** We had our Delegate Night and Potluck in June, with approximately 60 people in attendance. We have elected a new Tech Host to take over our hybrid District meeting format. We have been doing a hybrid meeting since February and we are still learning and improving it.

DISTRICT 08 (CONTRA COSTA) - MEG B: Our district discussed how we communicate. We introduced "linktree" for easy access to our agenda. reports, website link, 7th tradition, GSR resources, area resources, and events. We discussed what to add to our website and how to implement anonymity. We discussed the ACM motion regarding a Spanish sharing session. Some explanation was needed to help GSRs understand the function of the ACM. We also talked about the summer assembly and the GSR job description. We looked at our sub-district map and reviewed the benefits of having a DCM. We will hold an election for a DCM in August. Our mid-month officer check-in resulted in a plan to touch base with all groups in our county to strengthen ties to general service.

**DISTRICT 09 (SOLANO SOUTH) – DONNA F:** No report.

**DISTRICT 90 (SOLANO NORTH) – STEVEN L.:** Our Unity Day is July 29<sup>th</sup> in Fairfield. We'll hear our Delegate's report and enjoy some ice cream and a skit called dysfunctional jeopardy. Our archives chair Tony W. converted a cassette recording made on November 10, 1985, of the Public Information Committee being interviewed on Vacaville radio station KUIC, into a YouTube video. We have a controversial topic within our District that we're seeking experience, strength, and hope on.

**DISTRICT 10 (MARIN) – DYLAN R.:** One of our two DCMs held a subdistrict meeting to explain the inverted triangle and flow of information. Our

Unity Day will be on October 21<sup>st</sup> in Novato, and our events coordinator is reaching out to groups to get involved. We added more volunteers to our BTG committee, and our tech committee has accepted two new members. Our Intergroup held a fun event and will be hosting a sober dance.

**DISTRICT 11 (NAPA)** – **SANDY S.:** We have open officer positions we are attempting to fill. Our DCMs hold a GSR school prior to our business meeting. Thank you to our VAO for presenting about hybrid meetings. Our intergroup hosted a Summer Picnic and has voted to fund a Meditation/11-step workshop. The Intergroup/District Web committee is working on a printable meeting schedule from the website. H&I is taking meetings into Napa State Hospital and the Napa Women's Jail; they hope to visit the juvenile hall soon.

**DISTRICT 12 (SONOMA) – DENISE G.:** We have open positions to fill. Our VAO discussed building enthusiasm in General Service. We are planning our Unity Day for October 14, 2023. It's an all-day event that includes, breakfast, lunch, speaker panels, a speaker meeting, sobriety countdown, a skit performed by SOCYPAA, and more. All are invited. The theme is "Planting Seeds of Change." Our Sonoma County bookstore has recently been remodeled and they now accept online orders. They are discussing a motion to sell non-conferenceapproved literature. Our District archivist will be redoing the display at the bookstore.

**DISTRICT 13 (LAKE) – HECTOR M.:** We approved several scholarships for members to attend the Summer Assembly. We hosted a successful Spring Fun event and plan to make it a yearly event, with participation from a local recovery center. We are planning to host the very first sponsor/sponsorship workshop. Date to come soon.

DISTRICT 14 (MENDOCINO) - MICHAEL Q.: Our 3

DCM rotation seems to be working well. Our recording secretary and coastal intergroup liaison positions are being manned by temporary volunteers. We have a GSR serving as H&I Liaison on a trial basis. MENDYPAA is very active, and our PI/ CPC committee is picking up steam. Our VAO outlined the assembly motion from our district and elaborated on the workshop topics. Next month, in Willits, will be our delegate report and ice cream social.

**DISTRICT 15 (HUMBOLDT/DEL NORTE) – MEGAN** *M.*: D15 has located a facility to hold our monthly meetings. We can rent their equipment to allow for a hybrid meeting for \$10 a meeting. Our first hybrid meeting is on the second Saturday of October at 10 am. In our July meeting, a member introduced a motion that suggests making virtual access a requirement of all CNCA 06 Area and Assembly meetings. We look forward to the Summer Assembly and are encouraging our Humboldt & Del Norte County AA members to attend.

**DISTRICT 16 (SPANISH CENTRAL) – PEDRO M.:** We continue to motivate groups and have a new GSR. On Sunday, July 30<sup>th</sup> we will celebrate our 35<sup>th</sup> anniversary and hear the Delegate's report. Everyone is invited. It will be at Grupo Central in San Francisco, 4260 Mission Street.

**DISTRICT 17 (SPANISH SOUTH) – LUIS R.:** Subdistricts are visiting groups without GSRs to motivate one and La Viña is motivating groups to subscribe members and to send their stories. BTG and PI continue their same activities. CPC and PI will work together in the Half Moon Bay area to inform about AA and mention the Hispanic grupo in the area. We have a volunteer who will interpret at the district when needed for the interpretation committee until we find a coordinator. We have a new GSR from the la Salida group from San Mateo County, the first from this group since it opened its

doors about 5 years ago. We have a big event August 25<sup>m</sup>-27<sup>m</sup> hosted by Santa Clara and San Mateo counties. It's free and all are welcome.

**DISTRICT 18 (SPANISH NORTH) – RODRIGO Z.:** D18 continues to work with the groups, sharing information on what is happening in A.A. We have brought the results of the 2023 GSC and had the delegate share his conference report. We are planning our 30th anniversary. We invite everyone to come to celebrate 30 years of service.

**DISTRICT 19 (SPANISH SOUTH SOUTH) – SARA** *N.:* Thanks to the visitor who told us about the summer assembly. Many of us were motivated to join. We are still working on our agenda and motivating more trusted servants of the 26 groups that we are to join general service.

**DISTRICT 20 (SPANISH EAST) – FRANCISCO Z.:** We are preparing for the Hispanic Interdistrict meeting on August 27 from 9:00 to 3:00 at 405 E. 10<sup>th</sup> Street in Pittsburg. There will be panels from members of Districts 16, 17, 18, 19, and 20 and from four of our Area Officers.

AREA STANDING & SUB-COMMITTEES, SHARING SESSIONS, AND LIAISON REPORTS ACCESSIBILITIES – ENRIQUE.: The committee discussed ways to improve accessibility, inclusivity, and community outreach within A.A. The key areas of focus included providing large print service manuals, inventorying electronic devices for distribution, addressing attendance issues due to COVID restrictions, outreach to the Hispanic women community, budget considerations, and the creation of a Spanish Sign Language Big Book. Plans for a skit presentation at PRAASA 2024 and the possibility of providing childcare at Area assemblies were also discussed.

**ARCHIVES – CAROL H.:** A few members expressed their concerns that we have no Hispanic representation. We miss them at our meeting. We brought an archives display to the D05 Unity Day. Let us know if you would like a display for your

Unity Day. We drew a name (David H. from D03) and an alternate (Elvia P.) to attend the National AA Archives Workshop in Sudbury, Ontario Canada, September 7 - 10. Our next workday is August 19. All are welcome.

**BRIDGING THE GAP – JOHN O.:** We've been working to secure the location for the Bridging the Gap Forum in Clear Lake. We have two new BTG chairs, Sacha from D06 and Ashley from D12, and one new volunteer. There may be opportunities to expand BTG Services by networking with other agencies such as social services counselors. We are looking closely at the budget to determine the financial impact. Blue cards: 39; many were distributed within the area, 13 went to CNIA 07, and 2 were sent to Los Angeles area 05. Six presentations were given.

**FINANCE – DAVID N.:** We discussed the 2024 CNCA budget. Thank you CNCA standing and sub -committees for preparing committee budgets. Please submit any remaining budgets by the Summer Assembly. Reach out to your Finance Committee (FC) liaison with questions. We will develop the budget by the end of August to review the first full draft at our September meeting. The budget will be presented to the ACM in November for disapproval if any at the December ACM. We plan to hold a hybrid Finance Workshop on Sunday, October 8 provided by District 20. More to come, including a housekeeping motion for small costs to support the workshop.

**INTERPRETATION AND TRANSLATION – JOSE L.:** We translated about 24 documents, a couple of emails, the Comments, and Comentarios this month. We will purchase 100 radios, two cases, four chargers, and a power strip if our motion passes. We discussed our 2024 budget and set up volunteers for ICYPAA September 1<sup>st</sup>-4<sup>m</sup>. We are building a second bigger interpretation booth for the sharing session room. Please bring your FM radios to the Summer Assembly.

PI/CPC – MIGUEL H.: Elisabeth from D11 gave a

presentation on "How to break the steps to the public and to the professionals." Some main points were that we don't keep track of members, we are not religious, we don't share what we hear in meetings, and we don't give opinions regarding medications. Did you know that 50% of people who die from alcoholism never heard of AA? We have lots of work to do. We will hold a PI/CPC Workshop on September 16, 2023, from 2:00 pm-5:00 pm in Los Altos.

**TECHNOLOGY – JACQUELINE P.:** We continue to develop our guidelines and job responsibilities both for the Tech Committee and the Hybrid Sub-Committee. Our committee has entered the budget process. We sent out a brief Technology Assessment to Officers and Committee Chairs to discover if any new software or hardware is needed. The Hybrid Subcommittee will be testing out a bidirectional camera and a new microphone for the ACM and Assemblies. Come visit us at our table at the Summer Assembly and let us know about technology in your District. Do you think a Technology Sharing Session at the Area Committee Meeting would be helpful to you and your District? Please email me your thoughts. We would love to have more members join us on the Tech Committee.

WEBSITE - JAMES B ..: We meet on Zoom on the 3<sup>rd</sup> Wednesday of the month at 5:15 pm. All are welcome. We have open positions on the committee and would love to have you join. LITERATURE/GRAPEVINE/LA VIÑA SHARING SESSION – MATT E.: Today we discussed possible paths forward for a proposed pamphlet "AA for the Transgender Alcoholic," which was declined to be put on the Conference agenda in 2021 and 2022 after our Area's request. It included ideas like having our Area produce it, having a local intergroup (or intergroups) produce it, having content produced rather than strictly literature, and not limiting ourselves to a single path forward. A member shared that the Conference has acted in surprising ways in the past and therefore another request may be warranted.
