CALIFORNIA NORTHERN COASTAL AREA 06 (CNCA 06)
AREA COMMITTEE MEETING MINUTES
04/26/25

The monthly Area Committee Meeting (ACM) was held using a hybrid format on April 26,

2025 with virtual attendees on Zoom and in-person attendees at the Petaluma Community

Center. Drew B. opened the meeting at 12:30 pm, followed by the Serenity Prayer. The

A.A. Preamble was read by Mike O. (District 90). Francisco A. (Panel 55 Delegate) read

Tradition 4 in Spanish and Star A. read Concept 4 in English. We welcomed 4 new GSRs.

There were 6 past Delegates present: Diane O. (Panel 35), Bob D. (Panel 36 Area 28).

Francisco A. (Panel 55), Joann L. (Panel 67) and Eric L. (Panel 73). The March minutes

and financial report were accepted as published in the *CNCA Comments* and *Comentarios*. Birthdays: 137/8. Attendance: 132 (44 online and 88 in-person).

#### OFFICER REPORTS

**DELEGATE - CHITRA S.:** See Alternate Delegate's report.

**ALTERNATE DELEGATE – CLAUDIA N.:** Our Delegate Chitra arrived safely in New

York yesterday. The General Service Conference officially starts tomorrow. The Conference will hold its Inventory this year, and Bob W., General Manager, will be part of

Chitra's inventory working group. Chitra also serves on the Conference PI Committee.

which will meet on Monday and Tuesday to discuss the PI agenda topics, with full Conference discussions later in the week. Elections for two Regional Trustees and the

Trustee-at-Large/U.S. will take place on Wednesday. Our Area nominated Jennifer as our

choice for the Trustee-at-Large/U.S. Chitra will give her Delegate Report to our Area at

the Post-Conference Assembly on May 17 in San Francisco, where we will learn Conference results, including Advisory Actions and Committee Considerations. The International Convention is less than 70 days away—room blocks are regularly updated.

Misha from GSO shared PI updates on the "Our Primary Purpose" podcast, Young People

in A.A. videos, and initiatives to add A.A. literature to local and e-book library collections.

**CHAIR – DREW B.:** I like to break the general service year into thirds. The first third focuses on the General Service Conference and agenda topics. The second third is about

brainstorming for the future, leading to the Summer Assembly. The final third focuses on

local health, marked by the Fall Inventory Assembly. The cap to the first third will be our

Post-Conference Assembly in San Francisco, three weeks from today. Minutes and background materials will go out next week for the three items of new business. Our Delegate is in New York, preparing to deliver our group consciences during the Conference.

**TREASURER – DAN B.:** March was a weak month for contributions. We received \$8,200,

while expenses were relatively normal to low at \$11,700. As of March 31, we are within

\$6,000 of our Revenue target and \$400 under our Expense target—both very close to

plan. Financially, we're doing well, with approximately \$37,000 in our checking account

today, though that number will decrease with upcoming expenses. Thank you to District03 for a wonderful Pre-Conference Assembly! The website crash during the Pre-

Conference Assembly served as a reminder of Step One. Yet we pivoted, as always. After

passing around the Venmo code, we collected \$4,500, which is \$2,000 more than planned.

We're now exploring Venmo for Nonprofits. For now, contributions can be sent via

personal Venmo account. Please encourage groups to contribute electronically at cnca06.org/contribute; checks take longer to process and are more costly. Thank you for

supporting our Area's work.

## **ASSEMBLY COORDINATOR – MATT E.:** The Pre-Conference Assembly was wonderful.

Thank you, Districts 03 and 19! The Post-Conference Assembly is on May 17 in San Francisco. Please carpool. Talk to me about hosting an assembly in your district!

**REGISTRAR – SARAH B.:** This month, I began the major task of cleaning up our records

by reaching out to position holders to confirm if they're still serving and updating their information. It's given me a deeper appreciation for everyone who has worked to maintain

our records. I also started sending confirmation emails to position holders after they registered. Mail merge technology has helped with both tasks, enabling me to send personalized messages that include group names and positions easily.

**RECORDING SECRETARY – JACKIE B.:** The Pre-Conference Assembly business meeting minutes will be included in the May *Comments/Comentarios*. DCMCs and Committee Chairs will receive the updated motions background document next week from

our Chair. A Recording Secretary Workshop will be held online on Thursday, June 5.

beginning at 6:45 p.m. with a "Minutes 101" orientation, followed by presentations on "AI

Tools for Minutes" and "Anonymity and Electronic Distribution and Storage". A piece of

history: our first Delegate, Nick N. of Berkeley, was elected in 1950 and served as the

Panel 1 Delegate.

## **LITERATURE/GRAPEVINE/LA VIÑA – JOSE L.:** GSO continues to collect feedback on

how A.A. members use literature to carry the message. Ongoing projects include work on

the Fifth Edition of the Big Book, with expanded content on the medical and religious views of A.A. currently in development. The Fourth Edition of *Alcohólicos Anónimos* is

progressing, with the working group refining translations and selecting new personal stories. Multiple pamphlets, including *A.A. for the Native North American* and *Do You Think You're Different?*, are being updated with new stories, artwork, and translations.

The Twelve Steps and Twelve Traditions Illustrated video animation is now available in

French and Spanish, with the English version under review. Limited books from A.A.W.S.

are available online for free as a PDF. A.A. still relies on literature sales to support 12-

step services worldwide, and purchasing literature supports both international and local

service entities. To request printed Grapevine materials, contact gvrc@aagrapevine.org.

#### DISTRICT REPORTS

**DISTRICT 01 (MONTEREY) – ELENA B.:** On May 20, we'll host a pizza party with our

Delegate to hear her Conference report—everyone is invited for food, fellowship, and discussion. Hosted by our Intergroup, Unity Day will be on June 8 at Toro Park in Salinas.

Our GSRs will staff a General Service Welcoming table to provide literature and resourcesto newcomers. We are still unable to access district funds due to bank issues and are

exploring other options.

## **DISTRICT 02 (SALINAS/SAN BENITO) - JUAN T.:** We had strong representation from

District 02 at the Assembly, with five members attending in person and four joining via

Zoom. We're eagerly anticipating our Delegate's return from the Conference and look forward to hearing her report.

**DISTRICT 03 (SANTA CRUZ) – RYAN A.:** Thanks to everyone who attended, volunteered, and traveled to Santa Cruz for the Pre-Conference—hosting was an amazing experience. We're planning our Unity Day event on Sunday, June 1. Our BTG

Committee had three successful bridges and signed up nine future bridges exiting treatment. We are discussing the creation of a district website. The Joint Committee on

Safety is encouraging groups to send a Safety Liaison. Intergroup is launching an Accessibilities Committee.

**DISTRICT 04 (SANTA CLARA NORTH) – JON R.:** We had thoughtful sharing from trusted servants about their experiences representing their groups at the Pre-Conference

Assembly. We heard a presentation on the General Service app, and a few district members signed up as beta testers for Android. Our visiting Area Officer reminded us

that service work continues past the Pre-Conference. We've started discussing the assembly motions. Our Safety Committee is seeking a member with writing skills — contact the Safety Chair or visit district04cnca.org.

## **DISTRICT 40 (SANTA CLARA SOUTH) - PAM S.:** Members shared about facilitating

group consciences, understanding Agenda Topics, and provided suggestions for improvements. The Visiting Area Officer spoke to us about attending the Post-Conference Assembly and how to share the Delegate's report with our groups. New translation equipment has improved communication. Thanks to our treasurer for providing coffee service, to our literature coordinator for informing us about Grapevine

and La Viña, and to our PI/CPC and SCCYPAA liaisons for keeping us connected.

## **DISTRICT 05 (SAN MATEO) – JONATHAN L.:** We approved a motion to provide up to

\$1,000 in reimbursement for active General Service members wishing to virtually attend

the main session of the 2025 A.A. International Convention. Our Alternate DCMC and I

are working with District 06 to prepare for hosting the Post-Conference Assembly on May

17. Our visiting Area Officer shared insights on what GSRs can expect after the General

Service Conference, how to prepare for hosting an Assembly, and the importance of service. We are actively seeking volunteers from both districts for the Assembly.

**DISTRICT 06 (SAN FRANCISCO) – DAVID S.:** We filled three vacant positions. A visiting officer from Area 02 (Alaska) presented on PRAASA and shared how the strong

presence of California Spanish speakers inspired them to explore starting Spanishspeaking meetings in Alaska. After six months of discussion, we approved new travel reimbursement guidelines, which now cover rental cars for those who do not own one.

Our Accessibilities Committee passed three motions, including one to reconsiderresubmitting the Agenda Topic for a graphic novel version of the Big Book. We also decided to start an Interdistrict event and will invite our neighboring districts to join.

## **DISTRICT 07 (ALAMEDA NORTH) – BRIDGET L.**: District 07 still has two open service

positions: DCM of Subdistrict 04 and Accessibility Committee Chair. We will continue to

ask for availability. Our visiting Area Officer spoke on what's next after the Pre-Conference Assembly, as requested by GSRs at our officers' meeting. We had a lively

discussion about working with District 20 on an assembly this panel—more will be revealed. Our BTG representative sincerely requests more volunteers. The BTG meeting

for Districts 07 and 70 is the 2nd Monday of each month at 7:00 p.m. online.

## **DISTRICT 70 (ALAMEDA SOUTH) – CHASE C.:** Our District page in the General Service

app is up and running. Our online Third Legacy Workshop is hosting a 12-week Concepts

Study, facilitated by past Delegate Bob D., starting Wednesday, April 30, at 6:00 p.m. Our

District has 85 groups registered with the Area, and 39 of those groups have registered

GSRs. However, our district meeting attendance doesn't reflect those numbers – we will

investigate this further.

**DISTRICT 08 (CONTRA COSTA) – CHUCK B.:** We are grateful to our visiting area

officer, who spoke about their position and shared how A.A. principles combined with past

service can prepare us for our next position. A DCM presented an item of new business

to improve member safety when sharing information during GSO registration. Our PRAASA scholarship winner gave a report-back on her experience in Alaska.

**DISTRICT 09 (SOLANO SOUTH) – BILLIE JO C.:** The Pre-Conference was my first assembly. Two GSRs attended with me. The experience has made this commitment more

personal and meaningful to me. We are discussing our next workshop and where to hold

it. We shared the Media Blitz page with groups in our district, and many were surprised

to learn that AAWS had a YouTube channel and that a wealth of information is available

online. We will continue sharing this information with our groups.

**DISTRICT 90 (SOLANO NORTH) – DEBRA M.:** District 90 showed up at the Pre-Conference Assembly in significant numbers. We are planning our summer picnic and

the Delegate's Report/Ice Cream Social on June 7.

**DISTRICT 10 (MARIN) – FRANK T.:** Our April District meeting featured roundtable brainstorming on the Marin GSR survey results, focusing on improving group service participation and expanding groups through our primary purpose. We discussed and rated

Big Book page XIX (Traditions in abbreviated form), shared Pre-Conference experiences,

and explored how to conduct a group inventory. Volunteers will present on the "A.A. Group" pamphlet next month. We had a safety presentation; afterwards, our GSRs expressed interest in hosting a District safety workshop. We also welcomed new MCYPAA leadership, and a trusted servant touched on PICPC service.

**DISTRICT 11 (NAPA) – DUNCAN L.:** We discussed and reworded a Napa group's motion to revert a passage in the Plain Language Big Book to better appeal to atheist andagnostic members of A.A. We had a great showing in Santa Cruz for the Pre-Conference Assembly, with several officers and GSRs sharing their group consciences at the microphone for the first time and showing support to our hometown Delegate as she

heads to New York.

**DISTRICT 12 (SONOMA) – MAUREEN G.:** At our officers' meeting, we discussed how

to distribute the work and decision-making for implementing the General Service App. We

plan to bring a housekeeping motion to establish the app as a free tool for D12 service

members. An ad hoc committee will be formed to design the workflow and recommend

service positions to maintain the information. We aim to engage thoughtfully and foster a

spirit of sharing. We're also discussing support for GSRs in sub-districts without DCMs

and would like to hear from the experiences of other districts. Our Delegate's BBQ will be

June 2, replacing the District meeting.

## **DISTRICT 13 (LAKE) – CHRIS W.:** GSRs shared group consciences with our Delegate

at the Assembly. BTG remains ready to assist those exiting their confines. H&I visits the

men's and women's jails and brings meetings to three recovery programs in our district.

64 A.A. meetings are on schedule each week in Lake County, including two Fire Camp meetings.

**DISTRICT 14 (MENDOCINO) – ALEX P.:** Unfortunately, District 14 had a scheduling conflict that we were unable to resolve, so there is no report to share this month.

## **DISTRICT 15 (HUMBOLDT/DEL NORTE) – JANINE L.:** We had a good turnout at the

Pre-Conference Assembly, with new GSRs sharing their group consciences and longtime

members offering valuable service wisdom. Our district is continuing to recruit GSRs, and

we have recently filled a vacant DCM spot, although we have lost our Bridging the Gap

Chair. Our Accessibilities Chair is sending out the Accessibilities Checklist for groups to

review. Our PI/CPC Committee is slowly restarting after being inactive since the pandemic. Overall, the district is excited about General Service!

## **DISTRICT 16 (SPANISH CENTRAL) – ROSALBA P.:** We attended the Pre-Conference

Assembly and submitted our group consciences. Our community is excited to hear the

responses at the Post-Conference. We continue visiting groups to encourage participation in General Service. District 16 has formed a subcommittee for the 6th Hispanic Forum. We successfully held our first Interdistrict meeting with the five Spanish-

speaking districts and District 06. District 16 will host the Post-Conference dinner on May

16 at St. Gregory's Saroyan Hall. Tickets are \$35. We still have vacant service positions.

## **DISTRICT 17 (SPANISH SOUTH)—ERIC R.:** We visit groups without GSRs to help them

with agenda topics. We attended the Assembly and participated in the Interdistrict meeting. We also joined District 19's planning meeting for the 6th Hispanic Forum. We

have set a date for our anniversary and are grateful to our visiting area officer for their

support.

**DISTRICT 18 (SPANISH NORTH) – ALMA L.:** Our GSRs were present at the Pre-Conference Assembly and enjoyed giving their first group consciences. We continue to

learn at our Service Manual study meeting, held every first Wednesday of the month. We

gathered a district conscience on the Assembly motions, and some GSRs have started

discussing them with their groups. A visiting officer spoke about the four assemblies and

their importance. We approved holding a safety workshop. We continue visiting groups,

especially encouraging those without GSRs, and are preparing to co-host the Fall Inventory Assembly with District 11.

## **DISTRICT 19 (SPANISH SOUTH SOUTH)—ADAN M.:** Our Visiting Area Officer made a

big impact. Our district was pleased to participate in the agenda topics at the Pre-Conference, and GSRs realized the importance of being involved in General Service activities. We have set a date for our District anniversary and are organizing the Hispanic

Forum in Seaside, CA.

## **DISTRICT 20 (SPANISH EAST) - MISAIEL M.:** We learned a lot about the Conference

from our visiting area officer. We shared reports about the Pre-Conference, and GSRs

are interested in attending the next one. Each Wednesday, we visit groups to teach about

General Service, encourage the Seventh Tradition, and promote committee activity. Groups are scheduling La Viña and Safety workshops. Our Hispanic Forum subcommittee is active with regular planning meetings.

## AREA STANDING & SUB-COMMITTEES, SHARING SESSIONS, AND LIAISON REPORTS

**ACCESSIBILITIES—ENRIQUE E.:** Today, we heard reports of districts bringing the Plain

Language Big Book to local libraries and updating accessibilities information with their

intergroup offices. This was followed by a presentation and discussion on how childcare

and child-friendly meetings help make A.A. accessible to alcoholics with children. The

Accessibilities Committee offers safety workshops for districts and groups using GSO

material. If interested, please contact me. Please share the Accessibilities Checklist (SMF-208).

## **ARCHIVES – ELVIA P.:** The District Archives Representatives have been busy collecting

group histories. At our workday, we've been sorting through the past Delegates boxes to

prepare for digitization. Currently, we're working on Diane O.'s box, creating three piles:

keep, maybe keep, and shred. We invite one or two past Delegates to help us review what's important to preserve. Fun fact: In 1988, our Area Archives acquired a high-speed

dubber to convert reel-to-reel tapes to cassette. In 1989, we received 300 tapes, and now

we're working on digitizing them all!

## **BRIDGING THE GAP – LYNN K.:** District BTG Chairs reported 50 presentations, 104

Requests for Contact (blue cards), 19 new volunteers (yellow cards), and 15 completed

Bridges! We still do not have District Chairs for Districts 02, 09, 13, and 15. Four out of

the five Spanish districts still need BTG Chairs. We are looking for a Spanish Liaison. In

the meantime, our Recording Secretary speaks Spanish and is willing to assist the Spanish Districts. We elected a Literature Coordinator.

**COMMENTS/COMMENTARIOS - BLAKE L.:** I would like to thank all those who contributed to the newsletter. Special thanks to our Area Officers for their support and to

the translators for their service.

**FINANCE – JEFF D.:** The Treasury report was reviewed and verified. Net revenue was

slightly up, with expenditures slightly down. Expenses are expected to rise next month

due to the General Service Conference and other events but remain within budget. We

will meet the Area-authorized \$3,500 for delegate expenses, but based on actual numbers, the Finance Committee recommends increasing it to \$5,000. A committee budget worksheet is being finalized, and chairs are asked to begin reviewing 2026 expenses. Venmo was a success at the Pre-Conference, and its continued use for contributions is being explored.

## **I&T (INTERPRETATION AND TRANSLATION) - LUIS R.**: We discussed the need for

more radios to meet demand at Area meetings. We worked with an average of 10 documents and delivered translations as quickly as possible. If any committee requires

interpretation or translation, please notify us. We are getting ready for the Delegate's Report.

# PI/CPC (PUBLIC INFORMATION/COOPERATION WITH THE PROFESSIONAL COMMUNITY) – CLAUDIA N.: Today, we heard how Districts outreach to health fairs.

medical institutions, human resources, and first responders. Members highlighted tools

from aa.org, like customizable PI cards and pamphlets. One member raised an important

point about potentially overlooking the French-speaking community, particularly in the

wine industry. Miguel H. will present on using QR codes in English and Spanish at our

next meeting on May 24 at 9:00 a.m.

## **TECHNOLOGY—MEG B.:** Wi-Fi issues during the Pre-Conference Assembly caused

glitches for online attendees; we now have preventive measures in place. We discussed

the challenges of early travel start times for the hybrid team. We got 24 responses to our

workshop survey and added two new volunteers. We're preparing for the Post-Conference and an upcoming all-committee chair meeting. Today, I am presenting a

housekeeping motion to fund a committee member's attendance at the National A.A. Technology Workshop (NAATW).

**WEBSITE – SANDRA S.:** The CNCA website went down the morning of the Pre-

Conference due to a hosting issue with the database connection. It was restored after a

week of work. The site is now updated with information from January through April. We

had a volunteer step up to become the sixth member of the committee, pending approval

from the Area Officers. We will have volunteers staffing a Web Committee table at the

Post-Conference and Summer Assemblies. Area committees are reviewing their pages

for updates. If you have any suggestions or feedback for the Committee, please email

## **DCM SHARING SESSION – NICOLE C:** Today's focus was on service sponsorship. We

covered the types of service sponsorship, reviewed A.A. Concepts 1–12 with practical

examples, and emphasized the spiritual principles underlying service roles. Participants

emphasized the importance of asking for help, maintaining open communication, and practicing humility. The presentation helped attendees see how service concepts apply

personally and reinforced the value of workshops and mentorship. Upcoming topics include how to interpret the Conference Report and the learning curve in General Service.

## **SPANISH LINGUISTIC SHARING SESSION:** Our presenter asked how many GSRs had

the opportunity to present agenda topics to their groups and deliver the consciences at

the Pre-Conference Assembly. Many hands were raised. GSRs shared about how incredible it was to participate and bring their group's voice forward. Several members

spoke about the importance of the GSR's service.

# **LITERATURE/GRAPEVINE/LA VIÑA SHARING SESSION – JOSE L.:** We heard a presentation on sowing seeds for a better connection and primary purpose. We gathered

in a spirit of unity and growth, celebrating as two members marked anniversaries—

testimony to the transformative power of recovery. Those who joined brought even more

energy. The presenter shared meaningful updates, planting seeds for stronger future connections among groups. The energy in the room was collective inspiration and hope.

Central Offices of A.A.) meeting this month: misconception that Intergroups/Central Offices are not part of A.A.; the distinction between our employment and our 12th step

service; dealing with anonymity issues by saying "I work for a small non-profit"; by-laws:

local ways to use excess funds, such as lowering literature prices and increasing PI and

outreach funding; and Founders Day events. The Grapevine Publisher gave us an update

on proposed bulk pricing. The 40th Annual ICOAA Seminar will take place in Memphis,

TN, from September 19 to 21.

## **OFICINA CENTRAL HISPANA – FABIAN P.:** The Hispanic Central Office of Northern

California is located in San Jose, Santa Clara County. The office comprises 17 groups,

including committees on Sponsorship, Public Information, 12th Step List, H&I, Literature,

• That CNCA provide one-time ASL interpretation for the 2025 Post-Conference Assembly business meeting at a cost not to exceed \$500." — Presented by District 08

<u>Presentation</u>: We are presenting a motion similar to one we brought last year. We have

a member from our district who would benefit from participating more fully during the Assembly Business Meeting with ASL interpretation. This motion is specifically for the

business meeting portion, not the Delegate's Report, as there is already an Area motion

that covers ASL for the Delegate's Report when requested. We estimate the cost at \$500

based on current interpreter rates. The interpreter would provide services via Zoom, benefiting both in-person and online attendees. [Chair clarifies that a request was made

for ASL interpretation for the Delegate's Report, and per the previous Area motion, we

will have it.]

Questions: Q: Does this mean we will have two ASL interpreters, one for morning and

<u>Presentation</u>: There will be a 75-minute Recording Secretary's Workshop on Thursday,

June 5. I'm requesting funds for Spanish interpretation and one of our regular ACM interpreters is available. The interpreter's rate is \$70 per hour. The workshop will begin

with a 15-minute orientation at 6:45 p.m., followed by a full hour-long workshop starting

at 7:00 p.m.

<u>Questions</u>: No questions. // No objections. <<**Housekeeping Motion Passed>> DISCUSSION TOPICS** 

• Paperless Comments/Commentarios

<u>Discussion</u>: Last time someone said we need to decide one or the other, but I don't think

we can make a blanket statement like that. There are people who need both. // I shared

last month about my experience as Comments/Commentarios Chair. We went from 800

to 400 to 34 printed copies. It costs about \$4–\$5 per booklet. From a public health perspective, I thought there must be an accessibility need—but in general service, you

need an email to register. If you need bigger print, you can print it at home. I'm still curious

to hear from the folks who need paper and understand why. // Are we talking about emailing it in a manner where people can print it themselves? I think that would be terrific.

Other places are doing that too. // Last panel, I got the *Comments* in the mail. I'm old school and I liked paper, but now I get it electronically and I feel fully informed. I have a

bin full of old papers from two panels; maybe I'll give them to Archives. // It's assumed everyone has a printer. I just got one. // I want to lovingly invite our Spanish-speaking members to share. I recently sent the *Commentarios* as a PDF by WhatsApp to Spanish

officers, and it was appreciated. Many Spanish-speaking GSRs communicate through

WhatsApp or paper, not email. If we eliminate paper entirely, we risk widening the communication gap or shifting the cost of printing to Spanish-speaking districts. // In my

district, about half the members are comfortable with technology and half are not. Some

still need printed materials, and we have a GSR without an email address. // The *Comments* and *Commentarios* can be available in the General Service App – as long as

there's a hyperlink, they can be added to the Area page. // We're in the 21st century and

most members can read on their phones or computers. If someone needs a printed copy,

we can facilitate that within the districts. // As Area Registrar, I confirm that to register a

trusted servant in Fellowship Connection, an email is required. I recognize that not everyone is comfortable with technology, but service has taught me new skills I didn't have when I started. // GSO publishes three newsletters – *Box 459*, *A.A. Behind the Walls*,

and *About A.A.* – and none are available in print anymore. Moving away from paper *Comments* would help catapult people into the digital era by removing the fallback to

analog methods. // Maybe what we really should be talking about is whether communicating by email or paper is even still the best method for the Area. //

Area Officer Visits

<u>Discussion</u>: We always have something for officers to do when they visit, but if they can't

come, that's fine too. We appreciate whatever works for them. // Last year, we had a

financial crunch, and officer visits were cut for three months to save money. Some were

upset. // As a new DCMC, officer visits really helped in the first few months when I

know what I was doing. // As a past area officer, visits are the most rewarding part of the

job. The question is whether we want visits prioritized even in tough times or left as

stopgap when funds are low. // We love officer visits, but since we are hybrid, we'd gladly

have them attend virtually if needed. // Hybrid districts could offer officers the option to

attend online during lean months. // Officer visits create a spark in GSRs. We invite officers to dinner too. I served in an area without officer visits before, and it makes a big

difference. // I love visiting districts and bringing guests along. If anyone near Sunnyvale

wants to carpool for a visit, reach out. // Could having officers visit hybrid districts online

and in-person ones live be enough of a stopgap? // In-person visits matter because of the

informal conversations. If needed, Zoom is better than losing the visits altogether. // Visits

help officers hear directly from groups and keep the Area connected. // Visiting districts

helps officers check on the health of groups and learn where help is needed. // Seeing an

officer visit showed me there's more to A.A. than just the district. It inspired me to get involved in general service. // Officer visits are budgeted at \$16,000, so money isn't a

barrier right now. // GSRs trust information more when it comes from visiting officers, not

just their own district. It cuts through ego. // Officer visits are exciting and motivating, even

though translation challenges remain. We're improving that. // Missing officer visits reminds us why group contributions matter. It's a good reminder that a dollar doesn't go

as far anymore. //

Communication Platforms in General Service:

<u>Discussion</u>: Bill W. spoke in 1960 about the excitement of new communication methods

like transatlantic phones. Our principles stay the same, but how we organize and communicate should keep evolving. I'm open to exploring new ways as long as it doesn't require 24/7 moderation. My concerns are mainly about anonymity, privacy, and

moderation. // There is still a lot of suspicion around anonymity and attending meetings

online. It's an important conversation because using platforms like Zoom has been a big

boom for A.A. // I serve a large, spread-out district. I mostly use email to communicate,

but GSRs aren't reading their emails. I'm trying to figure out how to communicate with

GSRs and DCMs across a big geographic area while protecting their anonymity. We

have a lot of tools, but we don't always use them effectively. // Behind every communication platform in A.A., someone is putting in time and effort. I try to stay open-

minded and check out the tools out of respect for that service. Even if a tool isn't for me.

it might help someone else. // Information flows up or down the triangle, but most of our

current platforms—apps, newsletters, email—only push information downward. Weneed more truly interactive platforms where communication can flow both ways. In my

district, we're trying a team chat platform like Slack for more interaction. It's been quiet

so far, but it offers a space to ask questions easily. // I serve on the NAATW Steering Committee. I'm excited about how technology can help keep A.A. viable and available

for future generations. GSO doesn't have a Tech desk to serve groups, and right now,

NAATW fills that gap. // We need to meet people where they are. Text messaging is one

of the most effective communication tools today. My home group uses Expert Texting where members opt in to receive updates directly by text, and it's much harder to ignore

a text than email. //

#### WHAT'S ON YOUR MIND?

<u>Discussion</u>: It doesn't feel safe to me that we decided to provide ASL for the business meeting and Delegate's Report but not for the Conference theme. The theme is "Working

Together, Building Trust"—are we building trust with Deaf alcoholics when we don't provide ASL? As someone who is hard-of-hearing, I'm between communities myself, and

it makes me sad we aren't doing more for accessibility. // The April 2025 Comments and

Commentarios were uploaded to the General Service app. Archives are also available

there. // District 16 is hosting a Pre-Assembly dinner on Friday, May 16. Tickets are \$35

for salmon, beef, or vegetarian plates. Sales close May 10. // Last night I spoke at our

district's beginner meeting. It's supported by District 11 and rotates secretaries every six

weeks. Sharing on A.A. literature and service after nine years of sobriety gave me an

unexpected spiritual experience. // My home group, Love and Service, offers ASL the

fourth Sunday of each month at our hybrid meeting. If you know a Deaf alcoholic who

could benefit, please share. // I'm moved by the Pre-Conference Assembly report and

grateful to District 3 and 19. It's inspiring to see people work so hard and share their experiences. // I sometimes attend online meetings and recently found an Autism and A.A.

group. They don't have a GSR yet. Seeing people on the spectrum come into meetings

made me realize we need to better support them.

The meeting was closed at 3:28 p.m. by Drew B. with the Responsibility Declaration.

# CALIFORNIA NORTHERN COASTAL AREA 06 (CNCA 06) ASSEMBLY BUSINESS MEETING MINUTES FOR 2025 PRE-CONFERENCE ASSEMBLY

The Pre-Conference Assembly business meeting was held using a hybrid format on April

5, 2025 with virtual attendees on Zoom and in-person attendees at the Santa Cruz Civic

Auditorium in Santa Cruz, CA. Drew B. opened the meeting at 9:15 a.m. followed by the

Serenity Prayer. The AA Preamble was read by: Alicia L. (District 08). Caitlin (District 40)

read the Twelve Traditions in English and Salvador M. (District 19) read the Twelve Traditions in Spanish. Eleven past Delegates were present: Bob D. (Panel 36, Area 28).

Barbra M. (Panel 41), Woody R. (Panel 50, Area 07), David N. (Panel 59), Jim F. (Panel

59, Area 38), Ken M. (Panel 61), Raymundo L. (Panel 65), Joann L. (Panel 67), Teddy B-

W (Panel 69), Jennifer B. (Panel 71) and Eric L. (Panel 73). Teddy B-W currently serves

as a Non-Trustee Director on the A.A. Grapevine, Inc. There was also one past trustee

present, David N. (past General Service Board Trustee). The Summer 2024 minutes were

accepted as published in the September 2024 *CNCA Comments and Comentarios*. Registered attendance: 279 voting (41 online; 238 in-person) / 174 non-voting (19 online; 155 in-person)

#### **OFFICER REPORTS**

**DELEGATE – CHITRA S.:** The program of A.A. depends on our participation and is

shaped by our willingness. The group conscience process is a spiritual experience, and

agenda topics allow for fearless and honest discussion of our strengths and weaknesses.

We are invited to participate and use our voices. Are we communicating clearly? Are we

creating space for others to participate equally? Have we read the literature and background, asked for help when needed, and shared our experience when asked? We

have a responsibility to practice deep listening – hearing each other rather than responding or fixing. We are asked to remain teachable, to know our Traditions and Concepts, and to let go of needing to be right. Unity is not created through uniformity but

through safe disagreement and shared experience. I would not be alive today without this

fellowship. So yes, I can do the work and walk through fear to stay present, sober, and of

service. Welcome to Panel 75.

## **ALTERNATE DELEGATE – CLAUDIA N.:** At PRAASA, during the Remote Communities

Panel, the Area 79 Delegate shared about a district spanning five islands. Visiting the

district was very challenging, requiring plane travel and overnight accommodations. When

she arrived at one island with the Service Manual, they assumed she was the leader of

A.A. The DCM explained she was a trusted servant. That visit led to the island's first GSR

 now three of the five islands have GSRs. It's a powerful example of showing up, planting

seeds, and trusting the process. Concept 1 states that final responsibility and ultimate

authority for A.A. world services should always reside in the collective conscience of our

whole fellowship. We may not be as remote, but your work to gather and share your group

conscience contributes to that collective voice.

**CHAIR – DREW B.:** Welcome, everybody, to the first assembly of Panel 75. Today is the

big one – the Pre-Conference Assembly – where the groups share their conscience on

the future of Alcoholics Anonymous. No pressure! We'll hear group consciences on 39

agenda items this weekend. We are living out the 12 Concepts, which for me means trust

and respect. Your groups and districts have trusted you, and "universal respect" is key to

our usefulness today. As you listen to others share, please be kind, open-minded, and

respectful of the work they did to capture their group's conscience. Please refrain from

cheering, clapping, or booing during sharing – save that for officer reports. Before we

begin, we have some business. The Fall Election Assembly took all day, so the last time

we did Assembly business was Summer 2024. There is no Old Business. Today we'll

hear three new business presentations – just questions on intent and wording. Make new

friends and have fun!

**TREASURER – DAN B.:** March was a middling month for contributions, with about \$7,000 received. Expenses were higher at \$8,000, mostly due to officer travel to districts

and PRAASA, and initial costs for sending our Delegate to the General Service Conference. Year-to-date, we are financially stable with approximately \$25,000 in the

checking account. CNCA now has a credit card linked to our Bank of America account

with a \$5,000 limit, offering more security for electronic purchases.

Reimbursements are

now processed via Zelle, improving efficiency over manual checks. Please encourage

groups to contribute electronically at cnca06.org/contribute and include your group number if known – checks are slower and costlier to process. The cost of this assembly

is approximately \$7,000: \$1,000 for the site, \$4,000 for food, and \$200 for coffee. Assemblies are expensive and worth it, but we have a responsibility to fully self-support,

including for those attending via Zoom. While there is no suggested amount, please be

generous.

## **ASSEMBLY COORDINATOR – MATT E.:** I so full of love this morning. I went to bed last

night full of fear, but by the time I got here, all my fear was erased. My day has completely

shifted already – and it's only 9 a.m. – so thank you all so much for being here. Giant

## **REGISTRAR – SARAH B.:** Over the past three months, I've been learning Airtable, our

"Minutes 101" orientation and presentations on AI tools and maintaining anonymity duringthe electronic distribution of minutes. Pending approval of a housekeeping motion at the April ACM, Spanish interpretation will be available. I hope you'll join us! I've been enjoying the Area Motions Book – the historical record of our Area business since 1971. Fun fact: our hand-made green, yellow, red timer debuted in 2010!

## **LITERATURE/GRAPEVINE/LA VIÑA – JOSE L.:** The Literature Committee Workbook,

released in September 2024, was well received, selling out in two months. It is back in

stock and available to view online. The 2024–2026 A.A. Service Manual sold over 6,200

copies in its first month. The *Plain Language Big Book*, released in November 2024, sold

over 71,000 copies in 18 days, is now in its second printing, and is available as an e-book

and on Corrections tablets nationwide. Member feedback continues to shape literature

projects, including updates to A.A. for the Native North American, Do You Think You're

Different? and Questions and Answers on Sponsorship. Work continues on the Fifth

Edition of the Big Book and the Fourth Edition of *Alcohólicos Anónimos*. The trustees'

Literature Committee is seeking two Appointed Committee Members to lead pamphlet

development for the Asian and Asian American alcoholic and the Transgender alcoholic.

**ARCHIVES – ELVIA P.:** Of the 23 Districts in our Area, 11 have District Archives Representatives on our committee. In 1975, the General Service Office (GSO) Archives

Room opened in New York. Due to overload and limited staffing, Areas were asked to

manage their own archives. In 1979, when CNCA had 18 Districts, the Area Archives

Committee was formed with seven past Delegates and one A.A. member. Today, the

Area maintains an Archives Repository in Pleasant Hill, which stores Area business materials, District and group histories, historical photos, a signed First Edition Big Book.

and the original CNCA 06 history manuscript. We are actively scanning and digitizing

**BTG (BRIDGING THE GAP) – LYNN K.:** The CNCA BTG committee statement of purpose reads that "Bridging the Gap is a General Service subcommittee that supports

that very important first step for alcoholics who have just been released from a hospital,

treatment center, or correctional facility. By providing a temporary contact, Bridging the

Gap helps newcomers make the transition to Alcoholics Anonymous in their home community. Members of Alcoholics Anonymous, usually acting in pairs, meet the patientsor inmates after release and accompany them to their first A.A. meeting. As in all 12-step

work, this activity is strictly voluntary. Today, all but two CNCA districts have BTG chairs.

**FINANCE – JEFF D.:** The CNCA Finance Committee has two primary functions: to provide checks and balances for the Area Treasurer by reviewing 7th Tradition contributions and expenses, and to create and publish the annual Area Budget, ensuring

prudent financial decisions through discussion and consensus. The committee also provides background and clarity on budget-related questions and the impact of Area

motions, using experience, data, and recommendations. As of today, contributions and

expenses are in line with the 2025 budget projections.

## **I&T (INTERPRETATION AND TRANSLATION) – LUIS R.:** This committee of seven

we have a coordinator and secretary, and we select topics useful to new GSRs. A volunteer presents on the topic chosen the month before, followed by participation from

everyone in the room. The secretary then reports back to the ACM. We started with just

four GSRs, one coordinator, and one secretary – now the room is full every month. We're

grateful to our Higher Power and Area Chair for encouraging us to bring this motion forward.

## AREA BUSINESS PRESENTATION:

• General Service App Update – *Presented by Dan B., Area Treasurer.*<u>Presentation:</u> The app is now available in the Apple App Store – search "A.A. General

Service" to download. The Android version is not yet approved in the Google Play Store.

Google is a different company than Apple and they have different rules. They require a

two-week beta test with active users. We need Android users willing to download and use

the app daily during the test period. Testing will begin after the Pre-Conference Assembly.

To participate, provide your Gmail address to me by emailing treasurer@cnca06.org and

I will add you to the invite list to be a beta test. Your commitment will be to interact with

the app every day.

<u>Questions</u>: **Q:** How long is the testing period? **A:** The Android (Google) testing period will

be approximately two weeks long. It's expected to start on Monday or Tuesday. Your

commitment during the test is to open the app every day for two weeks. // Q: How do we

connect the Districts to the app? **A:** Once the app is approved on the Google Play Store.

we'll grant access to all DCMCs. Districts can then begin uploading their information to

the app at any time. // Q: Why is my District not showing up on the app for iPhone users?

**A:** We haven't granted access to current DCMCs to upload yet. Some districts appear in

the app because their DCMCs from the last panel already added content. Once the Google Play approval is complete, more districts will be added. // Q: What is the difference

between this app and the Grapevine or Meeting Guide app? **A:** This is the General Service

App. It's specifically for GSRs, district, area, and other general service members to receive general service information from the district, area, and GSO. // Q: Are youavailable to give a presentation at my District? A: Yes.

#### PRESENTATION OF NEW BUSINESS:

Grapevine? — Presented by District 12 Sonoma at the Area Committee Meeting 9/28/24

<u>Presentation</u>: This motion was first presented at a sub-district and then brought to the full

district. GSRs collected group consciences and after discussion, the district unanimously

voted to forward the motion to the ACM in December of 2024. The ACM agreed it should

be decided at the Assembly. The intent of the motion is to add a thoughtful inventory

question to encourage group discussion about whether members have access to current

A.A. information resources at all service levels. The question is drawn from the inventory

section of the A.A. Group pamphlet, pages 29–30. We are asking to include 14 questions

instead of 13.

<u>Clarifying Questions</u>: **Q:** What was it in the sub-district that propelled this motion? What

was brought up at the sub-district? **A:** I don't know - I was not there. [The initial motion

maker clarified that this arose because the GSRs at the sub-district meeting didn't know

where to find information and that inspired this motion.] // Q: When this was discussed, how much was focused on the "The A.A. Group" pamphlet versus providing feedback on how to find information? A: The intent is to generate conversation in the groups about where this information exists. // Would you like to add language about finding resources in more places and specifically general service, such as on the websites and newsletters of

central officers and intergroups, General Service districts and areas, H&I, etc. A: For now,

we would like to keep the wording as is to generate. // Q: Would this be added specifically

as question 14 on page 30? // A: Yes. A friendly amendment accepted to add La Viña

#### after A.A. Grapevine. The motion now reads:

## <<Motion to become Presentation of New Business at the Post-Conference Assembly on May 17, 2025>>

• That CNCA 06 create a Subcommittee on Safety and Inclusion. – Presented by District 04 Santa Clara North Safety Committee at the Area Committee Meeting 11/23/24

<u>Presentation</u>: We've done a lot of safety work after forming a District Safety Committee.

We had a pretty successful forum on the subject. We think there's a groundswell of support for creating an Area committee around this issue. The need is clear – ourliterature and Traditions tell us that A.A. is inclusive and that everyone who has the desire

to stop drinking is welcome. Yet in our recent safety survey, many members, given the

chance to speak their truth, reported experiences of sexual harassment and predatory

behavior, or feelings of exclusion because of spiritual beliefs, disability, gender non-

conformity, and racial or ethnic differences. Sometimes these members are met with love

and tolerance, as is our code. We would conduct inventories. We have materials for

discussing what's going on and outreach – a group conscience to deal with and prevent

these barriers to recovery. But in many cases, this is not so, and alcoholics who need

A.A. leave A.A. The intended purpose of the Safety and Inclusion Sub-Committee would

be to foster communication around issues of safety and inclusion, and to understand and

provide resources to eliminate barriers that many members are still hesitant or even afraid

to talk about. We would serve as a repository of information, best practices, and individual

stories from members, groups, and districts that have managed to have these difficult

conversations. The goal is to help make the program of A.A. available and open to anyone

who wants to participate, by providing and compiling best practices around issues of

safety and inclusion. We recognize that every safety issue is as unique as the individual.

group, or district. We only want to provide resources to help each group or district address

these issues in accordance with their group conscience. We have no intention to dictate.

mandate, or serve as a governing body of any sort. We would research and collaborate

with other Areas and service structures to see how they are approaching this work. Our

model is the Safety Sub-Committee in Oregon Area 58. We would invite District Safety

and Inclusion Representatives to a monthly meeting and, upon request and in collaboration with districts, facilitate workshops, sharing sessions, and inventories.

<u>Questions</u>: **Q:** What about the Accessibilities Committee? **A:** We believe accessibility and

safety issues are closely related but delicate and complex. They both deserve focused

attention, and this proposal is specifically for a separate Area Safety Committee. A longer

conversation about overlap may be warranted. // Q: Does the intent include District 04

transferring its safety materials to the Area? **A:** No, District 04 would retain its safety

committee. The D04 Safety Chair could participate in the Area Safety subcommittee as a

district representative. Any A.A. is free to use the materials developed by D04. // **Q:** Is this

motion intended to address safety concerns at the group level or among people in service? **A:** We've heard stories from people who felt their concerns were not taken

seriously by their business meeting, steering committee, or GSRs. This is intended to

help address those experiences. // Q: Would this motion apply to A.A. as a whole? A: No,

this would establish a new sub-committee for the Area (CNCA), not for all of A.A. // Q:

Would the motion include members who feel excluded due to limitations, gender, appearance, etc.? Would you consider language about inclusion? **A:** Yes, inclusion is a

core intention of the proposed committee. The motion seeks to welcome people who feel

excluded for any reason, including identity, ability, or appearance. // Q: Who would be

responsible for forming the committee? Who would serve on it? A: It would be formed

from the ground up with volunteers and guided by group conscience. // Q: What is the

financial impact? **A:** The committee chair would not necessarily travel to Districts like Area

Officers do. There may be minimal costs such as support for hybrid meetings, but the

work would likely begin virtually. // << Motion to become Presentation of New Business

at the Post-Conference Assembly on May 17, 2025>>• That CNCA06 request that A.A. produce a public information service piece with a simple and consistent message, including QR codes, that could be used across the United

States/Canada service structure. And to request that A.A. use the service piece in a public information campaign. – *Presented by District 01 Monterey.* 

<u>Presentation</u>: This motion was inspired by ads for Human Trafficking seen in airports and

churches – simple, direct, and featuring QR codes. The idea hit me that this could be an

agenda item. I imagined a public info service piece reading "Are you having a problem

with drinking?" with aa.org and two QR codes: one linked to a landing page created and

maintained by GSO, and the other to the Meeting Guide App. According to service material from the General Service Office, our membership numbers grew from our inception in 1935 to 1990. From 1980 to 1990, membership doubled from about 1 to 2

million. But from 1990 until 2021, the last year on the report, membership has remained

around 2 million. And in 2021, membership dropped below 2 million for the first time since

2006. Assuming membership has remained around 2 million the last 4 years, this means

our membership numbers have been stagnating for 35 years and whatever we've been

doing during this time has not been working to grow our membership. According to the

World Health Organization, an estimated 209 million people worldwide have alcohol

dependence, an estimated 2.6 million deaths per year worldwide are attributable to alcohol consumption, and of those deaths 13% are aged 20 to 39 years old. The problem

is that our membership is not growing and there are estimated to be hundreds of millions

of alcoholics worldwide. This is an idea to reach them. The motion was developed with

input from 12 A.A. members, whose suggestions were incorporated into the proposal.

District 01 voted unanimously to pass the motion. In conclusion, we feel it would be beneficial for A.A. to have a simple, consistent message that conveys in seconds: if you're

having a problem with alcohol, A.A. is here – what A.A. is, and how to find it now. Placed

widely, it could plant seeds for those still stumbling in the dark to find the light someday,

just as we have.

<u>Questions</u>: **Q:** Are you suggesting we spam airports with stickers? Can you speak about

the distribution? **A:** The stickers seen in airports were just the seed of the idea. The motion

intentionally keeps the language broad so it doesn't prescribe how it would be delivered

or who would do what. It could be stickers, or something entirely different.

// Q: Should it

say GSO instead of A.A.? **A:** The wording is kept intentionally broad so it doesn't direct

whether it's GSO, the Board, or a specific committee. // **Q:** What do you mean by "information campaign"? **A:** A.A. already does public information work – placing PSAs, for

example. PI is not only allowed, it's essential to reaching alcoholics outside A.A. // **Q:** Who

is going to make the stickers and how much will it cost? A: That would be up to the Board

if the Conference passes the proposed agenda item. // Q: The motion wording is too open-

ended. A better phrasing would be "the General Service Office or the Conference directs

the trustees' PI Committee to..." A: Thank you for the suggestion, but the friendly amendment was not accepted. // Q: Is your intent to find out if all Areas in the US and

Canada think this is a good idea? **A:** Yes, the intent is for this to be a proposed Conference

agenda item so the Fellowship can weigh in. // Q: Is there any interest in focusing onworking with YPAA or BIPOC communities in this? A: That's a good question, but there's

no specific answer right now. // << Motion to become Presentation of New Business

cool. // When visiting groups, we should share how to use the Area or District websites.

including how to contribute and access information. Many members don't know how to

navigate these pages, so we're working on offering workshops. // It's moving and exciting

to hear all the group consciences. We have the best delegate. // Thank you for this amazing and inspiring experience. I also haven't been given options to register – maybe

post info about that. // I'm grateful to our Area Officers for creating summaries. They make

preparing a group conscience easier. Shout out to past delegate Suzanne Moore who

started it – originally for Spanish-speaking members. // The PI workbook copyright is from

1994. It's time to review the contents and update the PI kit for the modern day. // Huge

appreciation to the tech team. We're really excited about everything they're doing to keep

the conference running smoothly. // I love seeing the online attendees' faces in big bold

view and being able to read captions from the back. Thank you. // There's talk about

young vs. old and tech use. But research doesn't really back up the idea that only young

people are good at tech. Maybe let's listen more and assume less. // The lunch today was

under budget – thank you to Kimber! Also, thanks to Don, our hybrid events coordinator,

who beat me to the venue at 5:15 a.m. The tech team, parking volunteers, and everyone

working behind the scenes deserve our gratitude. // I have a hearing impairment and

If we want broader participation, online is the future. // Theplain language version of the Twelve Concepts is available in the appendices of the PLBB.// As the Accessibilities Chair, I found the access flyer to be a great resource. // I was ata meeting recently and a member who had a stroke said the PLBB helped him immensely.It's making a real difference. // This is a spiritual program, and recovery happens onealcoholic helping another through the Steps. I work in hospitals and correctional facilities – people are dying from alcoholism and fentanyl. They don't have time to be handed a pamphlet. // As the Pre-Conference

Assembly Chair, I didn't understand why we'd host an assembly – until this weekend. Seeing so many people from around the Area here brought me to tears. // Post-Conference Assembly is May 17 in San Francisco. //

Regarding Report and Charter B – my personal opinion is that requiring written permission from groups makes action intentionally impossible. // Thank you to our Delegate and to the amazing hybrid team. If you want to volunteer, email technology@cnca06.org. // When I was new, I couldn't read the Big Book, so I read *Living* 

Sober in the Redwoods. Last night I went to the Young People's bonfire and it warmed

my heart. I found A.A. in my 20s but didn't stick around. Now I want to help wrangle new

GSRs into service. // If as many people wanted to be PI/CPC reps as want to change the

literature, we'd reach a lot more alcoholics. // My group conscience is concerned we're

no longer an upside-down triangle. We don't choose the topics or get enough time with

agenda items. We need to help groups engage and weigh in on big issues, especially

literature changes. // When most groups say the same thing and those with differing views

don't get to share, it doesn't build trust. // I didn't learn about the Concepts until I got into

General Service. They helped me understand how A.A. is sustained. I'd love to see a

shortened version of the Concepts added to the Twelve and Twelve – with stories to spark

interest. // Delegate, go with confidence. Hearing everyone share gives me hope about

where we're going as a Fellowship. I'm looking forward to the Post-Conference and what

decisions are made. // This was my first assembly. District 03 set a high bar – my District

is hosting next. Thank you, Chitra, for sitting attentively all weekend. // I wish my group

business meetings were as effective as these assemblies. Not all newcomers are young

 many join in their 50s – something to remember when updating literature with things

like QR codes. // GSRs can cut costs – maybe stop staying at Marriotts. // Treasurer's

report: 7th Tradition contributions were \$4,458 – thank you for your love and support of

the Area and this Assembly. // This is my third year attending Assemblies, and I'm amazed

at how democratic this process is. I teach government, and A.A. truly values minority

me. At my first General Service assembly, I couldn't make eye contact and was terrified.

This service journey has transformed me from someone who didn't want to live into someone who is a responsible human being. Thank you. I'm so excited for the Conference. The Pre-Conference Assembly was closed on Sunday, April 6 2025 at 12:29 p.m. by Drew B. with the Responsibility Declaration.


