ACM:

OLD BUSINESS

- That CNCA rename the Web Committee to the Digital Communications Committee and expand its scope to include maintenance of all communications tools used by the Area. – *Presented by the Website Ad Hoc Committee*
- That CNCA contract with a dedicated paid Web Servant that reports to the Web Committee (or, if applicable, the renamed Digital Communications Committee). This non-rotating position could manage website security, updates, hosting, and technical operations under the direction and supervision of the committee. – *Presented by the Website Ad Hoc Committee*
- That the CNCA website aligns with modern web accessibility and UX guidelines. – *Presented by the Website Ad Hoc Committee*

NEW BUSINESS

- That Area 06 provide professional sign language interpretation at Area Assemblies as a reasonable accommodation for effective communication, when requested by a Deaf or Hard of Hearing A.A. member with at least two weeks' advance notice. No housekeeping motions would be required. Furthermore, a reasonable accommodations statement shall be added to all Area communication platforms — including but not limited to the Area website, Area newsletters, and Assembly flyers — stating that reasonable accommodations, including sign language interpretation, are available upon advance request. – *Presented by Jackie B., Area Recording Secretary.*
- That Area 06 provide professional sign language interpretation at Area Committee Meetings (ACMs) as a reasonable accommodation for effective communication, when requested by a Deaf or Hard of Hearing A.A. member with at least two weeks' advance notice. No housekeeping motions would be required. Furthermore, a reasonable accommodations statement shall be added to all Area communication platforms — including but not limited to the Area website, Area newsletters, and ACM flyers — stating that reasonable accommodations, including sign language interpretation, are available upon advance request. – *Presented by Jackie B., Area Recording Secretary.*
